1. Page 2, Lines 44 through 46:

44 (2) Nothing in this section may be construed to prevent a political subdivision from  
45 making an ordinance or other regulation related to a nonelectric perimeter wall or fence, or signage related to  
the perimeter wall or fence, that  
46 surrounds a battery-charged suspended-wire system.
