# UTA receives federal formula funding as follows:

Fund Name	Mandatory Uses
Urbanized Area Formula Grants- Growing States and High Density States Formula Program (49 USC 5307)	Almost any transit capital – UTA uses this funding mostly for preventive maintenance and State of Good Repair (SGR) projects.
Grants for Buses and Bus Facilities Formula Program (49 USC 5339(a) )	Almost any capital transit expense that is bus related. UTA uses this funding for facility improvements or rolling stock.
State of Good Repair Grants (49 USC 5337)	For capital projects that maintain a fixed guideway (rail) or a high intensity motorbus (BRT) system in a state of good repair.
Enhanced Mobility of Seniors & Individuals with Disabilities (49 USC 5310)	UTA programs most of this funding out to subrecipients in the UTA service district. This program provides formula funding to states for the purpose of assisting private nonprofit groups in meeting the transportation needs of older adults and people with disabilities when the transportation service provided is unavailable, insufficient, or inappropriate to meeting these needs.

### UTA receives federal discretionary (competitive) funding as follows:

UTA applies for federal discretionary grants when the Authority has projects meeting the funding requirements. In the past, UTA has received these competitive grants from the Federal Transit Administration, Federal Railroad Administration, Environmental Protection Agency, Department of Homeland Security, and others.




