UCA 41-1a-1222 Local Option Highway Construction and Transportation Corridor Preservation Fee

Revenue:

- \$10 on each motor vehicle registration within Salt Lake County
- Deposited into Local Highway and Transportation Corridor Preservation Fund

Fund Distribution:

- 50% deposited into the State's County of the First-Class Highway Fund
- 30% to be administered by the Council of Governments Public Works Committee
- 20% to a legislative body of a County of the First-Class (HB 244 2021)

Allowable uses

- Preserve a highway or public transit corridor that is right-of-way (UCA 72-2-117.5)

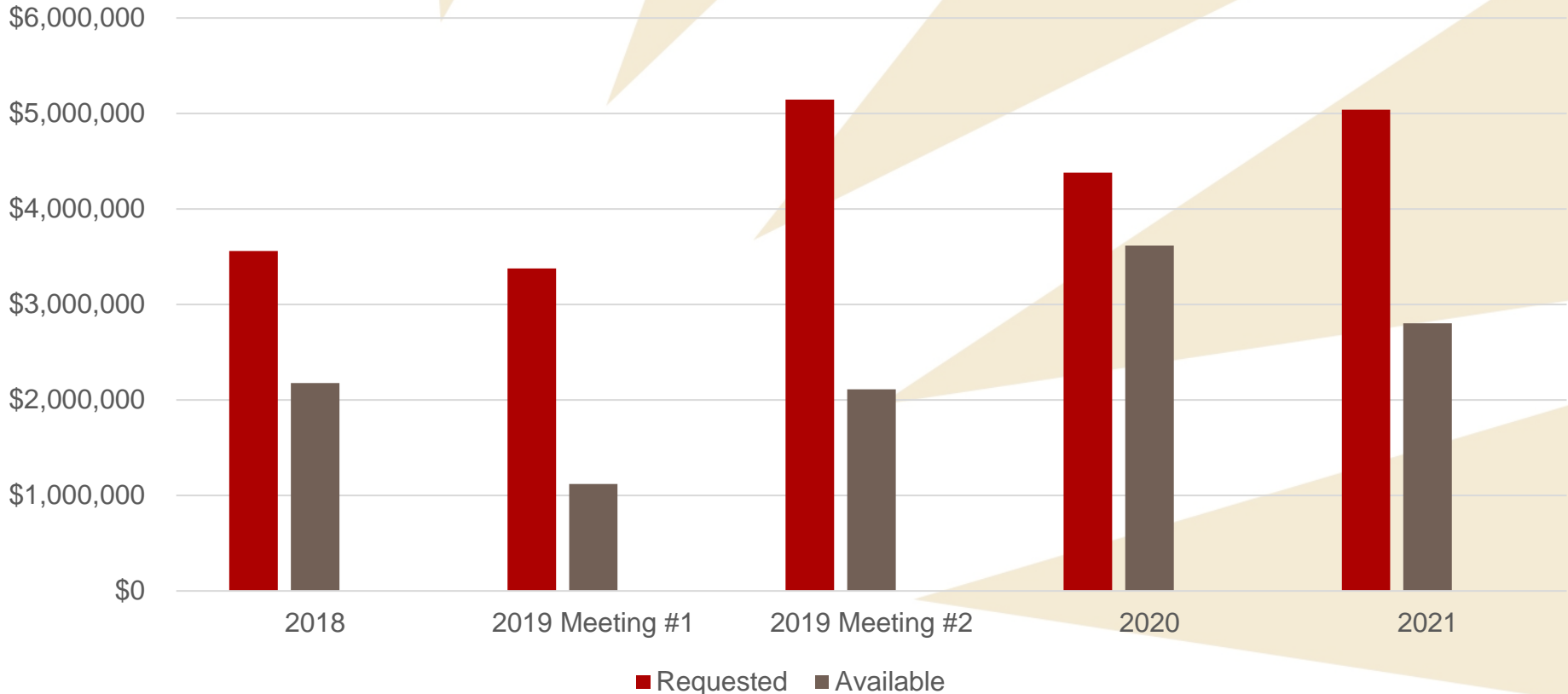

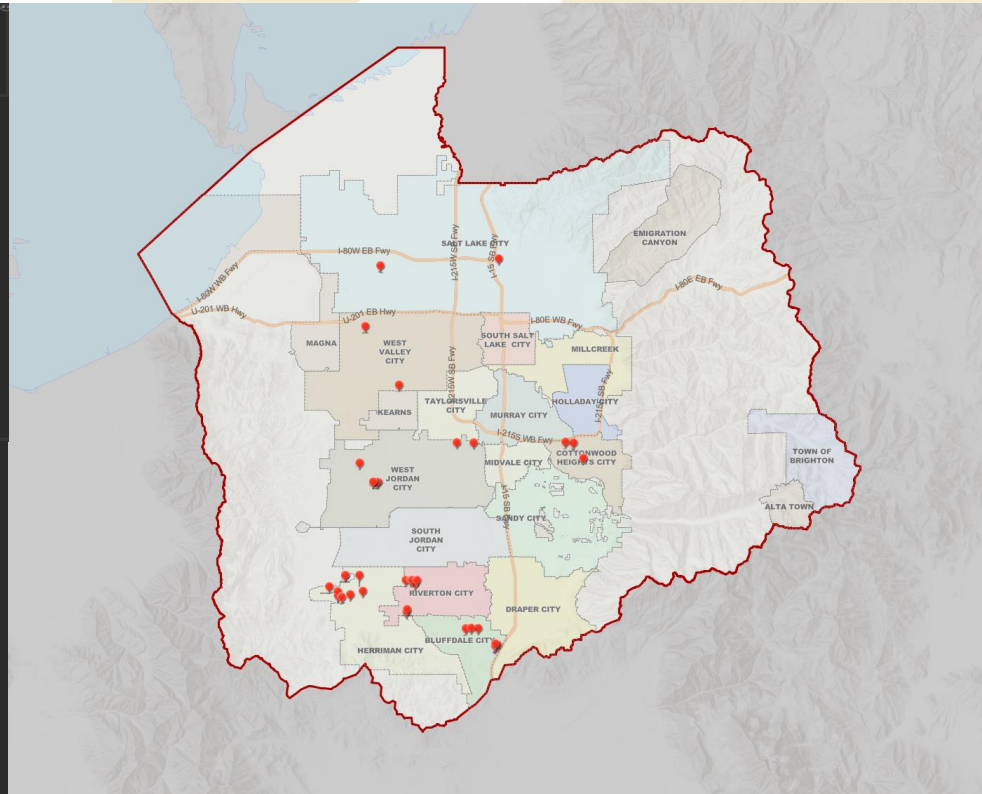
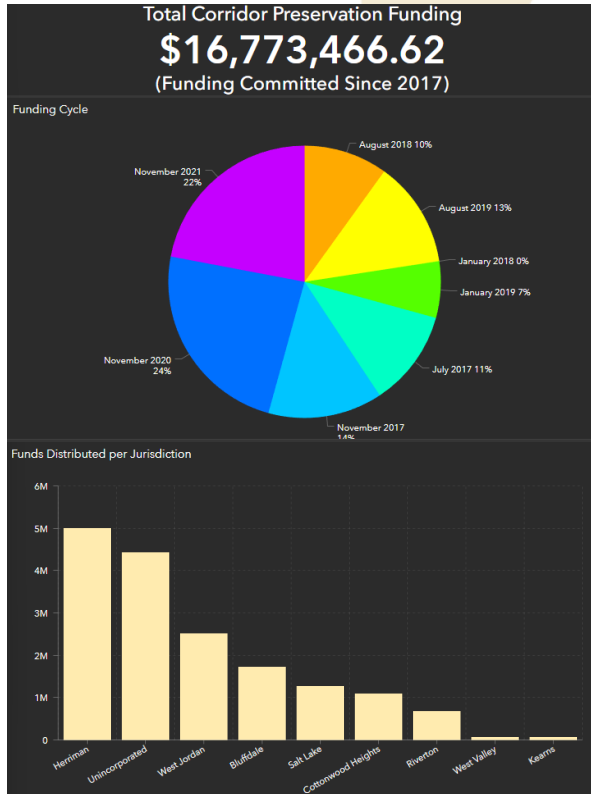
Requested vs. Available Funding

Approximately \$3M available annually for allocation.
 Funding does not always accommodate the need.

- Areas of rapid population growth

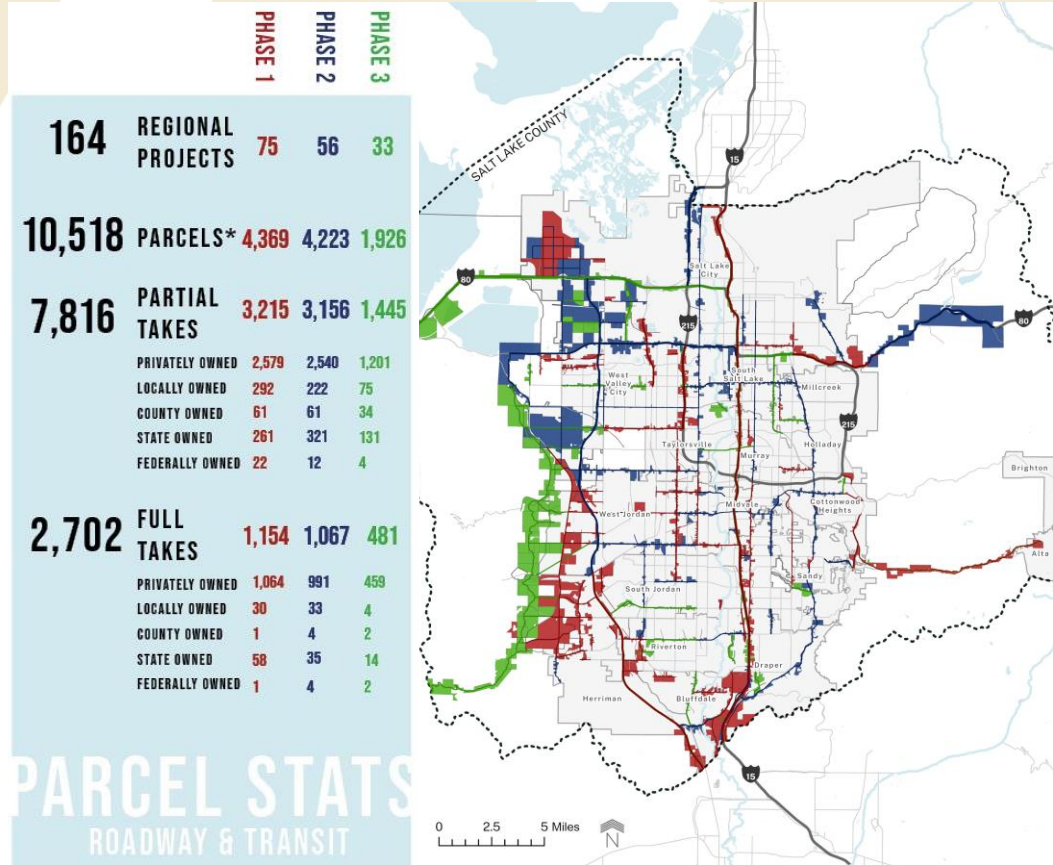
Study

- Provided a list of prioritized corridor preservation needs for the next 3-5 years
- Gain a better understanding of jurisdiction policies
- Recommend corridor preservation best practices
