34	Section 1. Section 4-39-102 is amended to read:
35	4-39-102. Definitions.
36	As used in this chapter:
37	(1) (a) "Commingle" means maintaining animals in a manner in which physical contac

39	(b) "Commingle" includes maintaining animals in the same pasture or enclosure.

64	Section 2. Section 4-39-107 is amended to read:
65	4-39-107. Powers of state veterinarian.
66	(1) The state veterinarian shall:
67	[(1)] (a) set up periodic or ongoing surveillance programs considered necessary for:
68	[(a)] (i) the recognition, control, monitoring, and elimination of infectious diseases and
69	parasites; and
70	[(b)] (ii) monitoring genetic purity; and
71	[(2)] (b) quarantine or make any disposition of diseased animals that the state
72	veterinarian considers necessary for the control or eradication of that disease.
73	(2) In carrying out the state veterinarian's duties under this section, the state
74	veterinarian may impose reasonable restrictions, as determined by the department, on the
75	transfer of domesticated elk to or from a domesticated elk herd for a limited time for the
76	purpose of conducting a health risk assessment for the domesticated elk herd.
77	(3) Notwithstanding anything to the contrary in Utah law, within 30 calendar days after
78	the day on which the state veterinarian begins an animal disease traceability investigation for a
79	domesticated elk herd, the state veterinarian shall provide written notice to an owner of the
80	domesticated elk facility of:
81	(a) the status of the animal disease traceability investigation, including any findings;
82	<u>and</u>
83	(b) the owner's right to appeal.
84	(4) The state veterinarian may not:
85	(a) quarantine a domesticated elk facility unless a domesticated elk at the domesticated
86	elk facility has, within the previous 60 months:
87	(i) tested positive for a disease spreading pathogen; or
88	(ii) commingled with a domesticated elk in a quarantined domesticated elk facility;
89	(b) continue a previously ordered quarantine if an animal disease traceability
90	investigation finds that:
91	(i) a suspect domesticated elk was not commingled with a domesticated elk that has
92	tested positive for a disease spreading pathogen in the 60 months prior to the date on which the
93	state veterinarian begins the investigation; or
94	(ii) no suspect domesticated elk resides at the domesticated elk facility:

95	(c) restrict the movement of a domesticated elk destined for a harvest facility or
96	slaughter facility; or
97	(d) deny an application for a new domesticated elk facility if the facility meets all the
98	requirements of this chapter.
99	Section 3. Section 4-39-303 is amended to read:
100	4-39-303. Importation of domesticated elk.
101	(1) A person may not import domesticated elk into the state for use in domesticated elk
102	facilities without first obtaining:
103	(a) an entry permit from the state veterinarian's office; and
104	(b) a domesticated elk facility license from the department.
105	(2) The entry permit shall include the following information and certificates:
106	(a) a health certificate with an indication of the current health status;
107	(b) proof of genetic purity as required in Section 4-39-301;
108	(c) the name and address of the consignor and consignee;
109	(d) proof that the elk are:
110	(i) tuberculosis [and brucellosis] free; or
111	(ii) enrolled in a tuberculosis herd monitoring accreditation program administered by
112	the United State Department of Agriculture or the Canadian Food Inspection Agency;
113	(e) the origin of shipment;
114	(f) the final destination;
115	(g) the total number of animals in the shipment; and
116	(h) any other information required by the state veterinarian's office or the department.
117	(3) No domesticated elk will be allowed into the state that originates east of the 100
118	degree meridian, to prevent introduction of the meningeal worm.
119	(4) A person who imports domesticated elk into the state from an international herd:
120	(a) may only import domesticated elk:
121	(i) that are male; and
122	(ii) to a harvest facility for use in the harvest facility; and
123	(b) shall ensure that the domesticated elk are harvested in the same season in which the
124	domesticated elk enter the state.
125	(5) For the purpose of enforcing Subsection (4), the department may make rules in

129	Section 4. Section 4-39-308 is enacted to read:
130	4-39-308. Study of importation of domesticated elk.
131	(1) As used in this section:
132	(a) "Committee" means the Natural Resources, Agriculture, and Environment Interim
133	Committee.
134	(b) "Eastern importation" means the importation into the state of domesticated elk
135	originating east of the 100 degree meridian.
136	(2) (a) The department shall conduct a study of domesticated elk importation.
137	(b) The department shall coordinate with the Division of Wildlife Resources and
138	relevant stakeholders that have an interest in domesticated elk importation to conduct the study
139	described in Subsection (2)(a).
140	(3) The study described in Subsection (2) shall:
141	(a) evaluate the risk to domesticated elk in the state of meningeal worm infection
142	related to eastern importation;
143	(b) evaluate strategies to mitigate meningeal worm infection related to eastern
144	importation, including:
145	(i) tracking;
146	(ii) testing;
147	(iii) vaccination; and
148	(iv) treatment;
149	(c) study avenues for importation of domesticated elk breeding stock other than eastern
150	importation, including potential risks and strategies for mitigating risks; and
151	(d) include a study or evaluation of any other factors the department deems necessary
152	to carry out the study described in Subsection (2).
153	(4) The study described in Subsection (2) may include:
154	(a) review of relevant literature; and
155	(b) surveys of other states' disease mitigation strategies and practices.
156	(5) (a) The department shall report to the committee on or before the committee's

157	September 2023 interim committee meeting.
158	(b) The report described in Subsection (5)(a):
159	(i) shall include recommendations:
160	(A) for or against eastern import, including recommendations for how to implement
161	eastern import, if any; and
162	(B) for importation of domesticated elk breeding stock, including recommendations for
163	implementation and disease mitigation strategies; and
164	(ii) may include recommendations for legislation.
165	(6) If the committee decides to recommend legislative action based on the report and
166	recommendations described in Subsection (5), the committee shall prepare legislation for
167	consideration by the Legislature in the 2024 General Session.
