Legislative Interim Meetings

Meetings were held November 16, 2022, or as noted

Business and Labor

Blockchain and Digital Innovation Task Force

Received a presentation and <u>annual report</u> from the chairs of the Blockchain and Digital Innovation Task Force. The task force formed a subcommittee to review changes to sandbox legislation and determined that an alteration to the Money Transmitters Act would be more effective by:

- including broader exemptions laid out in FINCEN guidance;
- creating a framework for cryptocurrency and blockchain arbitration in the state that would require jurors who are part of an arbiter or "sheriff" node to submit their qualifications for review; and
- establishing sheriff nodes that could be built into the base layer of a protocol or applied to existing blockchains that updated their smart contracts and would allow arbitration findings to be submitted to the Attorney General or Department of Commerce.

The task force also discussed establishing a state crypto wallet and investing in the minimum amount of Ethereum to establish a node on that blockchain.

Interim Summary

Discussed the committee's activities during the 2022 interim period and received a <u>handout</u> from staff that summarized the committee's studies and recommended bills over the course of the committee's six interim meetings.

Draft Legislation: Massage Therapy Practice Act Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Massage Therapy Practice Act Amendments," which would include:

- creating a license classification and establishing the qualifications and scope of practice for a massage therapy assistant and a massage assistant intraining;
- amending the massage therapist examination and background check requirements;
- addressing the supervision of a massage apprentice, massage assistant, and massage assistant intraining; and
- requiring certain signage and disclosures when a massage assistant or massage assistant in-training provides a massage service.

Draft Legislation: Professional Licensing Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Professional Licensing Amendments," which would permit the Division of Professional Licensing to designate certain professional licensing board members to preside over adjudicative proceedings concerning professional licenses and create a review process for the board members' recommended order. The bill would also modify licensing requirements for certain funeral service establishments and professionals, landscape architects, security personnel, and deception detection examiners.

Draft Legislation: Professional Licensing by Endorsement Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Professional Licensing by Endorsement Amendments," which would create a process for several state agencies to issue certain professional licenses and certificates by endorsement and would provide administrative rulemaking authority.

Required Reports

Discussed the following reports that were received in accordance with statutory reporting requirements and received several related documents:

- Recommended Changes to Construction Codes under <u>Title 15A, State Construction and Fire Codes Act</u> (Uniform Building Code Commission); and

Child Welfare Legislative Oversight Panel

Annual Oversight Reports

Received five reports on processes and outcomes in Utah's child welfare system:

Child Fatality Reviews

Briefed by the Department of Health and Human Services on its annual <u>summary</u> of fatality reviews conducted in FY 2022 involving individuals who had an open case for child welfare services within one year of death. The brief included recommendations for improving services to individuals in Utah's child welfare system. Panel members also received detailed written reports of each fatality and, in closed session, asked questions about specific cases.

Briefed by the Department of Child and Family Services and others on Utah's <u>120-day statutory preference</u> for placement of a child with relatives.

Attorney General's Youth Advisory Committee

Received a <u>presentation</u> about the work of the Attorney General's Youth Advisory Committee, also known as the "Teen Titans," including a policy proposal on digital safety.

Commission Working Groups Update

Discussed ongoing efforts of two of the three working groups created by the committee:

- the informational website workgroup, which presented the results of a survey on digital safety resources; and
- the partnerships workgroup.

Action: Voted to prepare a request for information to learn more about potential partnership opportunities and prepare a list of vetting questions for organizations that the commission may want to partner with.

Governor Cox's Social Media Strategy

Heard a <u>presentation</u> from the Office of Governor Spencer J. Cox about the Governor's Office of Families and its goals for addressing the effect of social media on youth and families.

Economic Development and Workforce Services

Draft Legislation: Disaster Amendments

Received a summary from a legislator and the Department of Emergency Management on 2023 General Session draft legislation, "<u>Disaster Amendments</u>," which would modify provisions related to the Post Disaster and Mitigation Restricted Account and the State Disaster Recovery Restricted Account.

Action: Approved as a committee bill 2023 General Session draft legislation, "Disaster Amendments."

Draft Legislation: Early Childhood Amendments

Received a summary from committee staff on 2023 General Session draft legislation, "Early Childhood Amendments," which would repeal the Governor's Early Childhood Commission and move the commission's responsibilities and duties to the Early Childhood Utah Advisory Council. Heard presentations from a legislator, the Department of Workforce Services, and the Department of Health and Human Services.

Action: Approved as a committee bill 2023 General Session draft legislation, "Early Childhood Amendments."

Draft Legislation: Rural Employment Expansion Grant Program Amendments

Received a summary from committee staff on 2023 General Session draft legislation, "Rural Employment Expansion Grant Program Amendments," which would extend the sunset date for the Rural Employment Expansion Grant Program by five years.

Action: Approved as a committee bill 2023 General Session draft legislation, "Rural Employment Expansion Grant Program Amendments."

Draft Legislation: State Flag Amendments

Received a summary from committee staff on 2023 General Session draft legislation, "State Flag Amendments," which would establish a new state flag. Also heard a presentation from a legislator and the Department of Cultural and Community Engagement.

Action: Approved as a committee bill 2023 General Session draft legislation, "State Flag Amendments."

Draft Legislation: Technology Commercialization Amendments

Received a summary from committee staff on 2023 General Session draft legislation, "<u>Technology Commercialization</u>
<u>Amendments</u>," which would create the Utah Innovation Lab for the purpose of investing in certain businesses developed in the state through technology commercialization.

Action: Approved as a committee bill 2023 General Session draft legislation, "Technology Commercialization Amendments."

Sunset Review: Point of the Mountain Development Commission

Received a presentation from a legislator on the Point of the Mountain Development Commission.

Education

Draft Legislation: Reading Software Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Reading Software Amendments," which would clarify that an existing requirement for demonstrating a certain statistical effect does not apply to reading software.

Draft Legislation: Charter School Governing Board Training

Discussed a committee bill file that would establish training requirements for members of charter school governing boards, as recommended in audit #2021-19, <u>A Performance Audit of Utah's Charter School Governance Structure</u>. Heard a summary of the <u>draft legislation</u> from committee staff.

Draft Legislation: Educator Growth Plan Framework

Discussed a committee bill file that would update the state's educator performance evaluations, as addressed in audit #2022-03, <u>A Performance Audit of Teacher and Principal Performance Within Utah's Public Education System</u>. Heard from committee staff and the State Board of Education on this draft legislation.

Draft Legislation: Superintendent Annual Report Amendments

Discussed a committee bill file that would require the Superintendent's Annual Report to include information about teacher turnover rates and teachers' reasons for leaving, as recommended in audit #2021-04, <u>A Performance Audit of the Utah State Board of Education's Internal Governance</u>. Received a summary of the <u>draft legislation</u> from committee staff.

Higher Education: Higher Education and Corrections Council

Received a <u>presentation</u> with an update on the work of the Higher Education and Corrections Council, created by 2022 General Session H.B. 226, "<u>Higher Education and Corrections Council</u>," to make recommendations about the development and delivery of higher education curriculum to persons incarcerated in Utah's correctional facilities.

Higher Education: Utah Tech Heritage Commission

Received an <u>update</u> from Utah Tech University about the work of the Utah Tech University Heritage Commission. Heard specifically about the activities the commission identified to "preserve the heritage, culture, and history of the region on the campus of Utah Tech University, including the regional significance of the term 'Dixie'." (<u>Utah Code 53B-31-401</u>)

Legislative Audit: A Performance Audit of Curriculum and Teacher Training in Public Education

Heard a <u>report</u> from the Office of the Legislative Auditor General on audit report #2022-12, <u>A Performance Audit of</u> Curriculum and Teacher Training in Public Education.

Public Education: Chronic Absenteeism and Truancy Working Group Recommendations

Heard a <u>presentation</u> on recommendations from a working group established to address chronic absenteeism and truancy.

Public Education: School Accountability System Redesign

Heard a <u>presentation</u> from the State Board of Education about the Utah School Accountability System Working Group's recommendations for updating the state's school accountability system.

Impact of Inflation on Federal Funding

Received a <u>presentation</u> from the Office of the Legislative Fiscal Analyst, a legislator, and the Utah Association of Certified Public Accountants regarding the impact that inflation has had on the funds that the state receives from the federal government. Discussed the risk to the state and potential policy solutions to address the state's reliance on federal funds.

Phoenix Correspondence Commission Report

Received a status update from a legislator regarding funding for the Phoenix Correspondence Commission.

Draft Legislation: Statewide Resource Management Plan

Received a <u>presentation</u> from the Public Lands Policy Coordinating Office regarding proposed revisions to the <u>State Resource Management Plan</u>. Discussed proposed draft legislation that would adopt a revised State Resources Management Plan.

Action: Approved as a commission bill 2023 General Session draft legislation, "State Resource Management Plan Amendments," which would adopt a revised state resource management plan.

Government Operations

Audit: Performance Audit of the Division of Technology Services

Received a <u>presentation</u> about the Office of the Legislative Auditor General's performance review of the Division of Technology Services.

Action: Approved as a committee bill 2023 General Session draft legislation, "Division of Technology Services Amendments," which would modify and clarify duties of the Division of Technology Services in relation to procurement, contract management, and security assessment.

Draft Legislation: Election Modifications

Action: Approved as a committee bill 2023 General Session draft legislation, "Election Modifications," which would modify provisions of the Election Code.

Draft Legislation: Local Official Amendments

Reviewed 2023 General Session draft legislation, "Local Official Amendments," which would provide direction in statute regarding when a city council may make changes to executive responsibilities.

Draft Legislation: Municipality Incorporation Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Municipality Incorporation Amendments," which would amend provisions related to incorporating a municipality.

Draft Legislation: Petition Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Petition Amendments," which would add provisions about the process for verifying the signature of a registered voter who signs a petition and adds provisions about the process for a registered voter who signs a petition to remove the voter's signature from a petition.

Draft Legislation: Public Notice Requirements

Action: Approved as a committee bill 2023 General Session draft legislation, "Public Notice Requirements," which would create classifications for types of public notices, specify the ways by which notification be provided for each classification, and amend public notice provisions to implement the new classification system.

Required Reports

Draft Legislation: State Commemorative Periods

Action: Amended and approved as a committee bill 2023 General Session draft legislation, "State Commemorative Periods Amendments," which would provide for the establishment of commemorative periods by the governor and require the governor's office to maintain a list of commemorative periods.

Sunset Reviews

Discussed the upcoming sunset dates for the Energy Producer States' Agreement, State Facility Energy Efficiency Fund, and the Motor Vehicle Review Committee. Upon recommendation of each of the overseeing entities, the committee took no action. Absent further action by the Legislature, the Energy Producer States' Agreement will be repealed June 30, 2023, and the State Facility Energy Efficiency Fund and the Motor Vehicle Review Committee will be repealed July 1, 2023.

Draft Legislation: Title 71 Recodification

Action: Approved as a committee bill 2023 General Session draft legislation, "<u>Title 71A - Veterans and Military Affairs</u>," which would restructure, reorganize, and rewrite some of the provisions of Title 71, Veterans, and create Title 71A, Veterans and Military Affairs.

Draft Legislation: Tourism Fund Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Tourism Fund Amendments," which would authorize counties of the third class to expend revenue generated by the transient room tax to pay for on-site emergency medical services in certain areas of the county.

Unified Economic Opportunity Commission Update

Received an <u>update</u> from a subcommittee of the Unified Economic Opportunity Commission regarding internal initiatives and recommendations for state employee retention and recruitment.

Health and Human Services

Behavioral Healthcare Licensing

<u>Briefed</u> by the new Office of Professional Licensure Review within the Department of Commerce on the office's forthcoming <u>review</u> of 34 types of mental and behavioral healthcare licenses, currently used by 18,000 licensees.

Draft Legislation: Health and Human Services Consolidation

Considered draft legislation recodifying Title 26, Utah Health Code, and Title 62A, Utah Human Services Code, into Title 26B, Utah Health and Human Services Code.

Action: Approved as committee bills:

- 2023 General Session draft legislation, "<u>Health and Human Services Recodification Administration</u>, <u>Licensing</u>, and <u>Recovery Services</u>";
- 2023 General Session draft legislation, "<u>Health and Human Services Recodification Health Care Assistance and Data</u>";
- 2023 General Session draft legislation, "<u>Health and Human Services Recodification Health Care Delivery</u>"; and
- 2023 General Session draft legislation, "<u>Health and Human Services Recodification Prevention</u>.
 Supports Substance Use and Mental Health."

Draft Legislation: Local Health Department Funding

Considered draft legislation that would require the Department of Health and Human Services and the Department of Environmental Quality to make rules for allocating state funds by contract to local health departments and require those state agencies to make certain determinations when making rules that affect local health departments.

Action: Approved as a committee bill 2023 General Session draft legislation, "Local Health Department Revisions."

Draft Legislation: Medical Record Access

Considered 2023 General Session draft legislation, "Medical Record Access Amendments," which would improve access to patient information by healthcare providers across healthcare systems.

Draft Legislation: Medical Cannabis Regulatory Structure

Considered draft legislation that would implement the <u>recommendations</u> of the Medical Cannabis Governance Structure Working Group created by the Legislative Management Commission in response to 2022 General Session S.B. 153, "Medical Cannabis Governance Study."

Action: Approved as a committee bill 2023 General Session draft legislation, "Medical Cannabis Governance Revisions."

Mental Health: Medicaid Coverage for Adults

<u>Discussed</u> potential use of the state's <u>Medicaid Expansion</u> <u>Fund</u> to fund Medicaid home and community support services for adults with a serious mental illness.

Sunset Review: Behavioral Health Crisis Response Commission

Considered draft legislation that would amend the duties, membership, and sunset date of the Behavioral Health Crisis Response Commission.

Action: Approved as a committee bill 2023 General Session draft legislation, "Behavioral Health Crisis Response Commission Amendments."

Sunset Review: Utah Marriage Commission Dedicated Credits

Considered draft legislation that would repeal the sunset date for nonlapsing dedicated credits accrued to the Utah Marriage Commission.

Action: Approved as a committee bill 2023 General Session draft legislation, "<u>Utah Marriage Commission Amendments</u>."

Judiciary

Draft Legislation: Administrative Appeals

Discussed 2023 General Session draft legislation, "Administrative Appeals Amendments," which would enable parties in administrative proceedings to file cross-petitions.

Action: Approved as a committee bill 2023 General Session draft legislation, "Administrative Appeals Amendments."

Draft Legislation: Criminal Financial Obligations

Discussed 2023 General Session draft legislation, "Criminal Financial Obligation Amendments," which would amend provisions regarding financial obligations owed by a criminal defendant and clarify the impact a settlement agreement has on restitution.

Action: Approved as a committee bill 2023 General Session draft legislation, "Criminal Financial Obligation Amendments."

Draft Legislation: Expungement Fee Waivers

Discussed 2023 General Session draft legislation, "Expungement Fee Amendments," which would require the Bureau of Criminal Identification to waive certain expungement fees if a court finds the petitioner indigent.

Draft Legislation: Expungement of Juvenile Records

Discussed 2023 General Session draft legislation, "Juvenile Record Modifications," which would allow for a petition for expungement of certain juvenile records and allow for the automatic expungement of a successful nonjudicial adjustment completed on or after October 1, 2023.

Action: Approved as a committee bill 2023 General Session draft legislation, "Juvenile Record Modifications."

Justice Court Reform

Received an update from the Administrative Office of the Courts regarding the court's proposal for reforming the justice court system.

Justice Reinvestment Initiative

Received an update from the State Commission on Criminal and Juvenile Justice on various reforms Utah has undertaken as part of the Justice Reinvestment Initiative.

Preliminary Hearings

Discussed 2023 General Session draft legislation, "Criminal Prosecution Amendments," regarding the right of a defendant to depose a witness in a criminal prosecution.

Draft Legislation: Waiver of Punitive Damages

Discussed 2023 General Session draft legislation, "Waiver of Punitive Damages Amendments," which would prohibit courts from enforcing agreements to waive or limit liability for punitive damages in contracts.

Action: Approved as a committee bill 2023 General Session draft legislation, "Waiver of Punitive Damages Amendments."

Law Enforcement and Criminal Justice

Annual Report on the Justice Reinvestment Initiative

Received a presentation from the State Commission on Criminal and Juvenile Justice on progress made on the goals of the Justice Reinvestment Initiative. Received a <u>presentation</u> from the Division of Technology Services on the status of the creation of the criminal justice data collection system.

Criminal Code Evaluation Task Force Sunset Extension

Received a presentation from a legislator on the need to extend the sunset date for the Criminal Code Evaluation Task Force.

Action: Approved as a committee bill 2023 General Session draft legislation, "Criminal Code Evaluation Task Force Sunset Extension," which would extend the sunset date of the task force from July 1, 2023, to July 1, 2027.

Criminal Code Recodification

Discussed draft legislation that would recodify certain sections of the criminal code to adopt a standardized structure.

Action: Approved as a committee bill 2023 General Session draft legislation, "Criminal Code Recodification and Cross References," which would modify Title 76, Chapters 6, Offenses Against Property, and 6a, Pyramid Scheme Act, by redrafting offense statutes into a standardized structure.

Domestic Violence

Received a presentation from a legislator on draft legislation that would create a task force intended to coordinate and make recommendations to the Legislature regarding the collection of domestic violence data in the state.

Action: Approved as a committee bill draft legislation, "<u>Domestic Violence Modifications</u>," which would create the Domestic Violence Data Task Force.

Driving Under the Influence and Interlock Devices

Received a presentation from a legislator on suggested changes to the ignition interlock system program for individuals charged with driving under the influence.

Action: Approved as a committee bill 2023 General Session draft legislation, "<u>Driving Under the Influence Modifications</u>," which would prohibit the Driver License Division from suspending a driver license unless the person fails to complete certain requirements as an ignition interlock restricted driver.

First Responder Mental Health Amendments

Received a presentation from a legislator about proposed changes to mental health services provided to first responders.

Action: Approved as a committee bill 2023 General Session draft legislation, "First Responder Mental Health Amendments," which would add spouses of retired first responders to the list of those who qualify for mental health services.

Law Enforcement Investigation Amendments

Received a presentation from the Utah Attorney General's Office on recommended changes to procedures and requirements related to law enforcement investigations that utilize reverse-location warrants.

Action: Approved as a committee bill 2023 General Session draft legislation, "Law Enforcement Investigation Amendments," which would establish certain reporting requirements for law enforcement agencies that use reverse-location warrants and require the State Commission on Criminal and Juvenile Justice to compile and publish that data.

Protective Order Amendments

Received a presentation from a legislator on changes recommended by the Criminal Code Evaluation Task Force to pretrial protective orders, jail release agreements, and jail release court orders.


Action: Approved as a committee bill 2023 General Session draft legislation, "Protective Order Amendments," which would amend the definitions of "jail release agreement" and "jail release court order" and provide expiration provisions for certain pretrial protective orders.

School Security Requirements

Received a presentation from a legislator on a proposal to create a new position within the Department of Public Safety to address school security issues.

Action: Approved as a committee bill 2023 General Session draft legislation, "School Safety Requirements," which would create a state security chief position within the Department of Public Safety, establish the School Security Task Force to help define the duties of the state security chief, and require that all secondary schools have a school resource officer.

Transportation

Annual Report and Strategic Initiatives Update

Received a joint <u>presentation</u> from the Department of Transportation (UDOT) and the Transportation Commission on UDOT's strategic goals to achieve zero fatalities, optimize mobility, and preserve infrastructure, and the Commission's project prioritization model.

Draft Legislation: Advanced Air Mobility Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Advanced Air Mobility Amendments," which would:

- delegate oversight of vertiports to the Division of Aeronautics in the Department of Transportation;
- require registration of unmanned aircraft systems (UAS) and advanced air mobility (AAM) systems;
- grant rulemaking authority to UDOT to make rules related to registration fees and registration requirements for UAS and AAM systems; and
- enact and amend provisions related to preemption of local ordinances and business licensing of AAM businesses.

Draft Legislation: Highway Special Designation Process Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Highway Special Designation Process Amendments," which would require consultation with the relevant political subdivision before certain state highway special designations and define the process for special highway designations in statute.

Draft Legislation: Motor Vehicle Safety Inspection Advisory Council Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Motor Vehicle Safety Inspection Advisory Council Amendments," which would repeal the Motor Vehicle Safety Inspection Advisory Council.

Draft Legislation: Office of Rail Safety

Action: Approved as a committee bill 2023 General Session draft legislation, "Office of Rail Safety," which would authorize the Department of Transportation to enter into an agreement with the Federal Railroad Administration per 49 CFR Part 212 and assume oversight and inspection powers for Class I railroads in the state in cooperation with the federal government.

Draft Legislation: Road Jurisdiction Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Road Jurisdiction Amendments," which would amend the descriptions of SR-109 and SR-131, and transfer jurisdiction to the state.

Draft Legislation: Road Usage Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Road Usage Amendments," which would clarify that the Road Usage Charge Program Special Revenue Fund is an expendable special revenue fund and remove language requiring an appropriation by the Legislature for the Department of Transportation to administer the fund.

Draft Legislation: Traffic Safety Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Traffic Safety Amendments," which would require the Department of Public Safety (DPS) and the Utah Highway Patrol (UHP) to annually evaluate enforcement responsibilities on state highways, coordinate with local law enforcement agencies regarding enforcement responsibilities, and report any budgetary changes to the Legislature annually. The bill also would require the Department of Transportation to coordinate with DPS and UHP regarding changes to the state highway system.

Draft Legislation: Transportation Corridor Funding Amendments

Action: Approved as a committee bill 2023 General Session draft legislation, "Transportation Corridor Funding Amendments," which would allow the Department of Transportation to use corridor preservation funds to cover staff costs to administer the fund and extend the time horizon for use of the funds from 30 years to 40 years.

Draft Legislation: Transportation Funding Revisions

Action: Approved as a committee bill 2023 General Session draft legislation, "Transportation Funding Revisions, which would repeal two outdated and unnecessary accounts, the Impact Communities Transportation Development Restricted Account and the Motorcycle Safety Awareness Support Restricted Account, respectively.

Draft Legislation: Transportation Revisions

Action: Approved as a committee bill 2023 General Session draft legislation, "Transportation Revisions," which would:

- amend station area plan provisions;
- prohibit the passing of a working snowplow or snowplows in echelon formation;
- require motorists to give space for disabled vehicles with flashing hazard lights;

- amend local match requirements to qualify for certain transportation-related funds; and
- clarify division responsibilities within the Department of Transportation for oversight of capital development of public transit facilities.

Joint WFRC, UTA, UDOT, and MAG Zero Fare Transit Study Report

Received a <u>presentation</u> from Nelson Nygaard, Wasatch Front Regional Council (WFRC), and the Utah Transit Authority (UTA) on a joint study conducted by WFRC, UTA, the Department of Transportation, and the Mountainland Association of Governments on the impacts to the transit system if one of four scenarios was adopted:

- systemwide zero fare;
- zero-fare on bus;
- zero-fare for low-income riders; or
- \$1 flat fare on all services.

The study examined the benefits and costs with respect to operational efficiency, financial health of the system, and community benefits. The presentation was preliminary, and a final report will be available in December 2022.

Station Area Planning Update

Received a <u>presentation</u> from Wasatch Front Regional Council on the implementation of 2022 General Session H.B. 462, "<u>Utah Housing Affordability Amendments</u>," which required communities to plan and develop areas within a certain radius around FrontRunner, TRAX, and bus rapid transit stations. So far, one station area plan has received certification from the relevant metropolitan planning authority, one has been submitted for certification review, and another 25 are being prepared for adoption by the relevant municipality pending certification submission.

Transit Strategic Plan Update

Received a <u>presentation</u> from Utah Transit Authority on the agency's priorities and 2030 objectives that are still in development. Strategic priorities include exceeding customer expectations, moving Utahns to a better quality of life, building community support, generating critical economic return, and achieving organizational excellence. The Board of Trustees will adopt the final strategic plan in December 2022.
