

SUNSET REVIEW REPORT

LEGISLATIVE MANAGEMENT COMMITTEE | December 2022

Background

Provisions under Title 63I, Chapter 1, Part 2, Repeal Dates Requiring Committee Review by Title, are on a reauthorization schedule and subject to a review by an interim committee. Legislative Management Committee assigned the statutory provisions listed below that are scheduled to repeal between January 2023 and January 2024 to interim committees for review during the 2022 interim. Utah Code 63I-1-105 requires a reviewing committee to submit a report of its recommendations, including proposed legislation and recommendations concerning the statute or agency, to the Legislature before January 1 of the year in which the agency is scheduled for termination. This report identifies the assigned provisions and the outcomes of the committee reviews.
