

HB 244 UTAH VICTIM SERVICES COMMISSION

Utah Crime Victim Commission

1 The Commission provides a venue to have relevant state agencies, local government, and non-profit service providers coordinate resources, responsibilities, and efforts to establish partnerships. These partnerships would facilitate seamless, statewide, comprehensive services to crime victims and their families.

2 The Commission assures the consideration and inclusion of the rights and needs of crime victims within the criminal justice policy making systems and processes.

3 The Commission enhances and strengthens existing resources and expertise and does not create a new, large and expensive siloed agency. It provides a conduit for existing agencies to improve victim services in Utah.

4 The Commission provides the conduit through which the state becomes not just a partner, but a leader, in assuring that when a crime occurs in Utah, meaningful and accessible services are readily available to victims without regard to the location of the crime or where the victim lives.
