Moves the "Resource stewardship" role from Gov Ops to DEQ



#### Focused on:

#### Advantages of the move to DEQ:

- Expanded focus beyond air quality to include land and water
- Direct access to subject matter experts: air quality, water quality, recycling, waste management, and environmental contamination
- Leverage DEQ Communications team to amplify messaging: graphic design, photo/video editing, media training, PR, web expertise etc
- DGO/DEQ continue to partner on statewide DGO projects: buildings, fleet, and cooperative contracts
- Reports annually to the Natural Resources, Agriculture, and Environmental Interim Committee on the best practices to improve quality of air, water, and land



# What does the Resource Stewardship Coordinator/Director work on?

- Division of Natural Resources water conservation efforts
- State fleet electrification efforts
- The Division of Facilities and Construction Management's electric lawn mower equipment pilot
- The Rural EV Workforce Development Initiative that provides training programs for qualified EV technicians to maintain and repair these vehicles
- Proposed statewide state agency waste management plan expansion (includes minimizing wastes and improved recycling efforts)
