

Health & Human Services Code Recodification

Explanation of Repealed Sections in S.B. 40 (2023 GS) | February 15, 2023

Summary

Senate Bills 38, 39, 40, and 41 (2023 General Session) combine Title 26, Utah Health Code, and Title 62A, Utah Human Services Code, into a new Title 26B, Utah Health and Human Services Code. As part of this recodification, a number of sections are being repealed because they are obsolete or because the substance of the section is being combined with another part of the code. None of these repeals are intended to result in substantive changes.

There are three categories of repealed sections listed below:

- 1. Provision Moved: The provisions are moved into another section in Title 26B.
- 2. Provision Obsolete: The provision is no longer needed.
- 3. Short Titles: The Legislature no longer codifies the short title of titles, chapters, and parts.
