Crosswalk for S.B. 38, 39, 40, and 41 (2023 GS) | February 15, 2023

Summary

Senate Bills 38, 39, 40, and 41 (2023 General Session) combine Title 26, Utah Health Code, and Title 62A, Utah Human Services Code, into a new Title 26B, Utah Health and Human Services Code. This crosswalk shows where each section in the recodified Title 26B comes from in Title 26 or Title 62A.
