STATE OF UTAH

LONG TITLE

General Description:

This bill amends provisions relating to the Sex and Kidnap Offender Registry and the Child Abuse Offender Registry.

Highlighted Provisions:

This bill:

- ▶ merges the Sex and Kidnap Offender Registry and the Child Abuse Offender Registry into a single registry called the "Sex, Kidnap, and Child Abuse Offender Registry";
- ▶ changes the length of time an offender must register on the Sex, Kidnap, and Child Abuse Offender Registry when convicted of the crime of enticing a minor in certain circumstance; and
- ▶ makes technical and conforming changes.

This bill provides a special effective date.

81 Section 1. Section **13-51-107** is amended to read:

82 **13-51-107. Driver requirements.**

83 (1) Before a transportation network company allows an individual to use the
84 transportation network company's software application as a transportation network driver, the
85 transportation network company shall:

86 (a) require the individual to submit to the transportation network company:

87 (i) the individual's name, address, and age;

88 (ii) a copy of the individual's driver license, including the driver license number; and

89 (iii) proof that the vehicle that the individual will use to provide transportation network
90 services is registered with the Division of Motor Vehicles;

91 (b) require the individual to consent to a criminal background check of the individual
92 by the transportation network company or the transportation network company's designee; and

93 (c) obtain and review a report that lists the individual's driving history.

94 (2) A transportation company may not allow an individual to provide transportation
95 network services as a transportation network driver if the individual:

96 (a) has committed more than three moving violations in the three years before the day
97 on which the individual applies to become a transportation network driver;

98 (b) has been convicted, in the seven years before the day on which the individual
99 applies to become a transportation network driver, of:

100 (i) driving under the influence of alcohol or drugs;

101 (ii) fraud;

102 (iii) a sexual offense;

103 (iv) a felony involving a motor vehicle;

104 (v) a crime involving property damage;

105 (vi) a crime involving theft;

106 (vii) a crime of violence; or

107 (viii) an act of terror;

108 (c) is required to register as a sex offender, kidnap offender, or child abuse offender in
109 accordance with [~~Title 77, Chapter 41, Sex and Kidnap Offender Registry~~] Title 77, Chapter
110 41, Sex, Kidnap, and Child Abuse Offender Registry;

111 (d) does not have a valid Utah driver license; or

112 (e) is not at least 18 years [~~of age~~] old.

113 (3) (a) A transportation network company shall prohibit a transportation network driver
114 from accepting a request for a prearranged ride if the motor vehicle that the transportation
115 network driver uses to provide transportation network services fails to comply with:

116 (i) equipment standards described in Section 41-6a-1601; and

117 (ii) emission requirements adopted by a county under Section 41-6a-1642.

118 (b) (i) If upon visual inspection, a defect relating to the equipment standards described
119 in Section 41-6a-1601 can be reasonably identified, an airport operator may perform a safety
120 inspection of a transportation network driver's vehicle operating within the airport to ensure
121 compliance with equipment standards described in Section 41-6a-1601.

122 (ii) An airport operator shall conduct all inspections under this Subsection (3) in such a
123 manner to minimize impact to the transportation network driver's and transportation network
124 company vehicle's availability to provide prearranged rides.

125 (4) A transportation network driver, while providing transportation network services,
126 shall carry proof, in physical or electronic form, that the transportation network driver is
127 covered by insurance that satisfies the requirements of Section 13-51-108.

129 **13-67-101. Definitions.**

130 As used in this chapter:

131 (1) "Banned member" means a member whose account or profile is the subject of a
132 fraud ban.

133 (2) "Criminal background screening" means a name search for an individual's criminal
134 conviction and is conducted by searching:

135 (a) available and regularly updated government public record databases that in the
136 aggregate provide national coverage for criminal conviction records; or

137 (b) a regularly updated database with national coverage of criminal conviction records
138 and sexual offender registries maintained by a private vendor.

139 (3) (a) "Criminal conviction" means a conviction for a crime in this state, another state,
140 or under federal law.

141 (b) "Criminal conviction" includes an offense that would require registration under
142 [~~Title 77, Chapter 41, Sex and Kidnap Offender Registry~~] Title 77, Chapter 41, Sex, Kidnap,
143 and Child Abuse Offender Registry, or under a similar law in a different jurisdiction.

144 (4) "Division" means the Division of Consumer Protection in the Department of
145 Commerce.

146 (5) "Fraud ban" means the expulsion of a member from an online dating service
147 because, in the judgment of the online dating service provider, there is a significant risk the
148 member will attempt to obtain money from another member through fraudulent means.

149 (6) "Member" means an individual who submits to an online dating service provider
150 the information required by the online dating service provider to access the online dating
151 service provider's online dating service.

152 (7) "Online dating service" means a product or service that is:

153 (a) conducted through a website or a mobile application; and

154 (b) primarily marketed and intended to offer a member access to dating or romantic
155 relationships with another member by arranging or facilitating the social introduction of

156 members.

157 (8) "Online dating service provider" means a person predominately engaged in the
158 business of offering an online dating service.

159 (9) "Utah member" means a member who provides a Utah billing address or zip code
160 when registering with an online dating service provider.

161 Section 3. Section **26B-2-120** is amended to read:

162 **26B-2-120. Background check -- Direct access to children or vulnerable adults.**

163 (1) As used in this section:

164 (a) (i) "Applicant" means, notwithstanding Section 26B-2-101:

165 (A) an individual who applies for an initial license or certification or a license or
166 certification renewal under this part;

167 (B) an individual who is associated with a licensee and has or will likely have direct
168 access to a child or a vulnerable adult;

169 (C) an individual who provides respite care to a foster parent or an adoptive parent on
170 more than one occasion;

171 (D) a department contractor;

172 (E) an individual who transports a child for a youth transportation company;

173 (F) a guardian submitting an application on behalf of an individual, other than the child
174 or vulnerable adult who is receiving the service, if the individual is 12 years old or older and
175 resides in a home, that is licensed or certified by the office; or

176 (G) a guardian submitting an application on behalf of an individual, other than the
177 child or vulnerable adult who is receiving the service, if the individual is 12 years old or older
178 and is a person described in Subsection (1)(a)(i)(A), (B), (C), or (D).

179 (ii) "Applicant" does not include:

180 (A) an individual who is in the custody of the Division of Child and Family Services or
181 the Division of Juvenile Justice Services; or

182 (B) an individual who applies for employment with, or is employed by, the Department
183 of Health and Human Services.

184 (b) "Application" means a background screening application to the office.

185 (c) "Bureau" means the Bureau of Criminal Identification within the Department of
186 Public Safety, created in Section 53-10-201.

187 (d) "Certified peer support specialist" means the same as that term is defined in Section
188 26B-5-610.

189 (e) "Criminal finding" means a record of:

190 (i) an arrest or a warrant for an arrest;

191 (ii) charges for a criminal offense; or

192 (iii) a criminal conviction.

193 (f) "Incidental care" means occasional care, not in excess of five hours per week and
194 never overnight, for a foster child.

195 (g) "Mental health professional" means an individual who:

196 (i) is licensed under Title 58, Chapter 60, Mental Health Professional Practice Act; and

197 (ii) engaged in the practice of mental health therapy.

198 (h) "Non-criminal finding" means a record maintained in:

199 (i) the Division of Child and Family Services' Management Information System
200 described in Section 80-2-1001;

201 (ii) the Division of Child and Family Services' Licensing Information System described
202 in Section 80-2-1002;

203 (iii) the Division of Aging and Adult Services' vulnerable adult abuse, neglect, or
204 exploitation database described in Section 26B-6-210;

205 (iv) the Sex ~~[and], Kidnap, and Child Abuse Offender Registry~~ described in [~~Title 77,~~
206 ~~Chapter 41, Sex and Kidnap Offender Registry~~] Title 77, Chapter 41, Sex, Kidnap, and Child
207 Abuse Offender Registry, or a national sex offender registry; or

208 (v) a state child abuse or neglect registry.

209 (i) (i) "Peer support specialist" means an individual who:

210 (A) has a disability or a family member with a disability, or is in recovery from a
211 mental illness or a substance use disorder; and

212 (B) uses personal experience to provide support, guidance, or services to promote
213 resiliency and recovery.

214 (ii) "Peer support specialist" includes a certified peer support specialist.

215 (iii) "Peer support specialist" does not include a mental health professional.

216 (j) "Personal identifying information" means:

217 (i) current name, former names, nicknames, and aliases;

- 218 (ii) date of birth;
- 219 (iii) physical address and email address;
- 220 (iv) telephone number;
- 221 (v) driver license or other government-issued identification;
- 222 (vi) social security number;
- 223 (vii) only for applicants who are 18 years old or older, fingerprints, in a form specified
- 224 by the office; and
- 225 (viii) other information specified by the office by rule made in accordance with Title
- 226 63G, Chapter 3, Utah Administrative Rulemaking Act.
- 227 (k) "Practice of mental health therapy" means the same as that term is defined in
- 228 Section 58-60-102.
- 229 (2) Except as provided in Subsection (12), an applicant or a representative shall
- 230 submit the following to the office:
- 231 (a) personal identifying information;
- 232 (b) a fee established by the office under Section 63J-1-504; and
- 233 (c) a disclosure form, specified by the office, for consent for:
- 234 (i) an initial background check upon submission of the information described in this
- 235 Subsection (2);
- 236 (ii) ongoing monitoring of fingerprints and registries until no longer associated with a
- 237 licensee for 90 days;
- 238 (iii) a background check when the office determines that reasonable cause exists; and
- 239 (iv) retention of personal identifying information, including fingerprints, for
- 240 monitoring and notification as described in Subsections (3)(d) and (4); and
- 241 (d) if an applicant resided outside of the United States and its territories during the five
- 242 years immediately preceding the day on which the information described in Subsections (2)(a)
- 243 through (c) is submitted to the office, documentation establishing whether the applicant was
- 244 convicted of a crime during the time that the applicant resided outside of the United States or
- 245 its territories.
- 246 (3) The office:
- 247 (a) shall perform the following duties as part of a background check of an applicant:
- 248 (i) check state and regional criminal background databases for the applicant's criminal

249 history by:

250 (A) submitting personal identifying information to the bureau for a search; or

251 (B) using the applicant's personal identifying information to search state and regional

252 criminal background databases as authorized under Section 53-10-108;

253 (ii) submit the applicant's personal identifying information and fingerprints to the

254 bureau for a criminal history search of applicable national criminal background databases;

255 (iii) search the Division of Child and Family Services' Licensing Information System

256 described in Section 80-2-1002;

257 (iv) if the applicant is applying to become a prospective foster or adoptive parent,

258 search the Division of Child and Family Services' Management Information System described

259 in Section 80-2-1001 for:

260 (A) the applicant; and

261 (B) any adult living in the applicant's home;

262 (v) for an applicant described in Subsection (1)(a)(i)(F), search the Division of Child

263 and Family Services' Management Information System described in Section 80-2-1001;

264 (vi) search the Division of Aging and Adult Services' vulnerable adult abuse, neglect,

265 or exploitation database described in Section 26B-6-210;

266 (vii) search the juvenile court records for substantiated findings of severe child abuse

267 or neglect described in Section 80-3-404; and

268 (viii) search the juvenile court arrest, adjudication, and disposition records, as provided

269 under Section 78A-6-209;

270 (b) shall conduct a background check of an applicant for an initial background check

271 upon submission of the information described in Subsection (2);

272 (c) may conduct all or portions of a background check of an applicant, as provided by

273 rule, made by the office in accordance with Title 63G, Chapter 3, Utah Administrative

274 Rulemaking Act:

275 (i) for an annual renewal; or

276 (ii) when the office determines that reasonable cause exists;

277 (d) may submit an applicant's personal identifying information, including fingerprints,

278 to the bureau for checking, retaining, and monitoring of state and national criminal background

279 databases and for notifying the office of new criminal activity associated with the applicant;

280 (e) shall track the status of an applicant under this section to ensure that the applicant is
281 not required to duplicate the submission of the applicant's fingerprints if the applicant applies
282 for:

283 (i) more than one license;

284 (ii) direct access to a child or a vulnerable adult in more than one human services
285 program; or

286 (iii) direct access to a child or a vulnerable adult under a contract with the department;

287 (f) shall track the status of each individual with direct access to a child or a vulnerable
288 adult and notify the bureau within 90 days after the day on which the license expires or the
289 individual's direct access to a child or a vulnerable adult ceases;

290 (g) shall adopt measures to strictly limit access to personal identifying information
291 solely to the individuals responsible for processing and entering the applications for
292 background checks and to protect the security of the personal identifying information the office
293 reviews under this Subsection (3);

294 (h) as necessary to comply with the federal requirement to check a state's child abuse
295 and neglect registry regarding any individual working in a congregate care program, shall:

296 (i) search the Division of Child and Family Services' Licensing Information System
297 described in Section 80-2-1002; and

298 (ii) require the child abuse and neglect registry be checked in each state where an
299 applicant resided at any time during the five years immediately preceding the day on which the
300 applicant submits the information described in Subsection (2) to the office; and

301 (i) shall make rules, in accordance with Title 63G, Chapter 3, Utah Administrative
302 Rulemaking Act, to implement the provisions of this Subsection (3) relating to background
303 checks.

304 (4) (a) With the personal identifying information the office submits to the bureau under
305 Subsection (3), the bureau shall check against state and regional criminal background databases
306 for the applicant's criminal history.

307 (b) With the personal identifying information and fingerprints the office submits to the
308 bureau under Subsection (3), the bureau shall check against national criminal background
309 databases for the applicant's criminal history.

310 (c) Upon direction from the office, and with the personal identifying information and

311 fingerprints the office submits to the bureau under Subsection (3)(d), the bureau shall:

312 (i) maintain a separate file of the fingerprints for search by future submissions to the
313 local and regional criminal records databases, including latent prints; and

314 (ii) monitor state and regional criminal background databases and identify criminal
315 activity associated with the applicant.

316 (d) The bureau is authorized to submit the fingerprints to the Federal Bureau of
317 Investigation Next Generation Identification System, to be retained in the Federal Bureau of
318 Investigation Next Generation Identification System for the purpose of:

319 (i) being searched by future submissions to the national criminal records databases,
320 including the Federal Bureau of Investigation Next Generation Identification System and latent
321 prints; and

322 (ii) monitoring national criminal background databases and identifying criminal
323 activity associated with the applicant.

324 (e) The Bureau shall notify and release to the office all information of criminal activity
325 associated with the applicant.

326 (f) Upon notice that an individual's direct access to a child or a vulnerable adult has
327 ceased for 90 days, the bureau shall:

328 (i) discard and destroy any retained fingerprints; and

329 (ii) notify the Federal Bureau of Investigation when the license has expired or an
330 individual's direct access to a child or a vulnerable adult has ceased, so that the Federal Bureau
331 of Investigation will discard and destroy the retained fingerprints from the Federal Bureau of
332 Investigation Next Generation Identification System.

333 (5) (a) Except as provided in Subsection (5)(b), after conducting the background check
334 described in Subsections (3) and (4), the office shall deny an application to an applicant who,
335 within three years before the day on which the applicant submits information to the office
336 under Subsection (2) for a background check, has been convicted of:

337 (i) a felony or misdemeanor involving conduct that constitutes any of the following:

338 (A) an offense identified as domestic violence, lewdness, voyeurism, battery, cruelty to
339 animals, or bestiality;

340 (B) a violation of any pornography law, including sexual exploitation of a minor or
341 aggravated sexual exploitation of a minor;

- 342 (C) sexual solicitation;
- 343 (D) an offense included in Title 76, Chapter 5, Offenses Against the Individual, Title
344 76, Chapter 5b, Sexual Exploitation Act, Title 76, Chapter 4, Part 4, Enticement of a Minor, or
345 Title 76, Chapter 7, Offenses Against the Family;
- 346 (E) aggravated arson, as described in Section 76-6-103;
- 347 (F) aggravated burglary, as described in Section 76-6-203;
- 348 (G) aggravated robbery, as described in Section 76-6-302;
- 349 (H) identity fraud crime, as described in Section 76-6-1102;
- 350 (I) sexual battery, as described in Section 76-9-702.1; or
- 351 (J) a violent offense committed in the presence of a child, as described in Section
352 76-3-203.10; or
- 353 (ii) a felony or misdemeanor offense committed outside of the state that, if committed
354 in the state, would constitute a violation of an offense described in Subsection (5)(a)(i).
- 355 (b) (i) Subsection (5)(a) does not apply to an applicant who is seeking a position as a
356 peer support provider, a mental health professional, or in a program that serves only adults with
357 a primary mental health diagnosis, with or without a co-occurring substance use disorder.
- 358 (ii) The office shall conduct a comprehensive review of an applicant described in
359 Subsection (5)(b)(i) in accordance with Subsection (6).
- 360 (6) The office shall conduct a comprehensive review of an applicant's background
361 check if the applicant:
- 362 (a) has a felony or class A misdemeanor conviction for an offense described in
363 Subsection (5) with a date of conviction that is more than three years before the date on which
364 the applicant submits the information described in Subsection (2);
- 365 (b) has a felony charge or conviction for an offense not described in Subsection (5)
366 with a date of charge or conviction that is no more than 10 years before the date on which the
367 applicant submits the application under Subsection (2) and no criminal findings or
368 non-criminal findings after the date of conviction;
- 369 (c) has a class B misdemeanor or class C misdemeanor conviction for an offense
370 described in Subsection (5) with a date of conviction that is more than three years after, and no
371 more than 10 years before, the date on which the applicant submits the information described
372 in Subsection (2) and no criminal findings or non-criminal findings after the date of conviction;

373 (d) has a misdemeanor conviction for an offense not described in Subsection (5) with a
374 date of conviction that is no more than three years before the date on which the applicant
375 submits information described in Subsection (2) and no criminal findings or non-criminal
376 findings after the date of conviction;

377 (e) is currently subject to a plea in abeyance or diversion agreement for an offense
378 described in Subsection (5);

379 (f) appears on the Sex [~~and~~], Kidnap, and Child Abuse Offender Registry described in
380 [~~Title 77, Chapter 41, Sex and Kidnap Offender Registry~~] Title 77, Chapter 41, Sex, Kidnap,
381 and Child Abuse Offender Registry, or a national sex offender registry;

382 (g) has a record of an adjudication in juvenile court for an act that, if committed by an
383 adult, would be a felony or misdemeanor, if the applicant is:

384 (i) under 28 years old; or

385 (ii) 28 years old or older and has been convicted of, has pleaded no contest to, or is
386 currently subject to a plea in abeyance or diversion agreement for a felony or a misdemeanor
387 offense described in Subsection (5);

388 (h) has a pending charge for an offense described in Subsection (5);

389 (i) has a listing in the Division of Child and Family Services' Licensing Information
390 System described in Section 80-2-1002 that occurred no more than 15 years before the date on
391 which the applicant submits the information described in Subsection (2) and no criminal
392 findings or non-criminal findings dated after the date of the listing;

393 (j) has a listing in the Division of Aging and Adult Services' vulnerable adult abuse,
394 neglect, or exploitation database described in Section 26B-6-210 that occurred no more than 15
395 years before the date on which the applicant submits the information described in Subsection
396 (2) and no criminal findings or non-criminal findings dated after the date of the listing;

397 (k) has a substantiated finding of severe child abuse or neglect under Section 80-3-404
398 or 80-3-504 that occurred no more than 15 years before the date on which the applicant submits
399 the information described in Subsection (2) and no criminal findings or non-criminal findings
400 dated after the date of the finding;

401 (l) (i) is seeking a position:

402 (A) as a peer support provider;

403 (B) as a mental health professional; or

404 (C) in a program that serves only adults with a primary mental health diagnosis, with or
405 without a co-occurring substance use disorder; and

406 (ii) within three years before the day on which the applicant submits the information
407 described in Subsection (2):

408 (A) has a felony or misdemeanor charge or conviction;

409 (B) has a listing in the Division of Child and Family Services' Licensing Information
410 System described in Section 80-2-1002;

415 (m) (i) (A) is seeking a position in a congregate care program;

416 (B) is seeking to become a prospective foster or adoptive parent; or

417 (C) is an applicant described in Subsection (1)(a)(i)(F); and

418 (ii) (A) has an infraction conviction for conduct that constitutes an offense or violation
419 described in Subsection (5)(a)(i)(A) or (B);

420 (B) has a listing in the Division of Child and Family Services' Licensing Information
421 System described in Section 80-2-1002;

422 (C) has a listing in the Division of Aging and Adult Services' vulnerable adult abuse,
423 neglect, or exploitation database described in Section 26B-6-210;

424 (D) has a substantiated finding of severe child abuse or neglect under Section 80-3-404
425 or 80-3-504; or

426 (E) has a listing on the registry check described in Subsection (13)(a) as having a
427 substantiated or supported finding of a severe type of child abuse or neglect as defined in
428 Section 80-1-102; or

429 (n) is seeking to become a prospective foster or adoptive parent and has, or has an adult
430 living with the applicant who has, a conviction, finding, or listing described in Subsection
431 (6)(m)(ii).

432 (7) (a) The comprehensive review shall include an examination of:

433 (i) the date of the offense or incident;

434 (ii) the nature and seriousness of the offense or incident;

- 435 (iii) the circumstances under which the offense or incident occurred;
- 436 (iv) the age of the perpetrator when the offense or incident occurred;
- 437 (v) whether the offense or incident was an isolated or repeated incident;
- 438 (vi) whether the offense or incident directly relates to abuse of a child or vulnerable
439 adult, including:
- 440 (A) actual or threatened, nonaccidental physical, mental, or financial harm;
- 441 (B) sexual abuse;
- 442 (C) sexual exploitation; or

- 539 (K) child kidnapping, as described in Section 76-5-301.1;
- 540 (L) aggravated kidnapping, as described in Section 76-5-302;
- 541 (M) human trafficking of a child, as described in Section 76-5-308.5;
- 542 (N) an offense described in Title 76, Chapter 5, Part 4, Sexual Offenses;
- 543 (O) sexual exploitation of a minor, as described in Title 76, Chapter 5b, Sexual
544 Exploitation Act;
- 545 (P) aggravated exploitation of a minor, as described in Section 76-5b-201.1;
- 546 (Q) aggravated arson, as described in Section 76-6-103;
- 547 (R) aggravated burglary, as described in Section 76-6-203;
- 548 (S) aggravated robbery, as described in Section 76-6-302;
- 549 (T) lewdness involving a child, as described in Section 76-9-702.5;
- 550 (U) incest, as described in Section 76-7-102; or
- 551 (V) domestic violence, as described in Section 77-36-1; or
- 552 (ii) an offense committed outside the state that, if committed in the state, would
553 constitute a violation of an offense described in Subsection (13)(c)(i).
- 554 (d) Notwithstanding Subsections (5) through (10), the office shall deny a license or
555 license renewal to an individual seeking a position in a congregate care program or a
