

- West Davis Highway (Davis County)
- US-89; Farmington to I-84 (Davis County)
- Mountain View Corridor (Salt Lake County)
- Mountain View Corridor/2100 North Freeway (Utah County)
- SR-7, Southern Parkway (Washington County)



- West Davis Highway
 - o 16 miles
 - 2 lanes in each direction
 - 6 new interchanges
- Lanes open late 2023/early 2024





- US-89; Farmington to I-84
 - 9 miles 6-lane Freeway
 - Four New Interchanges
 - Two New Grade Separated Crossings
 - Remove At-Grade Crossings
 - New Frontage Road Connectivity
- Completed 2023







- Mountain View Corridor; Porter Rockwell Boulevard to Old Bingham Highway
 - 12 miles of new freeway
 - 2 lanes each direction
 - 13 interchanges
- Planned completion 2028





- Mountain View Corridor; 2100 North to Porter Rockwell Boulevard
 - 4 miles of new roadway
 - 2 lanes each direction
 - Interchange improvements at 2100 North
- Planned completion late 2025





- SR-7, Southern Parkway
 - 26 miles of roadway
 - 12 existing interchanges
 - 5 planned interchanges
