Legislative Interim Meetings

Meetings were held October, 11, 2023, or as noted

Business and Labor

County Recorder Standards Board

Discussed the purpose and function of the County Recorder Standards Board (CRSB), including its operations and activities, as outlined in the <u>CRSB annual report</u>. CRSB's purpose is to make rules to establish statewide standards for county recorders. Discussed recommendations for legislation from the CRSB to create more consistency in defining notarial acknowledgment across multiple statutes.

Action: Opened a committee bill file to create more consistency in defining notarial acknowledgment across multiple statutes.

Draft Legislation: Consumer Lender Notification Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Consumer Lender Notification Amendments," which would require a consumer lender to submit to the commissioner of financial institutions evidence of registration through the Nationwide Multistate Licensing System and Registry.

Draft Legislation: Massage Therapy Practice Act Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Massage Therapy Practice Act Amendments," which extends the sunset date for the Massage Therapy Practice Act by 10 years.

Employment of Minors

Discussed 2024 General Session draft legislation, "Employment of Minors Amendments," related to the employment of minors and state labor laws related to minors that conflict with federal labor laws. Discussed creating a state exemption for minors in the entertainment industry.

Legislative Prioritization of Licensing Reviews

Discussed the Office of Professional Licensure Review's (OPLR) statutory obligation to conduct a review of each regulated occupation at least once every 10 years. For calendar year 2024, <u>OPLR proposed</u> to conduct a review of personal care and economic opportunity occupations regulated by the Department of Commerce for:

- cosmetology;
- massage therapy;
- security;
- burglar alarm sales and service; and
- hunting and outfitting services.

Discussed the scope and review process. Received a <u>handout</u> about the review process timeline and requirements. Received a <u>presentation</u> from OPLR.

Action: Approved, without modification, the proposed list of occupational licenses for periodic review in 2024 and to submit a copy of the approved list to the Legislative Management Committee in accordance with Utah Code Section 13-1b-303.

Prelitigation Hearing Panels

Discussed the purpose, function, and role of the Division of Professional Licensing's (DOPL) prelitigation hearing panels that review alleged medical liability cases against health care providers. Received a presentation from committee staff on the historical timeline of the panels, current panel proceedings, and how the Utah Supreme Court has limited their use and policy options. Heard how DOPL fulfills its clerical role in administering the panels. Received comments from practicing attorneys and the primary provider of medical professional liability insurance in the state.

Action: Opened a committee bill file to eliminate prelitigation hearing panels in the Division of Professional Licensing that were created by the Utah Health Care Malpractice Act to hear alleged medical liability cases against health care providers.

Utah Office of Regulatory Relief

Discussed the Utah Office of Regulatory Relief's (UORR) maintenance of the regulatory sandbox program, regulatory relief webpage, and the noncustodial blockchain registry.

Discussed UORR's framework for analyzing the risks of removing or waiving laws and regulations that inhibit the creation of new and existing companies or industries, and reciprocity agreements between states that use or propose to use similar regulatory sandbox programs. Received a presentation and annual report from UORR.

Criminal Code Evaluation Task Force

October 12, 2023

Criminal Code Amendments

Discussed changes to 2024 General Session draft legislation, "Criminal Code Amendments." The changes include:

- making it a crime for individuals in a position of special trust in a high school to engage in certain sexual conduct with an adult high school student; and
- making it a crime for an individual to remove the clothing of another individual without the individual's consent in certain circumstances.

Action: Amended and referred 2024 General Session draft legislation, "Criminal Code Amendments," to the Law Enforcement and Criminal Justice Interim Committee for approval as a committee bill.

Economic Development and Workforce Services

Affordable Housing

Received a <u>presentation</u> from the deputy director of the Department of Workforce Services on the purpose and function of the Unified Economic Opportunity Commission and its subcommittee, the Commission on Housing Affordability. Discussed various federal and state government programs administered by the Division of Housing and Community Development under the Department of Workforce Services.

Received a <u>presentation</u> from J. Fisher Companies, an affordable housing developer, on past and current housing developments. Discussed funding sources, challenges, and the need for additional state funds.

Received a <u>presentation</u> from the Utah Housing Corporation on the programs it runs and the impacts of those funds. Received additional handouts on first-time homebuyer programs regarding:

- the <u>Utah First-Time Homebuyer Law Enforcement Grant;</u>
- the <u>Utah First-Time Homebuyer Assistance Program</u>; and
- the <u>Utah Veteran First-Time Homebuyer Grant</u>.

Heard from the Utah League of Cities and Towns regarding the role and challenges of local governments in addressing affordable housing.

Received a presentation and recommendations from <u>Summit County</u> and Columbus Pacific Development on recent and current affordable housing projects in Summit County, including challenges faced by the county.

Department of Cultural and Community Engagement Annual Report

Received a <u>presentation</u> from the Department of Cultural and Community Engagement on the <u>2023 Annual Report</u> and the impact of a select number of programs and plans for programming for future years.

Department of Workforce Services Annual Report

Received a <u>presentation</u> from the Department of Workforce Services on the <u>2023 Annual Report</u>, the state of Utah's economy and some of the department's programs serving refugees, supporting the unemployed and workforce, and assisting in rehabilitation services.

Governor's Office of Economic Opportunity Annual Report

Received a <u>presentation</u> from Strategic Initiatives and the Governor's Office of Economic Opportunity (GOEO) on the <u>2023 Annual Report</u> outlining the impacts of several GOEO programs, including incentives and grants and tourism and film.

Education

Draft Legislation: SafeUT and School Safety Commission

Action: Approved as a committee bill 2024 General Session draft legislation, "SafeUT and School Safety Commission Amendments," which would extend the sunset date for the commission by five years.

Draft Legislation: School Lunch Amendments

Received a presentation from a legislator on draft legislation "School Lunch Amendments," which would:

- create a school meal trust fund;
- create a tax credit for donations to the trust fund;
- create a tax credit to local education agencies to reduce school lunch debt; and
- appropriate money to cover the costs of reduced-price school meals.

Draft Legislation: Sensitive Material Review Amendments

Heard a <u>presentation</u> from committee staff on 2024 General Session draft legislation, "<u>Sensitive Material Review Amendments</u>," and discussed <u>potential changes</u> to the bill draft

Action: Voted to direct committee chairs to gather feedback on the bill draft from committee members and work with committee staff to update the bill file for the next interim committee meeting.

Public Education: Parent Engagement and Student Absenteeism

Received comments from Wasatch School District representatives on the district's parent liaison program and the effect it has had on student attendance rates.

Public Education: Utah State Board of Education

Received presentations from the State Board of Education (USBE) on its <u>legislative priorities</u> for the 2024 general session and its proposed <u>oversight framework</u> of USBE programs.

Federalism Commission

October 10, 2023

Impact of the New National Monument Along the Utah/Arizona Border

Discussed the possible impact of the newly created Baaj Nwaavjol'tah Kukveni – Ancestral Footprints of the Grand Canyon National Monument upon the citizens of Southern Utah, including utilities delivery, agricultural grazing, and mineral extraction.

Action: Voted to send a letter to the Secretary of the Interior opposing the creation of the national monument because of the impact it would have on the livelihoods and industry of the citizens of southern Utah.

Legislative Jurisdiction of Federally Controlled Lands

Action: Voted to direct the outside attorneys contracted with the Federalism Commission to work on updating the information available to commission members on the issue of legislative jurisdiction on federally controlled lands.

Moab Trails Closure

Action: Voted to send a letter to the Moab Bureau of Land Management Office and the Secretary of the Interior opposing the closure of off-road trails around Moab.

Statewide Resource Management Plan

Received <u>recommendations</u> from the Public Lands Policy Coordinating Office to revise statutes regarding the statewide resource management plan. **Action:** Opened a commission bill file to adopt the recommended changes to the statewide resource management plan.

U.S. Forest Service Policy on E-bikes

Heard from a legislator and the Department of Natural Resources regarding a recent policy change by the U.S. Forest Service.

Action: Voted to send a letter to the U.S. Forest Service requesting that it send someone to address questions regarding the e-bikes policy.

Water Issues

Received a presentation from the Colorado River Authority of Utah regarding federal involvement in water projects in Utah. Discussed efforts to protect the quantity of water that Utah is entitled to receive and how the lower basin states are addressing mandatory water reductions.

Government Operations

Committee Bill File Update

Received an update from committee staff on the status of committee bill files opened by the committee.

Draft Legislation: Joint Tenancy Presumption Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Joint Tenancy Presumption Amendments," which would provide that an ownership interest in real estate granted to two or more persons in their own right is presumed to be a joint tenancy with rights of survivorship unless otherwise declared in the grant.

Draft Legislation: Municipal and Special District Election Amendments

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "Municipal and Special District Election Amendments," which would modify the Election Code, in relation to municipal and special district elections, to describe election functions that are required to be performed by a county and those that may be performed by a municipality or special district.

Electronic Ballots for Emergency Responders

Considered 2024 General Session draft legislation, "Electronic Voting Amendments," which would authorize a registered voter assisting with an emergency on the date of an election to cast an electronic ballot under certain conditions.

Actions: Amended the short title of 2024 General Session draft legislation, "Electronic Voting Amendments," to "Emergency Responder Voting Amendments," and approved the draft legislation as a committee bill.

Initiatives and Referenda

Discussed <u>potential amendments</u> to ballot initiatives, including amendments to comply with the Americans with Disabilities Act.

Action: Opened a committee bill file to consider potential amendments to ballot initiatives.

Paid Leave Amendments

Discussed committee bill file, "Paid Leave Amendments," which would modify provisions related to paid postpartum recovery leave and paid parental leave provided by certain state employers for eligible state employees.

Right to Repair

Discussed the right to repair, which is directed at the ability of consumers to repair their own products instead of going back to the original manufacturer for service.

Health and Human Services

Draft Legislation: Caregiver Compensation Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Caregiver Compensation Amendments," which would amend a definition related to reimbursement for certain personal care services under Medicaid.

Draft Legislation: Coverage of Certain Mental Health Services

Discussed a <u>report</u> on the status of health benefit plans contracting with local mental health authorities to reimburse behavioral health crisis services.

Draft Legislation: Fatality Review

Action: Approved as a committee bill 2024 General Session draft legislation, "<u>Fatality Review Amendments</u>," which would amend fatality provisions.

Draft Legislation: Health and Human Services Amendments

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "<u>Health and Human Services Amendments</u>," which would address technical issues related to the 2023 General Session recodification of health and human services statutes.

Medicaid Hospital Assessments

Discussed ongoing efforts to address the scheduled sunset of the Inpatient Hospital Assessment Act and Medicaid Expansion Hospital Assessment Act.

Promoting Effectiveness and Efficiency in Health and Human Services

Received a <u>presentation</u> from the Foundation for Government Accountability on improving the effectiveness and efficiency of government services, including the elimination of fraud, waste, and other misuse.

Draft Legislation: Psychotropic Medication Oversight Pilot Program

Action: Approved as a committee bill 2024 General Session draft legislation, "Psychotropic Medication Oversight Pilot Program Amendments," which would remove the sunset date for the Psychotropic Medication Oversight Pilot Program and amend program provisions.

Draft Legislation: Rehabilitation Services Funding

Action: Approved as a committee bill 2024 General Session draft legislation, "Rehabilitation Services Amendments," which would consolidate the Neuro-Rehabilitation Fund and the Pediatric Neuro-Rehabilitation Fund and extend the related sunset date by 10 years.

Draft Legislation: Utah Health Data Authority

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "Health Data Authority Amendments," which would remove the Utah Health Data Authority from the Legislative Oversight and Sunset Act.

Judiciary

Committee Bill on Sexual Offenses

Received a <u>presentation</u>, <u>handout</u>, and <u>proposed language</u> from prosecutors and received comments from a defense attorney on a committee bill that would clarify statutes related to child sexual offenses.

Action: Voted to convene a working group to propose amendments to the committee bill that would address stakeholder comments regarding the definition of "sexual intercourse" in the child rape statutes.

Indigent Defense Commission Report

Received a <u>presentation</u> from the Indigent Defense Commission on its operations and the operations of indigent defense systems across the state.

Juvenile Justice and School Discipline Report

Received a <u>presentation</u> and comments from the Commission on Criminal and Juvenile Justice, Juvenile Justice and Youth Services, the State Board of Education, and school officials on a statutorily required report regarding juvenile justice and school discipline data.

Review of Required Reports

Received an <u>overview</u> from committee staff on required agency reports due to the committee and possible amendments to the list of required reports for the committee's consideration.

Sunset Review of the Interdisciplinary Parental Representation Pilot Program

Received a <u>presentation</u> from committee staff on the sunset review process and conducted a sunset review of the Interdisciplinary Parental Representation Pilot Program, which the Legislature created in 2022 to enhance parental representation in child welfare cases.

Action: Opened a committee bill file to extend the sunset date for the Interdisciplinary Parental Representation Pilot Program by two years.

Law Enforcement and Criminal Justice

Draft Legislation: Criminal Code Recodification and Cross References

Received a <u>presentation</u> from committee staff on the recodification of the criminal code. Discussed 2024 General Session draft legislation, "<u>Criminal Code Recodification and</u> Cross References."

Actions: Approved as a committee bill 2024 General Session draft legislation, "Criminal Code Recodification and Cross References," which would recodify Utah Code Sections 76-8-316, 76-8-316.2, 76-8-316.4, and 76-8-316.6.

Opened a committee bill file to clarify that propelling a bodily fluid qualifies as domestic violence.

Draft Legislation: Correctional Facility Amendments

Received a presentation from committee staff on 2024 General Session draft legislation, "Correctional Facility Amendments."

Action: Approved as a committee bill 2024 General Session draft legislation, "Correctional Facility Amendments," which would make it a crime to transport, provide, sell, or possess a communication device at a correctional facility in violation of facility policy.

Draft Legislation: Offender Registry Amendments

Received a presentation from committee staff on 2024 General Session draft legislation, "Offender Registry Amendments." Received comments from the Sex Offense Management Board on a subcommittee created by the board to examine the Sex and Kidnap Offender Registry and make recommendations for changes.

Action: Approved as a committee bill 2024 General Session draft legislation, "Offender Registry Amendments," which merges the Sex and Kidnap Offender Registry and the Child Abuse Offender Registry into a single registry called the "Sex, Kidnap, and Child Abuse Offender Registry" and changes the length of time an offender must register on the Sex, Kidnap, and Child Abuse Offender Registry when convicted of the crime of enticing a minor in certain circumstances.

Draft Legislation: School Threat Penalty Amendments

Received a presentation from committee staff on 2024 General Session draft legislation, "School Threat Penalty Amendments." Received a presentation from the Statewide Information and Analysis Center on incidents of school hoax and threat incidents.

Action: Approved as a committee bill 2024 General Session draft legislation, "School Threat Penalty Amendments," which requires a student to be suspended or expelled from a public school if the student makes a false emergency report targeted at a school, enhances the penalties for making a threat against a school and makes it a second degree felony for an actor to make a false emergency report in certain circumstances.

Sunset Review: Domestic Violence Data Task Force

Received a <u>presentation</u> from the Statewide Information Analysis Center on intimate partner violence and lethality assessment protocol.

Discussed extending the sunset date of the Domestic Violence Data Task Force, which gathers information and reports on lethality assessments and domestic violence data collection efforts.

Action: Opened a committee bill file to extend the sunset date of the Domestic Violence Data Task Force by three years.

Utah Communications Authority Update

Received a <u>presentation</u> from the Utah Communications Authority on the primary functions of the authority, ongoing difficulties, and potential solutions.

Medical Cannabis Governance Structure Working Group

October 10, 2023

Recommendations Related to Medical Cannabis Governance

Action: <u>Recommended</u> to the Health and Human Services and Natural Resources, Agriculture, and Environment interim committees:

- that the scope and authority of the Cannabis
 Production Establishment Licensing Advisory Board be
 amended to include oversight of medical cannabis
 pharmacies;
- that the ownership interest threshold for publicly traded cannabis production companies be increased from 2% to 10% for those who must disclose information and complete a background check;
- amendments to clarify that the pharmacist in charge has authority to determine which products are carried in the medical cannabis pharmacy they oversee;
- that the state establish a limit on the number of medical cannabis pharmacy licenses that a single entity may hold; and
- that the Medical Cannabis Governance Structure working group sunset date be extended by one year.

Industrial Hemp Program

Discussed opportunities to improve the structure and oversight of the industrial hemp program.

Medical Cannabis Business Tax Credits

Discussed the values of a tax credit versus decoupling approach for granting medical cannabis businesses state tax relief.

Other Working Group Recommendations

Discussed working group members' legislative priorities going into the 2024 General Session.

Potential Federal Rescheduling of Marijuana: Implications for Utah

Received a <u>presentation</u> from working group staff on the implications of the possible rescheduling of marijuana, from Schedule I to Schedule III, and the impact it would have on Utah's medical cannabis and industrial hemp programs. The working group discussed the possibility of federal rescheduling of marijuana.

Natural Resources, Agriculture, and Environment

Big Game Population Management

Received a <u>presentation</u> from the Division of Wildlife Resources regarding mule deer population management practices in Utah and efforts by the division and others to meet statewide deer population objectives.

Cloud Seeding Symposium

Heard comments from a legislator and the Division of Water Resources regarding the first Utah Cloud Seeding Symposium and goals of the cloud seeding program.

Draft Legislation: Coal Miner Certification Panel Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Coal Miner Certification Panel Amendments," which would extend the sunset date for the Coal Miner Certification Panel by 10 years.

Earthquake Early Warning Feasibility Study

Received a <u>presentation</u> from the Utah Geological Survey regarding the feasibility of implementing an Earthquake Early Warning system in the state and options to mitigate seismic risks and costs.



Meningeal Worm Study

Received a <u>presentation</u> from the state veterinarian and the Division of Wildlife Resources, which included a risk analysis of meningeal worm infection to domesticated elk in the state and recommendations to mitigate those risks.

Mining Permitting Processes

Heard from a legislator and the Division of Oil, Gas and Mining regarding procedural changes to <u>Title 40</u>, <u>Mining and Mines</u>, and efforts to improve the permitting process.

Performance Audit of the Intermountain Power Agency

Received a <u>presentation</u> from the Office of the Legislative Auditor General regarding the performance audit of the Intermountain Power Agency and recommendations for the committee's consideration and review.

Private Landowner Involvement in Wildlife Programs

Heard comments from a legislator and the Division of Wildlife Resources regarding Wildlife Board rules related to private property access.

Statewide Water Marketing Strategy Overview

Heard comments from the Division of Water Resources and Clyde Snow regarding water marketing strategies, the Utah Water Banking Act, pilot projects, upcoming events, and interactive tools for meeting water marketing milestones.

Political Subdivisions

Draft Legislation: Affordable Housing Grant Program

Discussed 2024 General Session draft legislation, "Affordable Housing Utility Relocation Fund Amendments," which would create a grant program in the Olene Walker Housing Loan Fund for the purposes of providing grant money to affordable housing developers to relocate utility lines.

Elected Officials Disclosure Consistency

Received a presentation from a legislator regarding elected officials <u>disclosure of information</u> requirements and <u>conflict of interest</u> statements required by the state, counties, municipalities, and special districts.

Action: Opened a committee bill file to address allowing municipalities and state land authorities to post disclosure documents for elected and appointed officials to the state database that is being developed by the Office of the Lieutenant Governor.

Draft Legislation: Growth in the Public Treasurer's Investment Fund

Action: Approved as a committee bill 2024 General Session draft legislation, "Public Fund Amendments," which would require the state treasurer to annually report on funds invested in the Public Treasurer's Investment Fund, by political subdivision.

Draft Legislation: Metro Townships

Action: Approved as a committee bill 2024 General Session draft legislation, "Metro Township Modifications," which would create the process for metro townships to convert to a city or town form of government and would repeal the current language authorizing metro townships.

Draft Legislation: Open and Public Meetings Act Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "Open and Public Meetings Act Amendments," which would modify the Open and Public Meetings Act by amending the definition of "meeting" and eliminating the term "convene."
