## **DEQ and LHDs Coordination Efforts Annual Status Report**

During the 2023 General Session, the Utah Legislature passed House Bill 71 (HB71), updating 19-1-201(4). The updated rule requires the Utah Department of Environmental Quality (DEQ) and the Local Health Department (LHD) Governance Committee to coordinate efforts when DEO evaluates a policy or rule that affects an LHD. Those efforts will be reported to the Administrative Rules Review and General Oversight Committee before November 1st of each year.

The Utah Department of Environmental Quality (DEQ) and the Local Health Department (LHD) Governance Committee consist of:

- 1. DEO Executive Director
- 2. Two representatives of DEQ appointed by the DEQ Executive Director
- 3. Three Health Officers of local health departments appointed from the Utah Association of Local Health Departments (UALHD) designated by UALHD.

As required in 19-1-201(4)(b), the DEO-LHD Governance Committee shall evaluate rules and department policies that affect local health departments. When evaluating a rule or policy, the committee must consider the following factors:

- 1. Compute an estimate of the cost to local health departments to comply with the rule or policy.
- 2. Specify whether additional funding is provided to local health departments to implement the rule or policy.
- 3. Advise whether the rule or policy is still needed.

A summary of the DEQ-LHD Governance Committee coordination efforts is listed in Table 1.
