Legislative Interim Meetings

Administrative Rules Review and General Oversight

November 13, 2023

Charter School Authorization Requirements

Received a presentation from representatives of charter schools and the State Charter School Board updating the progress made since the committee's last meeting. Discussed recommended changes to the education code that would clarify the timeline for approval of new charter school authorizers.

***Action:** Opened a committee bill file to adopt the recommended changes to the authorization timeline in conjunction with the State Charter School Board and State Board of Education.*

Commercial Use of Inedible Game Products

Received a presentation from committee staff and stakeholders on recent changes made by the Department of Natural Resources to administrative rule [R657-5-20](#). Discussed whether the rule change prohibiting the commercial use of inedible game byproducts complies with the intent of the Legislature.

***Action:** Opened a committee bill file recommending to the Legislature that all administrative rules be authorized, with the exception of the relevant portions of administrative rule R657-5-20.*

Davis School District Harassments Settlement

Received a presentation from administrators and board members from the Davis School District providing a summary of the [settlement agreement](#) between the district and the U.S. Department of Justice. Discussed the requirements of the settlement, including reporting requirements and how the district is involving students in proposed policy changes.

Business and Labor

Alcohol Quota Study

Received a presentation from a legislator giving a progress update on the alcohol quota study previously discussed by the committee. Discussed the timeline for reviewing the finalized report and development of legislation for the upcoming 2024 General Session.

Draft Legislation: Behavioral Health Licensing Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Behavioral Health Licensing Amendments](#)," which would modify licensing requirements for mental and behavioral health professions.

Draft Legislation: Charitable Solicitations Act Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Charitable Solicitations Act Amendments](#)," which would amend provisions related to charitable solicitations.

Draft Legislation: Commercial Filing Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Commercial Filing Amendments](#)," which would require the Division of Corporations and Commercial Code to send notice to a secured party of record if a debtor files a termination statement terminating a financing statement.

Draft Legislation: Consumer Lender Notification Amendments

Discussed changes to 2024 General Session draft legislation, "[Consumer Lender Notification Amendments](#)," which would modify the requirements for engaging in business as a consumer lender in the state.

Draft Legislation: Consumer Review Fairness Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Consumer Review Fairness Amendments](#)," which would prohibit certain consumer contracts from including provisions that restrict the ability of consumers to review a good or service and grant enforcement authority to the Division of Consumer Protection.

Draft Legislation: Corporate Dissolution Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Corporate Dissolution Amendments](#)," which would prohibit the Division of Corporations and Commercial Code from administratively dissolving a corporation or nonprofit corporation until the division requests that the State Tax Commission certify whether the entity is in good standing and provide the entity's contact information on file.

Draft Legislation: Division of Consumer Protection Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Division of Consumer Protection Amendments](#)," which would:

- enact and repeal provisions related to consumer complaints to the Division of Consumer Protection;
- consolidate processes for submitting and addressing complaints; and
- clarify conditions under which complaints are classified as public records.

Draft Legislation: Employment of Minors Amendments

Discussed 2024 General Session draft legislation, "[Employment of Minors Amendments](#)," which would:

- amend provisions related to employment of minors, including changing the hours that minors under 16 years old may work; and
- amend the list of permitted occupations for minors 10 years or older and 14 years or older.

Draft Legislation: Healthcare Malpractice Prelitigation Hearing Amendments

Discussed 2024 General Session draft legislation, "[Healthcare Malpractice Prelitigation Hearing Amendments](#)," which would repeal provisions of the Health Care Malpractice Act related to healthcare malpractice prelitigation hearing panels.



Draft Legislation: Insurance Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Insurance Amendments](#)," which would:

- exempt a health care sharing ministry from regulation under the Insurance Code, provided the health care sharing ministry makes certain disclosures to participants and the commissioner;
- require that motor vehicle liability coverage also include substitute transportation and prohibit certain practices in providing the coverage;
- require that certain licensees and prospective licensees report to the commissioner any civil action that is filed against the licensee or prospective licensee and involves conduct related to a professional or occupational license; and
- make several other policy and technical changes.

Draft Legislation: International Licensing Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[International Licensing Amendments](#)," which would broaden the Division of Professional Licensing's discretion to accept substantially similar education or experience in satisfaction of standard licensing requirements.

Draft Legislation: Physician Assistant Practice Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Physician Assistant Practice Amendments](#)," which would expand and clarify the scope of practice for a physician assistant.

Draft Legislation: State Construction and Fire Codes Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[State Construction and Fire Codes Amendments](#)," which would modify the state construction and fire codes.

Draft Legislation: Utah Office of Regulatory Relief Revisions

Action: Approved as a committee bill 2024 General Session draft legislation, "[Utah Office of Regulatory Relief Revisions](#)," which would modify the Utah Office of Regulatory Relief's responsibilities, the general regulatory sandbox program, and the composition and duties of the general regulatory sandbox program advisory committee.

Report: Confinement of Egg-laying Hens

Discussed a [statutorily](#) required [report](#) from the Department of Agriculture and Food about the efforts taken by farm owners and operators to comply with provisions that prohibit the confinement of an egg-laying hen in an enclosure.

Economic Development and Workforce Services

Deep Technology Talent Initiative Annual Report

Received a [presentation](#) from representatives of Talent Ready Utah, on the [Deep Technology Talent Initiative Annual Report](#). Talent Ready Utah, as part of the Utah System of Higher Education, administers several programs teaching technical and computer science skills to students of all ages throughout the educational systems in Utah.

Electric Bike Amendments

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "[Electric Bike Amendments](#)," which would refine the definition of electric assisted bicycles, requiring them to have moveable cranks with pedals attached at the time of manufacture.

Landowner Liability Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Landowner Liability Amendments](#)," which would expand the list of recreational activity injuries for which a landowner is not liable to include rock climbing and other similar activities.

Outdoor Recreation Infrastructure Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Outdoor Recreation Infrastructure Amendments](#)," which would alter the definition of "outdoor recreation infrastructure" to match the definition in Utah Code Section [79-7-501](#).

Utah Housing Policy Audit

Received a [presentation](#) from the Office of the Legislative Auditor on a performance [audit](#) of Utah Housing Policy. The audit reviews housing needs in Utah and the impact of previous legislation on housing trends and makes recommendations for future action.

Education

Draft Legislation: Alternative Education Scholarship Combination

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "[Alternative Education Scholarship Combination](#)," which would combine the Carson Smith Scholarship and Special Needs Opportunity Scholarship Programs into the Carson Smith Opportunity Scholarship Program and allow preschool and home school students to be eligible for a scholarship.

Draft Legislation: Classroom Neutrality

Reviewed draft legislation that would address neutrality for school officials and employees and incorporate recommendations from a State Board of Education working group on this issue.

Draft Legislation: Education Entity Amendments

Received a [presentation](#) from a legislator on 2024 General Session draft legislation "[Education Entity Amendments](#)," which would extend to home and micro-schools the duties, requirements, waivers, and rights currently granted to private and charter schools.

Action: Approved as a committee bill 2024 General Session draft legislation, "Education Entity Amendments."

Draft Legislation: Public Education Program Modifications

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "[Public Education Program Modifications](#)," which would implement a number of technical changes requested by the State Board of Education during the October 11, 2023, interim meeting.

Draft Legislation: Sensitive Material Review Amendments

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "[Sensitive Material Review Amendments](#)," which would clarify the definition of sensitive materials by establishing objective and subjective criteria for evaluating instructional materials in public education settings.

Draft Legislation: Statewide Online Education Program Modifications

Received an update from a legislator on progress made by a working group on the Statewide Online Education Program and discussed 2024 General Session draft legislation, "[Statewide Online Education Program Modifications](#)," which was opened by the chairs at the request of the State Board of Education.

Draft Legislation: Criminal Threat or Interference Amendments

Action: Amended and approved as a committee bill 2024 General Session draft legislation, "[Criminal Threat or Interference Amendments](#)," which would modify provisions related to criminal offenses conducted against a public servant, party official, or voter.

Draft Legislation: Department of Government Operations Revisions

Action: Approved as a committee bill 2024 General Session draft legislation, "[Department of Government Operations Revisions](#)," which would amend provisions related to the Division of Finance and the Division of Purchasing and General Services.

Draft Legislation: Division of Human Resource Management Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Division of Human Resource Management Amendments](#)," which would modify provisions of the Utah State Personnel Management Act.

Draft Legislation: Election Revisions

Discussed 2024 General Session draft legislation, "[Election Revisions](#)," which would modify provisions of the Election Code.

Draft Legislation: Electronic Notarization Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Electronic Notarization Amendments](#)," which would modify provisions related to electronic notarizations.

Draft Legislation: Initiatives and Referenda Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Initiatives and Referenda Amendments](#)," which would amend provisions relating to collecting signatures for, or removing signatures from, an initiative petition or a referendum petition.

Draft Legislation: Paid Leave Modifications

Action: Approved as a committee bill 2024 General Session draft legislation, "[Paid Leave Modifications](#)," which would address paid leave for certain state employees.

Draft Legislation: State Boards and Commissions Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[State Boards and Commissions Amendments](#)," which would establish sunset provisions for certain boards and commissions.

Post-Election Audit Study

Health and Human Services

Behavioral Healthcare

Received a [handout](#) from staff on 2024 General Session draft legislation, "[Behavioral Health System Amendments](#)," which would:

- amend three commissions and councils;
- create the Utah Behavioral Health Commission within the Department of Health and Human Services;
- create a Legislative Policy Committee under the commission; and
- sunset the commission in 2029.



Actions: Approved as a committee bill 2024 General Session draft legislation, "[Behavioral Health System Amendments](#)."

Approved as a committee bill 2024 draft legislation, "[Behavioral Health Crisis Response Modifications](#)," which would provide for the award of grants for the development of mobile crisis outreach teams and rural behavioral health receiving centers.

Contingency Planning for Continuity of Health and Human Services

Heard from the [Office of the Legislative Fiscal Analyst](#) and a [committee member](#) on managing federal funding risk.

Actions: Approved as a committee bill 2024 General Session draft legislation, "[Federal Funds Contingency Planning](#)," which would:

- repeal the annual federal receipts reporting requirement for state agencies;
- require certain state agencies to prepare a federal funds contingency plan at least every two years; and
- require a state sovereignty evaluation and a contingency analysis and plan with each federal funds request or reauthorization.

Approved as a committee bill 2024 General Session draft legislation, "[Health and Human Services Funding Amendments](#)," which would:

- require the Office of the Legislative Fiscal Analyst to analyze and make recommendations;
- extend the Medicaid Expansion Fund sunset date;
- fold the Medicaid Restricted Account into the Medicaid Growth Reduction and Budget Stabilization Account; and
- amend the conditions under which the Legislature may appropriate money from the Medicaid Growth Reduction and Budget Stabilization Account.

Health and Human Services Reporting Requirements

Action: Approved as a committee bill 2024 General Session draft legislation, "[Health and Human Services Reporting Requirements](#)," which would modify and repeal [reporting provisions](#) related to Department of Health and Human Services programs and replace a report for the Hepatitis C Outreach Pilot Program with a sunset date for the program.

Services for People with Disabilities

Heard from a committee member on the need for legislation to ensure that individuals with an intellectual or developmental disability can continue to be employed by sheltered workshops.

Social Work Licensure Compact

Action: Approved as a committee bill 2024 General Session draft legislation, "[Social Work Licensure Compact](#)," which would enact the Social Work Licensure Compact and provide rulemaking authority.

Judiciary

Draft Legislation: Airport Law Enforcement Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Airport Law Enforcement Amendments](#)," which would provide for the Department of Public Safety and the Utah Highway Patrol to assume law enforcement services for certain airports under certain conditions.

Draft Legislation: Criminal Accounts Receivable Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Criminal Accounts Receivable Amendments](#)," which would allow eligible individuals to request that the Office of State Debt Collection credit a portion of restitution payments against certain debts owed to the state.

Draft Legislation: Employment Confidentiality Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Employment Confidentiality Amendments](#)," which would make void and unenforceable nondisclosure and non-disparagement clauses in employment contracts and settlement agreements regarding sexual harassment and sexual assault disputes.

Draft Legislation: Joint Resolution Supporting Justice Court Reform

Action: Approved as a committee bill 2024 General Session draft legislation, "[Joint Resolution Supporting Justice Court Reform](#)," which would express the Legislature's support for the phased implementation of justice court reform.

Draft Legislation: Justice Court Reform Task Force Sunset Extension

Action: Approved as a committee bill 2024 General Session draft legislation, "[Justice Court Reform Task Force Sunset Extension](#)," which would extend the sunset date of the Justice Court Reform Task Force by 18 months.

Draft Legislation: Parental Rights Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Parental Rights Amendments](#)," which would clarify the requirements and procedure for voluntary relinquishment of parental rights.

Draft Legislation: Sexual Offenses Amendments

Action: Approved as a committee bill 2024 General Session draft legislation, "[Sexual Offenses Amendments](#)," which would clarify the conduct required for an actor to be guilty of certain sexual crimes committed against children.

Action: Recommended to the Judiciary Interim Committee 2024 General Session draft legislation, "[Joint Resolution Supporting Justice Court Reform](#)," which would express the Legislature's support for the phased implementation of justice court reform, with amendments to clarify how and when the reforms would be implemented.

Draft Legislation: Justice Court Reform Task Force Sunset Extension

Action: Recommended to the Judiciary Interim Committee 2024 General Session draft legislation "[Justice Court Reform Task Force Sunset Extension](#)," which would extend the sunset date by one year.

Criminal Code Amendments

Received a [presentation](#) from committee staff on 2024 General Session draft legislation, "[Criminal Code Amendments](#)," which would make changes to criminal offenses in [Title 76, Utah Criminal Code](#).

Action: Approved as a committee bill 2024 General Session draft legislation, "[Criminal Code Amendments](#)."

Domestic Violence Modifications

Action: Approved as a committee bill 2024 General Session draft legislation, "[Domestic Violence Modifications](#)," which would add the crime of propelling a bodily substance or material to the list of crimes that qualify as a domestic violence offense in certain circumstances.

Firearm Modifications

Action: Approved as a committee bill 2024 General Session draft legislation, "[Firearm Modifications](#)," which would address the punishment for individuals who use or possess a firearm while distributing illegal drugs.

Justice Reinvestment Initiative Report

Received a [report](#) from the Commission on Criminal and Juvenile Justice on the progress made on the five goals of the Justice Reinvestment Initiative as well as general crime indicators and the broad effects of reform.

Murdered and Missing Indigenous Relatives Task Force

Draft Legislation: Water Efficient Landscaping Requirements

Action: Approved as a commission bill 2024 General Session draft legislation, "[Water Efficient Landscaping Requirements](#)," which would restrict the use of lawn and turf by certain governmental entities.

Draft Legislation: Water Measuring and Accounting Amendments

Action: Approved as a commission bill 2024 draft legislation, "[Water Measuring and Accounting Amendments](#)," which would:

- modify the state water policy to address telemetry;
- grant rulemaking authority regarding measurement and accounting; and
- repeal outdated language.

Draft Legislation: Water Modifications

Action: Approved as a commission bill 2024 General Session draft legislation, "[Water Modifications](#)," which would address the regulation of water, including saved water.

Draft Legislation: Water Related Changes

Action: Approved as a commission bill 2024 General Session draft legislation, "[Water Related Changes](#)," which would address water related issues.

Draft Legislation: Water Shareholder Amendments

Discussed 2024 General Session draft legislation, "[Water Shareholder Amendments](#)," which would address the timing of a water company's response to a shareholder's proposed water right change application.

Draft Legislation: Water Usage Amendments

Discussed 2024 General Session draft legislation, "[Water Usage Amendments](#)," which would address the irrigating of lawn or turf in specified counties during a restricted period.

Draft Legislation: Water Usage By Schools

Action: Approved as a commission bill 2024 draft legislation, "[Water Usage by Schools](#)," which would:

- require water providers to analyze and report data related to water usage by certain schools and provide recommendations for water use reduction;

Property Tax - Real Property Price Disclosure and Transfer Taxes

Actions: Approved as a committee bill 2024 General Session draft legislation, "[Property Transaction Amendments](#)," which would require the grantor or the closing agent to make information about the property, including the purchase price, available to the county recorder when ownership of real property is transferred.
