## **Description:**

It is requested that the Utah Legislature fund a statewide effort to create a new unified vision for education. Utahns have high ambitions for the future of education and want to see improvements that will help every student gain the knowledge and skills needed to succeed professionally, find personal fulfillment, and contribute to their communities. But to accomplish these outcomes, Utah needs a clear and actionable vision for education. The requested \$250,000 will be matched by philanthropic support and will fund the local nonprofit Envision Utah to engage the public along with key education, legislative, state, and community leaders to create that vision. The result will be a vision and mission for education that has high levels of stakeholder and public support and that could be adopted into code by the Utah Legislature.

The project also anticipates a major convening event for education stakeholders; that event may also need to be scaled back. It is worth noting that philanthropic support for this effort may also be reduced with less legislative funding.

## Who would benefit from this request (who is the target audience)?

Utah public school students are the ultimate beneficiaries of this effort: a clear, actionable, and unified vision for education will foster a more effective learning environment for every student. Those who make decisions and policies impacting Utah's schools, including local education agencies, the Utah State Board of Education, and the Utah Legislature, will also benefit from a clearer unified vision.

#### What is this project or program intended to accomplish?

This project will create a vision and mission for education that has high levels of stakeholder and public support and that can be adopted into code by the legislature. This vision, along with the buy-in that will come from this process, will help local education agencies, the Utah State Board of Education, the Utah Legislature, and other education stakeholders create their own strategic plans and develop policies and priorities in alignment both with one another and with Utahns' hopes for education. This will also serve as a stronger tool for creating clear accountability in education.

# How will the Legislature know whether the project or program achieved its intended purpose?

At the end of this process, a recommended vision for education will be delivered to the Utah Legislature. It would be a strong indicator of success if the legislature adopts that vision into code with the support of the public and the education community. Short of that, greater alignment around education priorities among the public and education stakeholders would also indicate some success. Legislators will be involved in the process, and they will be able to evaluate the success of the effort throughout that process. Long-term success will be evaluated based on how effectively the new education vision guides education leaders and policymakers in their work and in improving student learning.

# **Section 5: Other Supporting Documents**

## **Intent Language**

The Legislature intends that the \$250,000 appropriated by this item be awarded to a private not-for-profit that serves as a neutral convener and raises additional private sector contributions to engage stakeholders to establish a mission and vision for education in Utah.
