Description:

This request will expand and enhance the workplace readiness of all students enrolled at SUU to enter the workforce upon graduation. SUU's career services office will expand capacity and offer career preparation and professional development including a significant increase in internship and practicum opportunities. Students will gain the career readiness skills and practical workplace experiences in addition to completed degrees that employers are seeking. Recent graduates as well as students working their way through college will be better prepared for the workplace while setting them up to contribute to their local communities and the state economy as talented and prepared new professionals. This request will fund new staff lines, operating expenses which include career assessment and expansion of a Professional Internship Program, and space renovation which affords every willing SUU student: - Completes a career assessment with a career coach - Receives career preparation training through the Career Academy (professionalism, writing,salary negotiation, critical thinking, problem-solving, etc.) - Gains real-world experience through participation in an internship, practicum, or SUU's Professional Internship Program - Receives job search training (resume/cover letter writing, interview preparation, mock interviews, etc.) - Receives job search assistance - Benefits from career/life coaching for their first year on the job
