This fundin g is intended to complete the capital stack necessary to fund pipeline replacement. Additional project funding is coming from loans from the federal EPA, as well as the Utah Division of Drinking Water and Ogden City ARPA funds. Ogden will be increasing its utility rates by approximately 50% over 7 years.
