Who would benefit from this request (who is the target audience)?

The Entire state of UT - wildlife and livestock populations contribute more than \$1 Billion in annual economic activity to UT. It is estimated wolf damage to herds and livestock costs ID, MT, and WY, tens of million each year. The State of ID has had to fund an annual \$500,000 wolf bounty program to try and mitigate damage.

What is this project or program intended to accomplish?

Keep wolves out of UT, until the state of UT is granted full management authority over wolf populations, in order to protect Utah's Wildlife herds, the hunting economy, the world renowned hunt expo, and livestock owners. Wolves also have killed man pets of people where wolves are found.

How will the Legislature know whether the project or program achieved its intended purpose?
