Section 4: Performance Outcome Measurement

Who would benefit from this request (who is the target audience)?

Family Promise hosts families with minor children while assisting them to find permanent housing. Families that are hosted are generally from Northern Utah but on occasion families from the Salt Lake Area will also be assisted.

What is this project or program intended to accomplish?

Currently, Family Promise hosts in an old North Ogden Fire Station that is run down and in need of repair; families sleep in one cramped room on mattresses. The building is difficult to heat or cool and is provided as a community service by North Ogden City but it is on a one-year lease that can be renewed.

How will the Legislature know whether the project or program achieved its intended purpose?

The structure will provide 20 beds from homeless families along with a day center for counseling and case management as well as offices for the staff. In 2023, over 1826 individuals in 546 families were served by Family Promise. The families follow a vigorous counseling program designed to teach them how to be independent, and once they graduate into housing, Family Promise follows them for 2 years
