The Coalition operates at a rate of approximately \$750,000 per year. The Coalition would have to pursue other funding options, including CIB. CIB does not have the grant funding it once did. The UBRY project would bring return revenue to the Coalition, but the Coalition would have to reach important process milestones to trigger that revenue (\$500,000/year).

Who would benefit from this request (who is the target audience)?

The Seven County Infrastructure Coalition's projects and planning efforts benefit the member counties (Carbon, Daggett, Duchesne, Emery, San Juan, Sevier, and Uintah). Projects like the UBRY will benefit the entire state of Utah, surrounding states, and the nation. The state would receive more than \$150M in tax revenue annually.

What is this project or program intended to accomplish?

The requested funding would allow the Coalition to continue its unique mission to identify and develop regional infrastructure projects within the energy-producing regions of the state. The Railway legal process MUST be finished, along with the ongoing planning and operations of the Coalition. Ultimately, the State stands to receive approximately \$27.9M in reimbursement from the Coalition's private partner.

Success will be achieved when the Railway legal process is brought to a close, allowing the private partner to pay the State approximately \$27.9M.
