### Who would benefit from this request (who is the target audience)?

Uintah County has identified that this program would benefit 100-1100 adult community members (annually) that are experiencing situational and/or chronic homelessness along with substance abuse addiction and mental health. The only (local) long-term housing resource is operated by the local MH/SA Authority is a twelve-bed occupancy unit and is at permanent capacity. Additionally, nearly 2,800 adult individuals in the local area receive behavioral health services every year with access to the General Outpatient Level of care only. Many of these individuals have to be displaced from our community and outsourced to the Wasatch front to receive a higher level of care treatment as well as access to licensed sober living resources.

### What is this project or program intended to accomplish?

Uintah County intends to establish a licensed housing program that would provide attainable, affordable, sustainable, and long-term housing stability for both male and female adults. Uintah County intends to establish local access to higher levels of behavioral health treatment which would allow the individual to remain in the community while receiving quality care. Uintah County would report directly to the State Agency with an annual report submission to be included in the area plan. The short-term target is to establish the foundation for a local continuum of care to be implemented that will include safe and affordable housing for adult individuals who are actively in substance use as well as suffering from mental health.
