The request for appropriations would have a positive ripple effect, benefiting individuals directly impacted by SMI and homelessness, the wider community, collaborating agencies, legal systems, and the organization itself.

What is this project or program intended to accomplish?

This project aims to significantly enhance the support and services provided by PAAG to individuals facing Severe Mental Illness (SMI) and homelessness. The funds will be utilized to expand safe and affordable housing options, strengthen drop-in center programs, and intensify community outreach initiatives. The overarching goal is to reduce homelessness, shelter stays, and prevent the incarceration of this vulnerable population. Through these interventions, the project seeks to create a more stable community, improve the overall mental health of participants, and foster long-term well-being.

How will the Legislature know whether the project or program achieved its intended purpose?

A short-term target for measuring progress could include a 20% reduction in the number of individuals experiencing homelessness within the first six months of implementing the enhanced services. Additionally, tracking a 15% decrease in shelter stays among the target population during this period would signify early success. Regular updates on the number of individuals accessing expanded services, positive client feedback, and collaborative efforts with partnering agencies should be provided to the Legislature to ensure transparency and demonstrate the project's effectiveness in its initial stages.
