A 2020 study revealed that companion animals played a crucial role in supporting individuals recovering from substance use disorders, particularly opioid use disorder. In 2023, Ruff Haven provided community members with 2,519 nights of safety and sobriety, emphasizing the importance of sheltering companion animals for those seeking substance use treatment. The organization is dedicated to innovation in programming, supporting individuals in substance use recovery and facing housing insecurity while addressing the trauma of separation from their animal companions.
