Description:

State Revenue Impact: Enactment of this bill assumes \$30,000,000 one-time of the total \$481,507,900 in Uniform School Funds transferred to the Public Education Economic Stabilization Restricted Account will be used to fund the appropriation detailed in the bill. State Expenditure Impact: Enactment of this bill appropriates \$30,000,000 one-time from the Public Education Economic Stabilization Restricted Account to the State Board of Education in FY 2025 to implement the Long-term Educational Achievement Program outlined in the bill. Enactment of this bill may cost the State Board of Education \$8,300 one-time from the Income Tax Fund in FY 2025 for administrative costs, the Board indicates that they can absorb this cost. The bill transfers another \$30,000,000 one-time in FY 2025 from the Uniform School Fund into the Public Education Economic Stabilization Restricted Account.
