1. Page 3, Lines 60 through 65:

60 As used in this chapter:

61 (1) (a) "Arts" means the various branches of creative human activity, including visual arts,

62 film, performing arts, sculpture, literature, music, theater, dance, digital arts, video-game arts,

63 and cultural vitality.

(b) "Arts" includes traditional, folk, classical, ethnic, contemporary, and other art forms.

- 64 (2) "Arts <u>and museums</u> board" means the Utah Arts <u>and Museums</u> Advisory Board
- 65 created in Section 9-6-301.

2. Page 20, Lines 596 through 603:

(b) select qualified recipients in accordance with Subsection (2).

597 (2) The office may distribute the money from the grant program to <u>or on behalf of</u> a private landowner:
