## HEALTH SHARING MINISTRY PLANS - ISSUES SUMMARY - Compiled May 31, 2022

## **OVERVIEW**

Health Sharing Ministries are non-profit entities through which hundreds of thousands of members who are willing to comply with the ministry requirements, (which are frequently faith based), voluntarily contribute and share in payment for other member's medical bills. Ministries maintain that they are not insurance plans and therefore not regulated through state insurance departments. Many ministries do not comply with ACA regulations and have a history of fraud. Intermountain has incurred significant financial losses through serving ministry plan members over the past several years. Many ministries encourage members to register for services as "private pay" to receive an up-front discount, after which the ministry may attempt to pay on the already discounted amount, or make no payment. Payer Contracting has made multiple attempts to contract with ministries to resolve these issues with no success.
