I have been involved in education for over 20 years and have watched as the federal government expanded its presence into and hindered the success of local schools. Since the early days of our republic, we have seen the federal government steadily and unconstitutionally encroach upon the rights of the states. Thomas Jefferson said, "that whensoever the General government assumes undelegated powers, its acts are unauthoritative, void, & of no force." So that begs the question, who decides when the federal government has overstepped its delegated powers? Unfortunately, we are incorrectly taught that it is the Supreme Court who makes that final decision, but that would be like letting the fox guard the henhouse. The federal courts are part of the federal government, so how could we expect them to be impartial? Jefferson taught that, "Where powers are assumed which have not been delegated, a nullification of the act is the rightful remedy: that every State has a natural right in cases not within the compact, (casus non fœderis) to nullify of their own authority all assumptions of power by others within their limits: that without this right, they would be under the dominion, absolute and unlimited, of whosoever might exercise this right of judgment for them." Nullification is not rebellion or anarchy. It isn't secession from the federal government. It is a constitutional method of preserving limited government. Elected officials swore an oath to the Constitution - not the federal government. It is clear that the founders viewed state nullification as the rightful remedy to unconstitutional acts by the federal government. We know that, "The powers delegated... to the federal government are few and defined." Therefore, our state legislature has a responsibility to protect our rights and liberties by standing up to the federal government and nullifying unconstitutional acts including those committed by the Department of Education.

The issue of transgender or gender-neutral bathrooms is an issue affecting privacy and security in public schools, universities, community centers and government buildings. The trouble began when President Joe Biden issued an executive order in 2021 redefining "sex" in all federal laws to include sexual orientation and gender identity. One effect was that the U.S. Department of Housing and Urban Development (HUD) issued a directive requiring schools to adopt the Biden administration's new definition of "sex" in federal law. It should be noted that HUD illegally deprived the public of notice and an opportunity to comment before issuing this rule change. By prohibiting discrimination on the basis of "gender identity," HUD's directive requires schools to allow male students who identify as female, and vice versa, into the opposite sex's dorms, showers, and bathrooms. This threatens the safety and privacy of all students, particularly women. This change has affected local schools such as the University of Utah. When I recently visited the University of Utah Marriot Library, I used a bathroom there that was gender neutral. Although the individual bathroom stalls were private, people of both genders were roaming about outside the stalls, and this made me uncomfortable. Also, gender-neutral or transgender bathrooms and locker rooms have become a major issue at SLC Community Centers, potentially compromising safety, security and privacy of families and individuals who use the community centers. The Salt Lake County Council voted in December 2023 to table discussion on a proposed ordinance to stipulate community centers have single-occupancy bathrooms and changing rooms for patrons, while designating multiple-occupancy bathrooms and locker rooms be restricted to the gender individuals were born with. Rep Kera Birkeland and Rep. Phil Lyman have introduced bills that address the issue of transgender bathrooms. This is a step in the right direction, but I believe even more needs to be done to protect the privacy and security of people using bathrooms, locker rooms, changing rooms and dorms that have become or could become transgender or gender neutral. I believe Biden's executive order and the resulting federal regulations affecting bathrooms, locker rooms, and related facilities should be overturned.
