1. Page 7, Lines 210 through 211:

210 (2) A qualifying claimant may claim a nonrefundable tax credit equal to 1.8%

109 (3) (a) "Anticompetitive business practice" means any practice that reduces the amount

110 of competition in the medical cannabis market that would be considered :

(i) an attempt to

111 monopolize, as defined in Section 76-10-3103{.--} ; or (ii) an illegal anticompetitive activity under Section 76-10-3104.

2. Page 74, Lines 2270 through 2271h:

2270 (2)Ŝ→ [[For a violation of Section 34A-5-114, the Legislature may withhold future state]

2271 [appropriations from a state agency or political subdivision]] Before taking an adverse employment

2271a action as defined in Section 34A-5-114 against an employee { who is known to be a } solely because the employee is a medical

2271b <u>cannabis cardholder or holds a prescription for another controlled substance</u>, a state employer or a political subdivision employer shall:

2271c (a) consult with legal counsel, if one is employed or contracted with to provide services to the
