



Recent Legislative Investments in Water

In recent years, Utah has faced a variety of water challenges which have been exacerbated by drought and population growth. In response, during the last four General Sessions (and one special session), the Legislature has invested over \$1.12 billion in water infrastructure and management. The following charts summarize appropriations according to project focus¹, recipient agency, revenue source, and more. The individual investments are listed according to legislative session on pages 2-4.

Most projects have been funded one-time (93%), which is logical considering nearly half of the funding (42%) came from one-time Federal funds provided by the American Rescue Plan Act. A little over half of the funds have been appropriated to the Department of Natural Resources, and roughly 60% of funding items were focused on either residential water (secondary and delivery) or irrigation water. The large drop in investments from the 2023 General Session to the 2024 General Session is likely due to a combination of reduced new revenue and exhausting the discretionary funding provided through the American Rescue Plan Act.


