# **Constitutional Sovereignty and Title IX Regulations**

Reviewed and discussed 2024 Third Special Session H.J.R. 301, "Joint Resolution-Legislative Findings on State Sovereignty in Regard to Title IX," and H.C.R. 301, "Concurrent Resolution-Directives to Government Officers Under the Utah Constitutional Sovereignty Act in Regard to Title IX."

Action: Voted to support 2024 Third Special Session H.J.R. 301, "Joint Resolution-Legislative Findings on State Sovereignty in Regard to Title IX," and H.C.R. 301, "Concurrent Resolution-Directives to Government Officers Under the Utah Constitutional Sovereignty Act in Regard to Title IX."

#### **Criminal Code Recodification**



#### **Economic Development**

# Special Session Draft Legislation: School District Amendments

Discussed 2024 Third Special Session H.B. 3003, "School District Amendments," which would repeal and amend certain provisions relating to creating a new school district and electing school board members when a new school district is created.

### **Federalism Commission**

June 18, 2024

#### **Education Issues**

Heard comments from members of the State Board of Education on a letter the board unanimously supported that requests the Legislature take action concerning the impact of new Title IX regulations. The board members also addressed questions from commission members about other federal actions that may be inconsistent with state sovereignty and the principles of federalism.

#### **Public Lands Management Issues**

Received a report from the Public Lands Policy Coordinating Office regarding land designations by the Bureau of Land Management (BLM) and the impact on the ability to construct the transmission lines necessary to develop new clean energies in the state.

Discussed efforts by the state to work with the federal government on:

- the Monroe Mountain grazing permits;
- the Grand Staircase Escalante Management and Grazing Plans; and
- other proposed BLM rules that would have a significant impact on public lands in Utah.

# **Government Operations**

#### **Division of Finance**

Received a <u>presentation</u> from the Division of Finance regarding the division's mission and vision, key functions and responsibilities, and strategic goals.

#### **Draft Legislation: Ballot Distribution Revisions**

Discussed Utah Code requiring an election officer to ensure that the bulk of ballots are mailed to voters from a location in Utah. The United States Postal Service processing center for southern Utah was relocated from Provo to Las Vegas, which has the effect of ballots being mailed to voters from outside of Utah.

Action: Approved as a committee bill 2025 General Session draft legislation, "Ballot Distribution Revisions," which would create an exception to the requirement that the bulk of ballots initially mailed to voters must be mailed from a location in Utah if the jurisdiction mailing the ballots is assigned to a United States Postal Service area distribution center outside of Utah.

#### **Internal Service Fund Rate-Setting Requirements**

Received a <u>presentation</u> (slides 1-6) from the Division of Facilities and Construction Management regarding internal service fund rate-setting requirements. The current process takes 22 months to propose and receive new funding, inhibiting cost recovery and market adjustments for the division's operations and maintenance programs. Discussed potential solutions such as a revised rate analysis and approval schedule or an alternate means of contingency funding to help alleviate the impacts associated with the Internal Service Fund rate-setting requirements.

**Action:** Opened a committee bill file to modify internal service fund rate-setting requirements.

#### **Intergovernmental Support Agreement**

Received a <u>presentation</u> (slides 7-9) from the Division of Facilities and Construction Management regarding intergovernmental service agreement policies. Discussed providing the division with the ability to enter into an intergovernmental support agreement and charge a fee to a non-state governmental entity, such as the United States military and U.S. Army Dugway Proving Ground, which has sought the division's services.

**Action:** Opened a committee bill file to address the division's limits in entering into an intergovernmental support agreement with a non-state governmental entity.

#### **State Agency Contact Information**

Discussed requiring state agencies and political subdivisions to post contact information on their websites for each function or public service that the entity provides to the public. Reviewed and compared several state agency webpages.

# Third Special Session Legislation: Sunset and Repeal Date Code Corrections

Action: Voted to support 2024 Third Special Session H.B. 3005, "Sunset and Repeal Date Code Corrections," which would non-substantively amend codified sunset and repeal date provisions to conform to a standardized format adopted during the 2024 General Session and non-substantively amend provisions in other portions of code to give effect to provisions from the sunset and repeal date code that no longer fit within the standardized format.

#### **Correctional Health Services Amendments**

**Action:** Opened a committee bill file to amend provisions related to correctional health services in an effort to reduce recidivism and improve access to behavioral health programs for incarcerated individuals.

# Government Response to Public Health Emergencies

Received a <u>presentation</u> regarding research studies on the safety and efficacy of vaccines, including the COVID-19 vaccines.

**Action:** Opened a committee bill file to address vaccine confidence.

#### **Transgender Treatment for Minors**

Received an <u>update</u> from committee staff on certain statutory provisions established by 2023 General Session S.B. 16, "<u>Transgender Medical Treatments and Procedures</u> Amendments."

Received an <u>update</u> from the Department of Health and Human Services on the systematic medical evidence review of hormonal transgender treatments in accordance with Section <u>26B-1-239</u>.

Received an <u>update</u> from the Division of Professional Licensing on the transgender treatment certification in accordance with Section <u>58-1-603</u> and discussed a <u>draft</u> clarification letter for health care providers.

Briefed on recent <u>studies</u> related to transgender treatment for minors, including "<u>The Cass Review: Independent Review of Gender Identity Services for Children and Young People</u>," a report commissioned by the National Health Service England to "... make recommendations on how to improve NHS gender identity services, and ensure that children and young people who are questioning their gender identity or experiencing gender dysphoria receive a high standard of care, that meets their needs, is safe, holistic and effective."

# 2024 Third Special Session

Utah State Legislature | June 19, 2024

# Summary of considered legislation:

On June 19, 2024, the Utah Legislature convened in Special Session to consider seven items.

<u>H.B. 3001</u>, Exchange Student Guardianship Amendments expands participation in the Statewide Online Education Program by allowing specified foreign exchange students to participate in the online program.

<u>H.B. 3002</u>, *Public Lands Funding Amendments* modifies the statutory authority of the Public Lands Litigation Restricted Account by renaming it the Federal Overreach Restricted Account, consolidating four appropriations into the restricted account, expanding the purposes for which the funds in the account can be used, and requiring an entity that receives funds from the restricted account to report to the Executive Appropriations Committee. H.B. 3002 also appropriates \$2.148 million from the restricted account to the Public Lands Policy Coordinating Office for efforts related to the management of public lands in Utah.

<u>H.B. 3003</u>, *School District Amendments* modifies provisions relating to the process to create a new school district and elect school board members when a new school district is created.

<u>H.B. 3004</u>, *Energy Security Adjustments* modifies provisions related to the decommissioning or disposal of project entity assets by expanding timelines for reporting requirements and allow**ing** for greater flexibility in the decommissioned assets process.

<u>H.B. 3005</u>, *Sunset and Repeal Date Code Corrections* completes the standardization of all sunset and repeal date sections and moves provisions with future modified language from the sunset and repeal date sections to their relevant section of code.

<u>H.J.R. 301</u>, Joint Resolution – Legislative Findings on State Sovereignty in regard to Title IX declares that Utah has the sovereign authority and responsibility to safeguard the state's health, safety, and welfare of, and to promote the prosperity of, Utah residents and that the federal government's overreach in regard to the new regulations adopted under Title IX infringes on this authority.

<u>H.C.R. 301</u>, Concurrent Resolution – Directives to Government Officers Under the Utah Constitutional Sovereignty Act in Regard to Title IX directs government officers to comply with Utah laws over Title IX regulations that conflict with state law.
