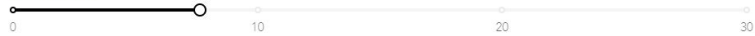

 - Up to \$20,000 in sales tax



Since 2018, online companies operating in MT are saving Utah boat owners:

- **\$500,000** per year in fees etc to boating restricted account
- **\$1.6m** per year in property taxes
- Tens of millions (Up to **\$68m**) in sales tax



Utah's Boats and OHVs:

- 65,000+ registered boats in Utah
 - ~\$5m revenue into restricted acct
- 230,000+ registered OHVs
 - ~\$12m revenue into restricted acct



Enforcement

- AG recommends 8 steps to determine a possible violation
- Often takes at least two separate interactions with the same boat 60 days apart
