### Overview of Property Tax Relief Programs

- Types of relief: Exemptions, credits, and deferrals
- Purpose: To alleviate the property tax burden on eligible homeowners
- Administering entities: County governments and the state

# Homeowner's Tax Credit (Circuit Breaker)

- Type: Mandatory
- Eligibility: Homeowners 66+ years or surviving spouses; income
   <\$40,840</li>
- Relief Amount: Credit up to \$1,259
- Funding: State General Fund
- Current Usage: 9,478 recipients in 2023

#### Homeowner's Valuation Reduction


- Type: Mandatory
- Eligibility: Homeowners 66+ years or surviving spouses; income
   <\$40,840</li>
- Relief Amount: Tax on 20% of fair market value
- Funding: County
- Current Usage: 7,976 recipients in 2023

### CB75+ Deferral Program

- Type: Discretionary
- Eligibility: Homeowners 75+ years; income <\$81,680; limited</li>
   liquid resources
- Relief Amount: Deferral of all or part of the tax
- Funding: State General Fund
- Current Usage: 2 recipients in 2023

### Challenges with CB75+ Deferral Utilization

- Estate Planning Concerns: Older homeowners are hesitant to pass on tax obligations to their estates
- Reverse Mortgages: Financial institutions holding liens are often unwilling to approve deferrals
- Awareness and Understanding: Potential beneficiaries may lack awareness of or understanding of the program.

### Impact on Counties

- County Revenue: Deferred taxes impact revenue
- Administration: Complexity in managing applications and approvals
- Balancing Act: Providing relief while maintaining fiscal health

# Moving Forward

- Policy Considerations: Explore ways to encourage CB75+ Deferral use
- Outreach and Education: Increase awareness of all available programs
- Collaboration: Work with financial institutions to address reverse mortgage issues
