35	Appeals Board, councils, Child Care Advisory Committee, and economic service areas.
36	(1) There is created within the department the following divisions:
37	(a) the Workforce Development Division to administer the development and
38	implementation of employment assistance programs;
39	(b) the Workforce Research and Analysis Division;
40	(c) the Unemployment Insurance Division to administer Chapter 4, Employment
41	Security Act;
42	(d) the Eligibility Services Division to administer public assistance eligibility;

101	(2) The office shall be administered by a director who shall be appointed by the executive
102	director and who may be removed from that position at the will of the executive director.

134	(3)(a) Money shall be deposited into the fund from legislative appropriations, federal
135	grants, private foundations, and individual donors.
136	(b) The director shall encourage a refugee who receives services funded under
137	Subsection (8) to be a donor to the fund when the refugee's financial situation
138	improves sufficiently to make a donation.
139	(4) Except for money restricted to a specific use under federal law or by a donor, the
140	director may not spend money from the fund without the input described in Subsection
141	<u>(2).</u>
142	(5) The state treasurer shall invest the money in the fund under Title 51, Chapter 7, State
143	Money Management Act, and all interest or other earnings derived from the fund money
144	shall be deposited into the fund.
145	(6) Money in the fund may not be used by the director for administrative expenses.
146	(7) If the department establishes a refugee services advisory committee referenced in
147	Subsection (2), the committee may:
148	(a) advise the director on refugee services needs in the state and on relevant operational
149	aspects of any grant or revenue collection program established under this part;
150	(b) recommend specific refugee projects to the director;
151	(c) recommend policies and procedures for administering the fund;
152	(d) make recommendations on grants made from the fund for refugee services activities
153	authorized under this section;
154	(e) advise the director on the criteria by which grants from the fund shall be made;
155	(f) recommend the order approved projects should be funded;
156	(g) make recommendations regarding the distribution of money from the fund in
157	accordance with federal or donor restrictions; and
158	(h) have joint responsibility to solicit public and private funding for the fund.
159	(8) The director may use fund money to:
160	(a) train an existing refugee organization to develop its capacity to operate
161	professionally and effectively and to become an independent, viable organization; or
162	(b) provide grants to refugee organizations and other entities identified in Subsection (9)
163	to assist them:
164	(i) with case management;
165	(ii) in meeting emergency housing needs for refugees;
166	(iii) in providing English language services;

167	(iv) in providing interpretive services;
168	(v) in finding and maintaining employment for refugees;
169	(vi) in collaborating with the state's public education system to improve the
170	involvement of refugee parents in assimilating their children into public schools;
171	(vii) in meeting the health and mental health needs of refugees;
172	(viii) in providing or arranging for child care services; or
173	(ix) in administering refugee services.
174	(9) The director, with the input described in Subsection (2), may grant fund money for
175	refugee services outlined in Subsection (8) through a request for proposal process to:
176	(a) local governments;
177	(b) nonprofit community, charitable, or neighborhood-based organizations or private
178	for-profit organizations involved with providing or arranging for the provision of
179	refugee services; or
180	(c) regional or statewide nonprofit organizations.
181	(10)(a) The director shall enter into a written agreement with each entity that
182	successfully applies for a grant.
183	(b) The agreement shall include specific terms for each grant consistent with the
184	provisions of this section, including the structure, amount, and nature of the grant.
185	(11) The director shall monitor the activities of the recipients of grants issued from the fund
186	on an annual basis to ensure compliance with the terms and conditions imposed on the
187	recipient by the fund.
188	(12) The director shall require an entity that receives a grant under this section to provide
189	periodic accounting of how the money was used.
190	(13) As part of the annual written report described in Section 35A-1-109, the director shall
191	report the status of the fund, including programs and services funded by the fund.

194	(1) In accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act, the
195	department may make rules to provide for the administration and coordination of
196	services to refugees beyond the time period refugee assistance is provided or funded by
197	the federal government, including the provisions of:
198	(a) services to address emergency needs;
199	(b) English language training; and
200	(c) services for victims of domestic violence.

- (a) with input from the department and any office or advisory committee involved with
 the provision of refugee services within the department; and
- (b) in accordance with any state and federal requirements related to the provision of
