# Rules in Progress

Rules with ~3 year timeline that meet CAA requirements and get area closer to attainment

Cumulatively equal to removing 13.2% of car and truck emissions

#### Gas dispensing rule

- Replace nozzles and hoses on gas pumps to reduce drips and fugitive emissions
- 215 tpy of emissions removed at \$6.5K \$9K / ton

#### Small 2-stroke yard care equipment

- Limit use of gas-powered trimmers, edgers, and blowers on high ozone days
- Up to 1,076 tpy of emissions removed at \$5K / ton for entire fleet to electricity

#### Major industry control analysis

- Analyze major source operation controls, and determine feasibility
- At least 800 tpy of emissions removed between \$1K-40K / ton

#### Refinery tank controls

- Improve controls on large refinery tanks that store volatile compounds
- Approximately 365 tpy of emissions removed with cost / ton estimates ongoing

# Rules in Progress

Rules with short and long term timelines that meet CAA requirements and get area closer to attainment

#### Long Term (3+ Years)

- Process heater emission limits
- Non-road equipment rules (SB 136)
- Tier upgrade and compliance standards for engines
- Composting
- Update solvent cleaning and adhesive/sealant applications
- Industrial baking
- Halogen reductions (HB 220)
- Low volatility gasoline (CAA required)
