

# LFA's Initial Summary of the Governor's Budget Recommendations

December 5, 2024

# **Statewide Impact**

# Compensation

#### State Employee Compensation

- \$59.7 m for a 2.5% cost of living adjustment
- \$47.8 m one-time for a Pay for Performance Increase (2% equivalent)
- \$19.5 m for a 5% health insurance benefits rate increase
- \$6.7 m one-time for an employee 401(k) match increase
- \$2.6m one-time and \$3.8 m ongoing for ISF Compensation Increases
- \$1.2 m for a 0.11% Tier-2 Salary Increase
- \$1.1 m for a 6.9% Dental Insurance benefits rate increase
- Did not recommend Targeted Compensation Increases

#### **Higher Education Compensation**

- \$50.5 m for a 2.5% cost of living adjustment

Note: The Utah Board of Higher Education is authorized to make its own budget requests to the Legislature. Below is a list of their requests with comparisons to the Governor's recommendation.
