

 - Request is included in the Rural Success section of the Governor's proposed budget for FY26






FY25 Appropriations


- With the \$500,000 in one-time funding for legal counsel, PLPCO hired a former Idaho District Court judge
- PLPCO, following the recommendation from the LFA, also hired a financial analyst who is working with the DNR finance team





Restrictive Rules and Designations








Public Lands Rule


- Museum management "Look, don't touch" approach
- Allows for restoration and mitigation leases – land use authorizations that the BLM can utilize to limit congressionally approved uses and activities that are mandated on public lands
- Circumvents/violates existing law and processes required by the Federal Land Policy and Management Act (FLPMA, 1976)

Continuing R.S 2477 Work

Win:

Judge Waddoups ruled that the state and counties are "holders of vested title" of certain R.S. 2477 rights-of-way

R.S. 2477 Statistics:

- Sworn deposition testimony on 8,500+ roads
- 72% of all R.S.2477 roads have been filmed
- Filmed over 1,100 roads/3,000 miles in 2024

Recent Action:

House Rock Valley Road culvert installation providing access The Wave and other tourist destinations in Kane County

Future Concerns:

BLM continues to close R.S. 2477 roads during Travel Management Planning (TMPs)


BLM Travel Management Planning

Finalized BLM Road Closures: 2,174 miles

- San Rafael Swell: 665 miles
- Labyrinth Rims/Gemini Bridges: 317 miles
- Henry Mountain/Fremont Gorge: 612 miles
- San Rafael Desert: 534 miles
- Canyon Rims/Indian Creek: 46 miles



National Monuments

 The Antiquities Act of 1906 states that national monuments must be, "the smallest area compatible with the proper care and management of the objects to be protected"




- The Bears Ears and Grand Staircase-Escalante National Monuments combined are:
 - 4x the size of Utah's 5 National Parks combined
 - 50x the size of Utah's 7 other National Monuments combined

Resource Development Coordinating Council (RDCC) processed **691** projects and PLCPO submitted **280** comment letters in 2024





Stand For Our Land Education Campaign Statistics

- TV, Billboards, Radio, and Online media:
 - 144 million impressions
- Creative platforms (e.g. Meta & print media):
 - 19.6 million impressions
 - 137,000 clicks to StandForOurLand.utah.gov
- The earned media coverage generated from this effort was extensive, with a total reach of over 1.2 billion nationally from August 20 to August 30.


