Section 1: Requester Details

Description:

Funding request for the Family Interim Non-Congregate Children Housing (FINCH) facility located at 315 W. 3300 S., South Salt Lake. This site has been in development and moving through city planning processes since March 2023. The property was acquired through funding partnerships with the Office of Homeless Services (OHS), Salt Lake County, Salt Lake City and the Church of Jesus Christ of Latter Day Saints. The operating and safety/security budget for the facility is \$5.8m. One-time funding was identified by OHS and approved for use by the Utah Homeless Services Board, and is being used for the facility from February 2025 - June 30, 2025. Funding is requested in the amount of \$6,000,000 in TANF to be spent over 3 years

Who would benefit the most from this request (who is the target audience)?

Children and families are experiencing homelessness at higher rates than our state has ever seen. From FY21 to FY24 we have seen a 60% increase in the number of people in families experiencing homelessness and a 58% increase in the number of children under 18 in these families experiencing homelessness throughout the state.

What is this project or program intended to accomplish?

The dedicated supportive services team for the non-congregate shelter will engage households in creating stability plans, which will focus on increasing income, securing safe and affordable housing, and addressing barriers to support individuals on their pathway to human thriving. The supportive services team will collaborate on a regular basis with law enforcement on cases involving participants with active warrants, criminal activity, and other needs to ensure a safe and positive environment for families.

How will the Legislature know whether the project or program achieved its intended purpose?

There will be an increase in the number of beds available and families served in the emergency shelter crisis system in Salt Lake County.
