Description:

There is currently a lack of affordable land acquisition and pre-development (A&D) lending for affordable housing developers. The one-time \$3 million appropriation will be combined with CRA funds from Utah banks to create a \$27 million, 90% loan-to-value A&D loan fund. The fund will create affordable, multi-family housing for less than 80% AMI Utahns along the Wasatch Front and throughout the state.

A short explanation describing how the project might be scaled?

The \$3 million of State funds will be matched by Afforda funds that have accrued over the past 10 years and combined with \$21 million of Utah bank CRA funds. The fund would create 3,000 affordable units over 5 years. The fund scales at any level. For example if the State were to appropriate \$1 million, Afforda would match with \$1 million and combine \$7 million of Utah bank CRA funds to create a \$9 million fund projected to create 1,000 units over 5 years.

What is this project or program intended to accomplish?

The program will provide \$27 million in land acquisition & pre-development lending for multi-family housing developers. The fund will create 600 affordable units (less than 80% AMI) a year. Funds provided by the State will be used entirely for lending and not for administrative costs.

How will the Legislature know whether the project or program achieved its intended purpose?

The fund achieves 600 units created annually by affordable housing developers.
