

2025 Approved Interim Study Items List (Amended), Audits, & Sunsets

Education Interim Committee | May 21, 2025

Study Items List

This list was approved by the Legislative Management Committee.

General Items

- 1. **U.S. Department of Education**: Review changes to the Department of Education and other federal education programs made by the current administration.
- 2. **Building Costs in Higher Education and Public Education**: Review building costs for K-12 and higher education to understand the variance in price across different projects.
- 3. **Reports**: Review reports due to the Education Interim Committee and reports required from local education agencies.

Higher Education

- 1. **Utah Board of Higher Education**: Hear a report on recent board action on the following:
 - The board's new policy on institutional statements acknowledging relationships with tribes and ancestral lands (<u>R252</u>).
 - Institutions' 2025 <u>tuition and fees increases</u> approved by the board.
- 2. **Utah Board of Higher Education Strategic Plan**: The Utah Board of Higher Education adopted a strategic plan in 2024; the board will update the committee on their progress on the plan.
- 3. **Strategic Reinvestment Plan**: Hear a report on the strategic reinvestment plans required of each institution of higher education in <u>HB 265</u> (2025).
- 4. **Higher Education Shared Services**: Hear an update on implementation of shared services across institutions of higher education within the Utah System of Higher Education.
- 5. **Higher Education Recodification**: Study options for recodifying the higher education code, Title 53B.

Public Education

- 1. **Administrator Salaries in Public Education**: A statewide overview and study of public-school administrator salaries in the state.
- 2. **Arts Education**: Overview of arts education in the state. This includes looking at the Beverly Taylor Sorenson Elementary Arts Learning Program.
- 3. **Utah High School Activities Association**: Review the role of the Utah High School Activities Association and the state's relationship with the association.
- 4. **LEA Employee Disciplinary Action**: Study the landscape for LEA disciplinary actions and how schools address issues of child abuse and misconduct in schools.
 - Review local and state discipline procedures for LEA employees.
 - Review the process for background checks.
 - Review the Utah Professional Practices Advisory Commission (UPPAC). This includes finding solutions to the backlog of cases UPPAC is facing and how to prevent further backlogs.



- 5. **State Board of Education Governance**: Review the State Board of Education's response and efforts to address recommendations from Audit 2021-04, "A Performance Audit of the Utah State Board of Education's Internal Governance."
- 6. **Special Education**: Overview of special education in the state. This includes looking at learning disabilities, screening methods, and other items related to special education.
- 7. **Charter Schools**: Review of the charter school landscape, including charter authorizers and charter school funding.
- Utah Schools for the Deaf and Blind (USDB): <u>HB 2</u> (2025) requires the Utah State Board of Education, in consultation with the Public Education Appropriations Subcommittee, to review USDB's governance, funding, scope of services, and capital facilities.
- 9. **Chronic Absenteeism**: Review specific policy solutions to address chronic absenteeism.
- 10. **Simplifying the Education Code**: Study education code (Titles 53E, 53F, 53G) for ways to make the code more accessible for educators and parents.
- 11. **Utah State Board of Education Program Oversight Reports**: Report on programs over which the state board has oversight.
- 12. **School Lunchtime and Recess**: Study how students are impacted by the way schools implement lunchtime and recess.
