## Legislative Interim Meetings

Meetings were held June 18, 2025, or as noted

### Business and Labor

#### Insurance Market Update

Received a [presentation](#) from the Insurance Department on overall trends in insurance markets to assess the ongoing impacts of enacted legislation and the need for further statutory changes. Discussed forthcoming federal legislation impacting insurance markets and reviewed premium trends in the health, auto, and property markets.

#### Junk Fees

Received a [presentation](#) from the Division of Consumer Protection on complaints regarding extra fees received that are not clearly communicated to consumers prior to purchase. Discussed model legislation from other states that mandate transparency for sellers and ban or restrict the practice of withholding mandatory costs until later in a transaction.

**Action:** Opened a committee bill file to work with the Division of Consumer Protection to draft language based on other state policies to ban or restrict the use of junk fees.

### Legislative Audit: Emergency Medical Transportation

## Sunset Review: Behavior Analyst Licensing Act

Considered 2026 General Session draft legislation, "[Behavior Analyst Licensing Amendments](#)," which would extend the sunset date of the Behavior Analyst Licensing Act by 10 years.

**Action:** *Approved as a committee bill 2026 General Session draft legislation, "Behavior Analyst Licensing Amendments."*

## Sunset Review: Health Care Providers Immunity from Liability Act

Considered 2026 General Session draft legislation, "[Health Care Providers Immunity Amendments](#)," which would extend the sunset date of the Health Care Providers Immunity from Liability Act by 10 years.

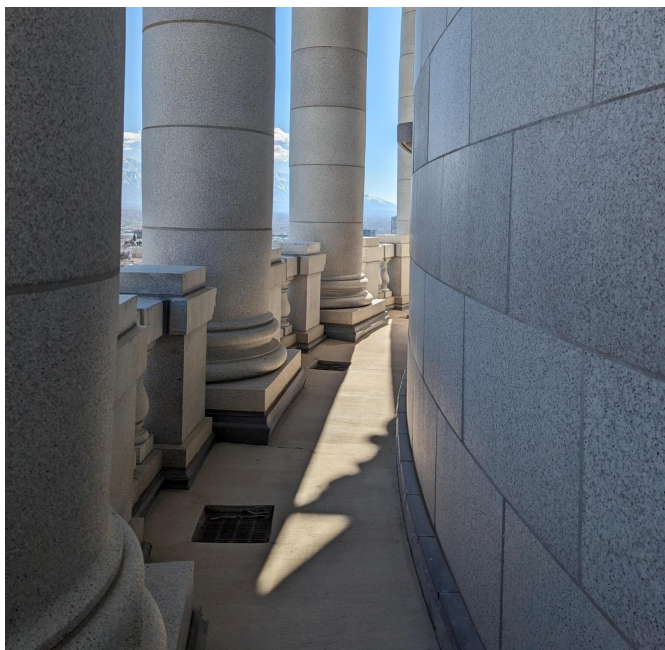

## Federalism Commission

June 19, 2025

### Department of Environmental Quality

Received a report from the Department of Environmental Quality (DEQ) on recent changes in environmental regulation at the federal level and DEQ's efforts to coordinate with the EPA on rules and oversight, and issues where the state could work to assert state's rights. Issues where DEQ would like to assert further authority include coal carbon residual regulations, lead and copper rules under the Safe Drinking Water Act, and Clean Water Act dredge and fill provisions.

### Eisenhower Study Results

Received a [presentation](#) from an attorney regarding work to [update](#) the 1956 Eisenhower Study that defined the legal jurisdiction of the federal government on public lands. Discussed how the findings in the report could impact Utah and the management of public lands within the state.

### Implementation of H.B. 488

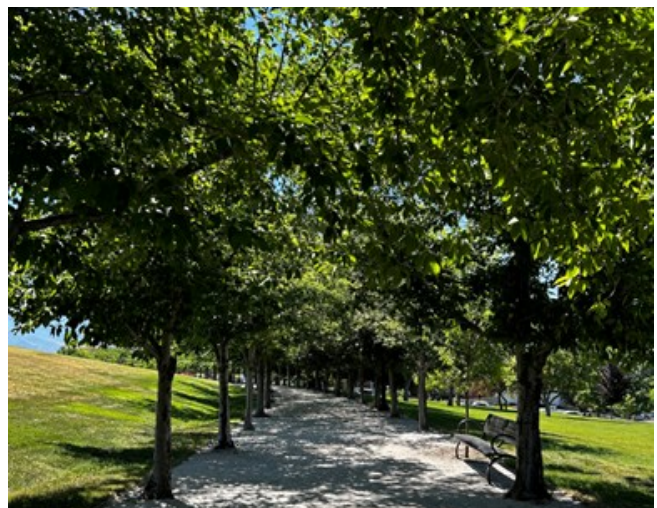
