37 *Be it enacted by the Legislature of the state of Utah:*

38 Section 1. Section **26B-2-105** is amended to read:

39 **26B-2-105 . Licensure requirements -- Expiration -- Renewal.**

40 (1) Except as provided in Section 26B-2-115, an individual, agency, firm, corporation,
41 association, or governmental unit acting severally or jointly with any other individual,
42 agency, firm, corporation, association, or governmental unit may not establish, conduct,
43 or maintain a human services program in this state without a valid and current license
44 issued by and under the authority of the office as provided by this part and the rules
45 under the authority of this part.

46 (2)(a) For purposes of this Subsection (2), "member" means a person or entity that is
47 associated with another person or entity:

48 (i) as a member;

49 (ii) as a partner;

50 (iii) as a shareholder; or

51 (iv) as a person or entity involved in the ownership or management of a human
52 services program owned or managed by the other person or entity.

53 (b) A license issued under this part may not be assigned or transferred.

54 (c) The office shall treat an application for a license under this part as an application for
55 reinstatement of a revoked license if:

56 (i)(A) the person or entity applying for the license had a license revoked under this
57 part; and

58 (B) the revoked license described in Subsection (2)(c)(i)(A) is not reinstated
59 before the application described in this Subsection (2)(c) is made; or

60 (ii) a member of an entity applying for the license:

61 (A)(I) had a license revoked under this part; and

62 (II) the revoked license described in Subsection (2)(c)(ii)(A)(I) is not reinstated
63 before the application described in this Subsection (2)(c) is made; or

64 (B)(I) was a member of an entity that had a license revoked under this part at

- 65 any time before the license was revoked; and
- 66 (II) the revoked license described in Subsection (2)(c)(ii)(B)(I) is not reinstated
- 67 before the application described in this Subsection (2)(c) is made.
- 68 (3)(a) Subject to Section 26B-2-110, and after the five-year waiting period described in
- 69 Subsection 26B-2-110(1)(c), the office may conditionally approve an application for
- 70 reinstatement as described in Subsection (2)(c), for a maximum of two years, if:
- 71 (i) the applicant's license was previously revoked due to repeated or chronic
- 72 violations; or
- 73 (ii) after the applicant's license was previously revoked, the applicant associated with
- 74 another human services program that provides a service that is substantially
- 75 similar to the services for which the applicant was previously licensed.
- 76 (b) If the office issues a conditional license under Subsection (3)(a), the office shall
- 77 prepare a conditional license plan describing the terms and conditions of the
- 78 conditional license.
- 79 (4) A current license shall at all times be posted in the facility where each human services
- 80 program is operated, in a place that is visible and readily accessible to the public.
- 81 (5)(a) Except as provided in Subsections (5)(c) and (d), each license issued under this
- 82 part expires at midnight on the last day of the same month the license was issued, one
- 83 year following the date of issuance unless the license has been:
- 84 (i) previously revoked by the office;
- 85 (ii) voluntarily returned to the office by the licensee; or
- 86 (iii) extended by the office.
- 87 (b) A license shall be renewed upon application and payment of the applicable fee,
- 88 unless the office finds that the licensee:
- 89 (i) is not in compliance with the:
- 90 (A) provisions of this part; or
- 91 (B) rules made under this part;
- 92 (ii) has engaged in a pattern of noncompliance with the:
- 93 (A) provisions of this part; or
- 94 (B) rules made under this part;
- 95 (iii) has engaged in conduct that is grounds for denying a license under Section
- 96 26B-2-703; or
- 97 (iv) has engaged in conduct that poses a substantial risk of harm to any person.
- 98 (c) The office may issue a renewal license that expires at midnight on the last day of the

- 99 same month the license was issued, two years following the date of issuance, if:
- 100 (i) the licensee has maintained a human services license for at least 24 months before
- 101 the day on which the licensee applies for the renewal; and
- 102 (ii) the licensee has not violated this part or a rule made under this part.
- 103 (d)(i) For a foster home that has been licensed for fewer than two years, a foster
- 104 home license issued on or after May 1, 2023, expires at midnight on the last day of
- 105 the same month the license was issued, one year following the date of issuance.
- 106 (ii) For a foster home that has been licensed for two or more years, a foster home
- 107 license issued on or after May 1, 2023, expires at midnight on the last day of the
- 108 same month the license was issued, three years following the date of issuance:
- 109 (A) unless the license is placed on conditions, suspended, or revoked by the office,
- 110 or voluntarily returned to the office by the licensee; and
- 111 (B) if the licensee has not violated this part or a rule made under this part.
- 112 (iii) A foster home licensee shall complete an annual background screening in
- 113 compliance with the requirements of Section 26B-2-120.
- 114 (6) Any licensee that is in operation at the time rules are made in accordance with this part
- 115 shall be given a reasonable time for compliance as determined by the rule.
- 116 (7)(a) A license for a human services program issued under this section shall apply to a
- 117 specific human services program site.
- 118 (b) A human services program shall obtain a separate license for each site where the
- 119 human services program is operated.
- 120 (c) If there is more than one foster parent in a licensed foster home, the foster home
- 121 license shall include the names of all foster parents in the home.
- 122 (8) Beginning on January 1, 2027, the office may not issue or renew a child-placing agency
- 123 license unless the applicant is a nonprofit organization, as that term is defined in Section
- 124 78B-4-101.

126 **26B-2-127 . Child placing licensure requirements -- Prohibited acts --**

127 **Consortium.**

- 128 (1) As used in this section:
- 129 (a)(i) "Advertisement" means any written, oral, or graphic statement or representation
- 130 made in connection with a solicitation of business.
- 131 (ii) "Advertisement" includes a statement or representation described in Subsection
- 132 (1)(a)(i) by a noncable television system, radio, printed brochure, newspaper,

- 133 leaflet, flyer, circular, billboard, banner, Internet website, social media, or sign.
- 134 (b) "Birth parent" means the same as that term is defined in Section 81-13-101.
- 135 (c) "Clearly and conspicuously disclose" means the same as that term is defined in
136 Section 13-11a-2.
- 137 (d) "Coercion" means utilizing threats, force, intimidation, confinement, or deception to
138 induce a birth parent to relinquish the birth parent's child or consent to an adoption.
- 139 (e) "Daily living needs" means food, clothing, hygiene, and local transportation.
- 140 (f) "Directly affected person" means the same as that term is defined in Section 76-7-203.
- 141 (g)(i) "Living expenses" means ordinary and necessary costs to maintain an
142 individual's needs, including housing, utilities, and out-of-state transportation.
- 143 (ii) "Living expenses" does not include lost wages, gifts, educational expenses, or
144 other similar expenses.
- 145 [(~~h~~)] (h)(i) "Matching advertisement" means any written, oral, or graphic statement or
146 representation made in connection with a solicitation of business to provide the
147 assistance described in Subsection (3)(a)(i), regardless of whether there is or will
148 be an exchange described in Subsection (3)(a)(ii).
- 149 (ii) "Matching advertisement" includes a statement or representation described in
150 Subsection [(~~1~~)(~~h~~)(~~i~~)] (1)(h)(i) by a noncable television system, radio, printed
151 brochure, newspaper, leaflet, flyer, circular, billboard, banner, Internet website,
152 social media, or sign.
- 153 (i) "Weekly allowance" means funds that a licensed child-placing agency may provide to
154 a birth parent for daily living needs.
- 155 (2)(a) Subject to Section 81-14-205, a person may not engage in child placing, or solicit
156 money or other assistance for child placing, without a valid license issued by the
157 office in accordance with this part.
- 158 (b) If a child-placing agency's license is suspended or revoked in accordance with this
159 part, the care, control, or custody of any child who is in the care, control, or custody
160 of the child-placing agency shall be transferred to the Division of Child and Family
161 Services.
- 162 (3)(a)(i) An attorney, physician, or other person may assist:
- 163 (A) a birth parent to identify or locate a prospective adoptive parent who is
164 interested in adopting the birth parent's child; or
- 165 (B) a prospective adoptive parent to identify or locate a child to be adopted.
- 166 (ii) A payment, charge, fee, reimbursement of expense, or exchange of value of any

- 167 kind, or promise or agreement to make the same, may not be made for the
168 assistance described in Subsection (3)(a)(i).
- 169 (b) An attorney, physician, or other person may not:
- 170 (i) issue or cause to be issued to any person a card, sign, or device indicating that the
171 attorney, physician, or other person is available to provide the assistance described
172 in Subsection (3)(a)(i);
- 173 (ii) cause, permit, or allow any sign or marking indicating that the attorney,
174 physician, or other person is available to provide the assistance described in
175 Subsection (3)(a)(i), on or in any building or structure;
- 176 (iii) announce, cause, permit, or allow an announcement indicating that the attorney,
177 physician, or other person is available to provide the assistance described in
178 Subsection (3)(a)(i), to appear in any newspaper, magazine, directory, on radio or
179 television, or an Internet website relating to a business;
- 180 (iv) announce, cause, permit, or allow a matching advertisement; or
- 181 (v) announce, cause, permit, or allow an advertisement that indicates or implies the
182 attorney, physician, or other person is available to provide the assistance described
183 in Subsection (3)(a)(i) as part of, or related to, other adoption-related services by
184 using any of the following terms:
- 185 (A) "comprehensive";
- 186 (B) "complete";
- 187 (C) "one-stop";
- 188 (D) "all-inclusive"; or
- 189 (E) any other term similar to the terms described in Subsections (3)(b)(v)(A)
190 through (D).
- 191 (c) An attorney, physician, or other person who is not licensed by the office shall clearly
192 and conspicuously disclose in any print media advertisement or written contract
193 regarding adoption services or adoption-related services that the attorney, physician,
194 or other person is not licensed to provide adoption services by the office.
- 195 (4)(a) An entity that advertises for adoption services shall disclose in the advertisement:
- 196 (i) the name of the states in which the entity is licensed to provide adoption services;
197 or
- 198 (ii) whether the entity is not licensed to provide adoption services in any state.
- 199 (b) An entity that advertises for adoption services may not promise financial incentives
200 in an adoption-related advertisement.

- 201 [(4)] (5) A person who intentionally or knowingly violates Subsection (2) or (3) is guilty of
202 a third degree felony.
- 203 [(5)] (6) This section does not preclude payment of fees for medical, legal, or other lawful
204 services rendered in connection with the care of a mother, delivery and care of a child,
205 or lawful adoption proceedings, except that a child-placing agency may not:
206 (a) charge or accept payment for services that were not actually rendered; or
207 (b) charge or accept payment from a prospective adoptive parent for medical or hospital
208 expenses that were paid for by public funds.
- 209 [(6)] (7) In accordance with federal law, only an agent or employee of the Division of Child
210 and Family Services or of a licensed child-placing agency may certify to United States
211 Citizenship and Immigration Services that a family meets the preadoption requirements
212 of the Division of Child and Family Services.
- 213 [(7)] (8) A licensed child-placing agency or an attorney practicing in this state may not place
214 a child for adoption, either temporarily or permanently, with an individual who would
215 not be qualified for adoptive placement under Sections 81-13-202, 81-13-203, and
216 81-13-402.
- 217 [(8)] (9)[(a) ~~A child-placing agency, as that term is defined in Section 63G-20-102, that~~
218 ~~serves a resident of the state who is a birth mother or a prospective adoptive parent~~
219 ~~must be a member of a statewide consortium of licensed child-placing agencies that,~~
220 ~~together, serve all birth mothers lawfully seeking to place a child for adoption and all~~
221 ~~qualified prospective adoptive parents.]~~
- 222 [(b) ~~The department shall receive and investigate any complaint against a consortium of~~
223 ~~licensed child-placing agencies.]~~
- 224 (a) There is created the Utah Child-Placing Agency Consortium to advise the Legislature
225 regarding child-placing agency adoptions and policy in the state.
- 226 (b) The consortium consists of one member of each licensed child-placing agency, as
227 that term is defined in Section 63G-20-102.
- 228 (c) The consortium shall meet at least quarterly.
- 229 (d) The majority of consortium members constitutes a quorum for conducting
230 consortium business.
- 231 (e) The consortium shall establish bylaws and procedures for consortium action and
232 recommendations.
- 233 (f)(i) A representative from the office shall chair the consortium.
- 234 (ii) The office shall oversee the consortium and provide staff support as needed.

- 235 (g)(i) The consortium shall report to the Health and Human Services Interim
236 Committee on or before October 1, 2026.
- 237 (ii) The report described in Subsection (9)(g)(i) shall include:
238 (A) the number of adoptions completed by each agency in 2025;
239 (B) the number of out-of-state transports arranged by each agency in 2025; and
240 (C) a description of each agency's fees in 2025.
- 241 (10)(a) A birth parent has the right to independent legal counsel in the adoption process,
242 selected by the birth parent, at a reasonable cost to be paid by the child-placing
243 agency or prospective adoptive parents.
- 244 (b) A birth parent may waive the right described in Subsection (10)(a).
- 245 (11) Before a parent relinquishes a child adoptee to a child-placing agency, or consents to
246 the adoption of a child adoptee, the parent shall be informed of the right described in
247 Subsection (10), with sufficient time to exercise the right prior to relinquishment or
248 consent, by the:
- 249 (a) child-placing agency;
250 (b) prospective adoptive parents; or
251 (c) representative of a person described in Subsection (11)(a) or (b).
- 252 (12) Before the day on which a final decree of adoption is entered, a statement shall be filed
253 with the court that:
- 254 (a) is signed by each parent who:
255 (i) relinquishes the parent's parental rights; or
256 (ii) consents to the adoption; and
257 (b) states that, before the parent took the action described in Subsection (12)(a)(i)(A) or
258 (B), the parent was advised of the parent's right to independent legal counsel
259 described in this section at the expense of the:
- 260 (i) child-placing agency; or
261 (ii) prospective adoptive parents.
- 262 (13) A licensed child-placing agency shall include on the child-placing agency's website, in
263 a prominent and conspicuous place:
- 264 (a) information regarding how a birth parent or adoptive parent can file a complaint with
265 the office; and
266 (b) notice of any current or former warnings or violations that the office has issued to the
267 child-placing agency within the past three years.
- 268 (14)(a) A licensed child-placing agency may only pay the following fees or expenses on

- 269 behalf of a birth parent:
- 270 (i) up to \$8,000 in living expenses;
- 271 (ii) weekly allowance;
- 272 (iii) medical expenses; and
- 273 (iv) legal expenses related to the adoption.
- 274 (b) Except as provided in Subsection (14)(c)(i), a licensed child-placing agency that
- 275 pays fees or expenses described in Subsection (14)(a) on behalf of a birth parent shall
- 276 make the payment directly to the applicable service provider when possible.
- 277 (c)(i) A licensed child-placing agency may provide a weekly allowance directly to a
- 278 birth parent.
- 279 (ii) A weekly allowance may not be provided as a lump sum, but shall be distributed
- 280 on a weekly basis for up to 12 weeks during pregnancy and four weeks
- 281 postpartum.
- 282 (iii) A weekly allowance may not exceed \$200 per week for a birth parent and \$75
- 283 per week for a directly affected person that is dependent on the birth parent.
- 284 (d) A licensed child-placing agency may exceed the limits described in this Subsection
- 285 (14) with court approval.
- 286 (15) Prior to an adoption being finalized, an adoptive parent or licensed child-placing
- 287 agency may not discuss or promise a potential post-adoption gift to a birth parent.
- 288 (16)(a) A licensed child-placing agency, an employee or contractor of a licensed
- 289 child-placing agency, or a prospective adoption parent may not utilize coercion in
- 290 any interaction with a birth parent.
- 291 (b) Coercive behavior includes:
- 292 (i) threatening financial or legal retaliation if a birth parent chooses to parent;
- 293 (ii) telling a birth parent that the birth parent will not receive assistance to return to
- 294 the birth parent's state of residence;
- 295 (iii) preventing a birth parent from physically leaving the birth parent's location;
- 296 (iv) preventing a birth parent from contacting the birth parent's supports, such as
- 297 family, friends, mental health professional, or legal counsel; and
- 298 (v) promising a financial benefit in exchange for the birth parent's relinquishment or
- 299 consent.
- 300 (17) If any member of a licensed child-placing agency has a financial interest in a service
- 301 provider that receives a payment as described in Subsection (14)(b), the licensed
- 302 child-placing agency shall disclose the financial interest to a birth parent, prospective

- 303 adoptive parent, the office, and a court that finalizes the adoption.
- 304 (18)(a) A licensed child-placing agency may not transport or arrange the transport of:
- 305 (i) a birth mother to the state if the agency knows or should know that the mother is
- 306 at 36 or more weeks of gestation; or
- 307 (ii) a birth mother who is less than 18 years old to the state.
- 308 (b) A parent or guardian of a birth mother who is less than 18 years old may make
- 309 independent arrangements to transport or travel with the minor birth mother.
- 310 (c) A licensed child-placing agency shall verify whether an out-of-state birth mother is
- 311 receiving Medicaid benefits prior to transporting or arranging the transport of the
- 312 birth mother to Utah.
- 313 (d) An individual who travels to Utah for the sole purpose of giving birth without intent
- 314 to remain in Utah following the birth does not qualify for Utah Medicaid benefits.
- 315 (19) A licensed child-placing agency that transports or arranges the transport of a birth
- 316 mother to the state for purposes related to an adoption shall ensure that the birth mother
- 317 is returned to the state from which the birth mother was transported using the same
- 318 mode and quality of transportation that was used to bring the birth mother to the state if
- 319 the birth mother does not elect to remain in Utah, regardless of the birth mother's
- 320 decision regarding relinquishment.
- 321 (20)(a) A licensed child-placing agency shall submit a form, created by the office, to the
- 322 office for each birth parent to whom the agency provides service.
- 323 (b) The form described in Subsection (20)(a) shall include:
- 324 (i) the name of the licensed child-placing agency;
- 325 (ii) whether the birth parent chose:
- 326 (A) to parent the child;
- 327 (B) adoption; or
- 328 (C) something else;
- 329 (iii) the date of:
- 330 (A) the birth parent's first contact with the agency;
- 331 (B) birth of the child adoptee;
- 332 (C) relinquishment; and
- 333 (D) the finalized adoption;
- 334 (iv) the location of the birth parent on each date described in Subsection (20)(b)(iii);
- 335 (v) whether a third-party facilitator was used to connect the birth parent and the
- 336 agency;

- 337 (vi) the total amount of funds that a birth parent received directly through a weekly
 338 allowance;
 339 (vii) the total amount that was paid on behalf of the birth parent for housing,
 340 out-of-state transportation, or utilities;
 341 (viii) the total amount that was paid for the birth parent's medical expenses, including
 342 mental health therapy;
 343 (ix) the total amount that was paid for the birth parent's legal expenses;
 344 (x) the value of any gifts provided to the birth parent;
 345 (xi) a description and value of any other benefit that was paid to or on behalf of the
 346 birth parent;
 347 (xii) whether the birth parent received Utah Medicaid benefits;
 348 (xiii) whether the birth parent received Medicaid benefits in another state; and
 349 (xiv) whether the birth parent received any other public assistance in Utah.

350 (21) The office shall investigate and may revoke or suspend a license of a child-placing
 351 agency that violates this section.

352 Section 3. Section **26B-2-244** is enacted to read:

353 **26B-2-244 . Birthing services at health care facilities.**

- 354 (1) As used in this section, "adoption services" means action related to an adoption,
 355 including counseling between a child-placing agency and a birth parent, signing
 356 paperwork related to an adoption, or the transfer of physical custody of a child adoptee
 357 from a birth parent to a child-placing agency or prospective adoptive parent.
 358 (2) A health care facility that provides birthing services shall develop policies regarding
 359 adoption services that occur at a health care facility.
 360 (3) A health care facility that provides birthing services shall notify the Office of Licensing
 361 if the health care facility takes action against a child-placing agency or a child-placing
 362 agency's representatives.
 363 (4) A health care facility or a health care facility's staff may notify the Office of Licensing
 364 if the facility or staff has concerns regarding unethical practices related to adoption
 365 services that occur at the health care facility.

366 Section 4. Section **63G-20-203.5** is amended to read:

367 **63G-20-203.5 . Child-placing agencies.**

- 368 (1) As used in this section, "consortium" means [~~a statewide consortium of child-placing~~
 369 ~~agencies]~~ the Utah Child-Placing Agency Consortium described in Subsection [
 370 26B-2-127(8)] 26B-2-127(9).

- 371 (2) Notwithstanding any other provision of law, a state or local government, a state or local
372 government official, or another accrediting, certifying, or licensing body, including the
373 Office of Licensing within the Department of Health and Human Services, may not:
- 374 (a) require a consortium-member child-placing agency to perform, assist, counsel,
375 recommend, consent to, facilitate, or participate in child placing, with a qualified
376 prospective adoptive parent, that is contrary to the child-placing agency's religious
377 teaching, practices, or sincerely held beliefs, or the good faith wishes of the birth
378 mother as to the optimal placement of the child;
- 379 (b) deny a consortium-member child-placing agency any grant, contract, or participation
380 in a government program because the child-placing agency cannot, consistent with
381 the child-placing agency's religious teaching, practices, or sincerely held beliefs, or
382 consistent with the good faith wishes of the birth mother as to the optimal placement
383 of the child, perform, assist, counsel, recommend, consent to, facilitate, or participate
384 in a child placement with a qualified prospective adoptive parent; or
- 385 (c) deny an application for an initial license or accreditation, deny the renewal of a
386 license or accreditation, or revoke the license or accreditation of a
387 consortium-member child-placing agency that cannot, consistent with the
388 child-placing agency's religious teaching, practices, or sincerely held beliefs, or
389 consistent with the good faith wishes of the birth mother as to the optimal placement
390 of the child, perform, assist, counsel, recommend, consent to, facilitate, or participate
391 in a child placement with a qualified prospective adoptive parent.
- 392 (3)(a) A consortium-member child-placing agency that cannot, consistent with the
393 child-placing agency's religious teaching, practices, or sincerely held beliefs, or
394 consistent with the good faith wishes of the birth mother as to the optimal placement
395 of the child, perform, assist, counsel, recommend, consent to, facilitate, or participate
396 in a child placement with a qualified prospective adoptive parent, shall refer the
397 individual who is seeking child-placement services to another child-placing agency in
398 the consortium.
- 399 (b) A referral by a child-placing agency under Subsection (3)(a) does not constitute a
400 determination that a proposed placement is not in the best interest of the child.
- 401 (4) The fact that a consortium-member child-placing agency cannot, consistent with the
402 child-placing agency's religious teaching, practices, or sincerely held beliefs, or
403 consistent with the good faith wishes of the birth mother as to the optimal placement of
404 the child, perform, assist, counsel, recommend, consent to, facilitate, or participate in a

405 child placement with a qualified prospective adoptive parent, may not form the basis for:
406 (a) the imposition of a civil fine or other adverse administrative action; or
407 (b) any claim or cause of action under any state or local law.

408 Section 5. Section **80-2-802** is amended to read:

409 **80-2-802 . Division child placing and adoption services -- Restrictions on**
410 **placement of a child.**

- 411 (1) Except as provided in Subsection (3), the division may provide adoption services and,
