#### Description:

State Expenditure Impact: Enactment of this legislation could cost the Supreme Court division \$1,770,200 one-time from the General Fund for construction of new chambers and modifications to the bench (\$1,680,000), courtroom technology (\$69,900), and IT equipment (\$20,300). It could also cost \$1,472,400 ongoing from the General Fund for the salary and benefits of two new justices (\$793,800), four law clerks (\$557,400), a judicial assistant (\$86,200), and operational expenses for these positions (\$35,000). It could also cost the Court of Appeals \$17,400 one-time from the General Fund to IT equipment and \$1,318,400 ongoing from the General Fund for the salary and benefits of two new justices (\$761,000), and four law clerks (\$557,400).
