Odyssey is proud to administer the Utah Fits All Scholarship Program. Since the transition, our focus has been on implementing a compliant, and parent centered system that supports educational choice while safeguarding public funds.

The progress made over the past eight months ensures that the UFA program is functioning as the law intended and positioned well for the years ahead.



## STUDENT PARTICIPATION

- **17,677** applications processed in 6 weeks
- **15,608** students funded
- **7,606** returning students
- **52.5%** private school students
- **47.5%** homeschooled students



## SPEND ALLOCATION



## **H.B. 467, 2<sup>nd</sup> Substitute: Utah Fits All Scholarship Program Amendments**

This bill establishes new provisions for the Utah Fits All Scholarship (UFA) program. UFA provides enrolled K-12 students with money for educational expenses, like private school tuition, tutoring services, and curricular materials. Students attending private school receive \$8,000 per year; home-based students receive between \$4,000 and \$6,000 yearly, based on age.

### **Summary of Changes**

#### **Private Schools**

**Definition:** Creates a **definition of a private school**, effective starting in the 2026-2027 school year (see text box and Private School Accreditation Working Group information below). (*Lines 168-191*)

**Requirements for private schools as qualifying providers:** Private schools may become a qualifying UFA provider, meaning they meet certain criteria and accept scholarship money directly. This bill **updates these requirements** to include the following, among others: (*Lines 825-1031*)

- Provide an audit from an independent accountant.
- Provide a statement clarifying that the school's published tuition costs, fees, and refund policies are the same for scholarship students as other students.
- If a scholarship student withdraws, report to the program manager within five business days.
- Provide a statement clarifying that if the school has a refund policy, the school will refund the program manager so funds can be placed in the student's scholarship account, not the family.
- Provide other information required by the program manager or financial administrator.

#### **Private School Definition**

- Non-public educational institution.
- **Accredited** – or working towards accreditation – by a recognized accrediting organization.
- Primary, not supplementary, source of education for enrolled students.
- Provides most of a student's academic instruction as the student's primary educational setting.
- Maintains records.
- Doesn't operate primarily to direct education funds to parents or third-party education providers.

**Parent reimbursement:** Parents may send students to private schools that are not qualifying providers and seek reimbursement, but **any private school an eligible student attends must meet the statutory definition.**

Parents may pay students' tuition directly at private schools that are not qualifying providers and seek monthly tuition reimbursement. The program manager should reimburse parents within 10 business days. Parents must provide invoices, proof of enrollment, and proof the school meets the statutory definition. (*Lines 472-475; 524-552*)

### *Private School Accreditation Working Group*

Creates a working group to review and evaluate accreditation organizations. Membership includes the program manager, the state superintendent, private school representatives, and parents, among others; the state superintendent will provide staffing. (*Lines 1032-1084*)

Duties include:

- Create a list of approved accreditation organizations by January 1, 2027, for the 2027-2028 school year, which the program manager must adopt.
- After providing the list, meet as needed to monitor accrediting organizations and recommend updates.

**Before** the program manager adopts the list, private schools must be accredited or actively working towards accreditation with any regional or national accreditor.

**After** the program manager adopts the list:

- Private schools accredited by non-approved accrediting organization have two years from the date of adoption to become accredited by an approved organization.
- Unaccredited private schools working towards accreditation must receive accreditation from an approved organization within two years.

### **Student Eligibility and Scholarship Awards**

Enrollment preference: Reorders and expands **enrollment preference:** (*Lines 387-410*)

Household applications: Creates new requirements for **processing applications from a household.** (*Lines 505-523*)

- Applications from the same household are (1) processed together, and (2) approved or denied as a unit.
- If there aren't enough scholarship funds, the family may (1) accept awards for some children, or (2) stay on the wait list until all children get a scholarship.

Age of eligible students: Under 19 years old before September 1 of the school year. (*Line 111*)

Participation in activities: Local education agencies must allow UFA scholarship students to participate in extracurricular and athletic activities. (*Lines 815-823*)

### **Program Manager Requirements**

Customer service: The program manager must maintain **adequate call center capacity.** This includes adequate staffing for peak enrollment periods, scalability plans, and continuous improvement based on parent feedback. (*Lines 745-753*)

Processing expenses:

- Process expense reimbursements within 10 days. (*Lines 634-636*)
- Create a pre-approval process for expenses before they're incurred, responding within 7 business days. Available to parents through an online portal and other methods. (*Lines 756-765*)

Educational marketplace: If the program manager runs an educational marketplace: (*Lines 766-775*)

- Prices must reflect **fair market value.**
- The program may not require exclusive marketplace use.
- The marketplace may not sell used or returned goods.

Compliance: Coordinate with the Utah State Board of Education's Department of Operations on policy interpretations, compliance issues, and customer service standards. (*Lines 576-577*)
