General Fund

Policy Impacts:

- The state sales tax earmark for the Transportation Investment Fund of 2005 was increased in the 2025 General Session (S.B. 195 “Transportation Amendments”)
 - Estimated to shift \$328 million in FY 2026 and \$343 million in FY 2027
 - The budget is partially offset by an ongoing reduction of \$330 million to the TIF appropriation from the General Fund
 - Unrestricted state sales tax revenue will reflect the increase in the earmark

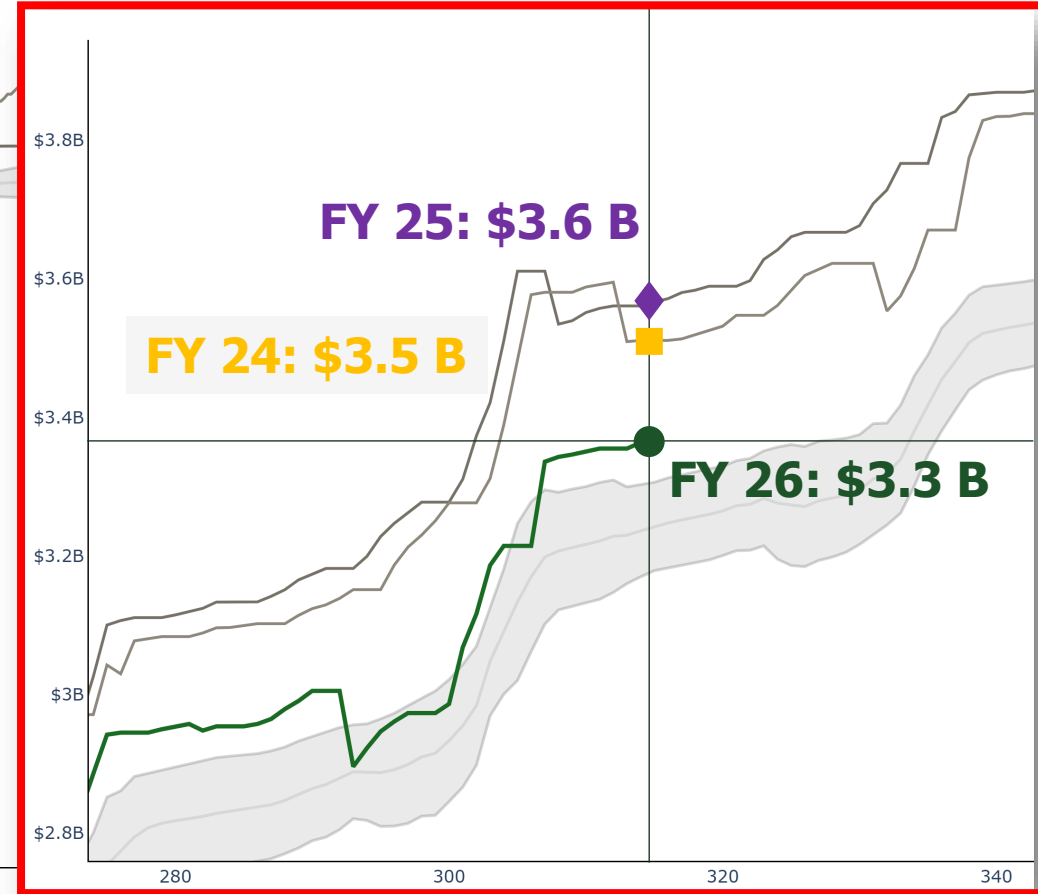
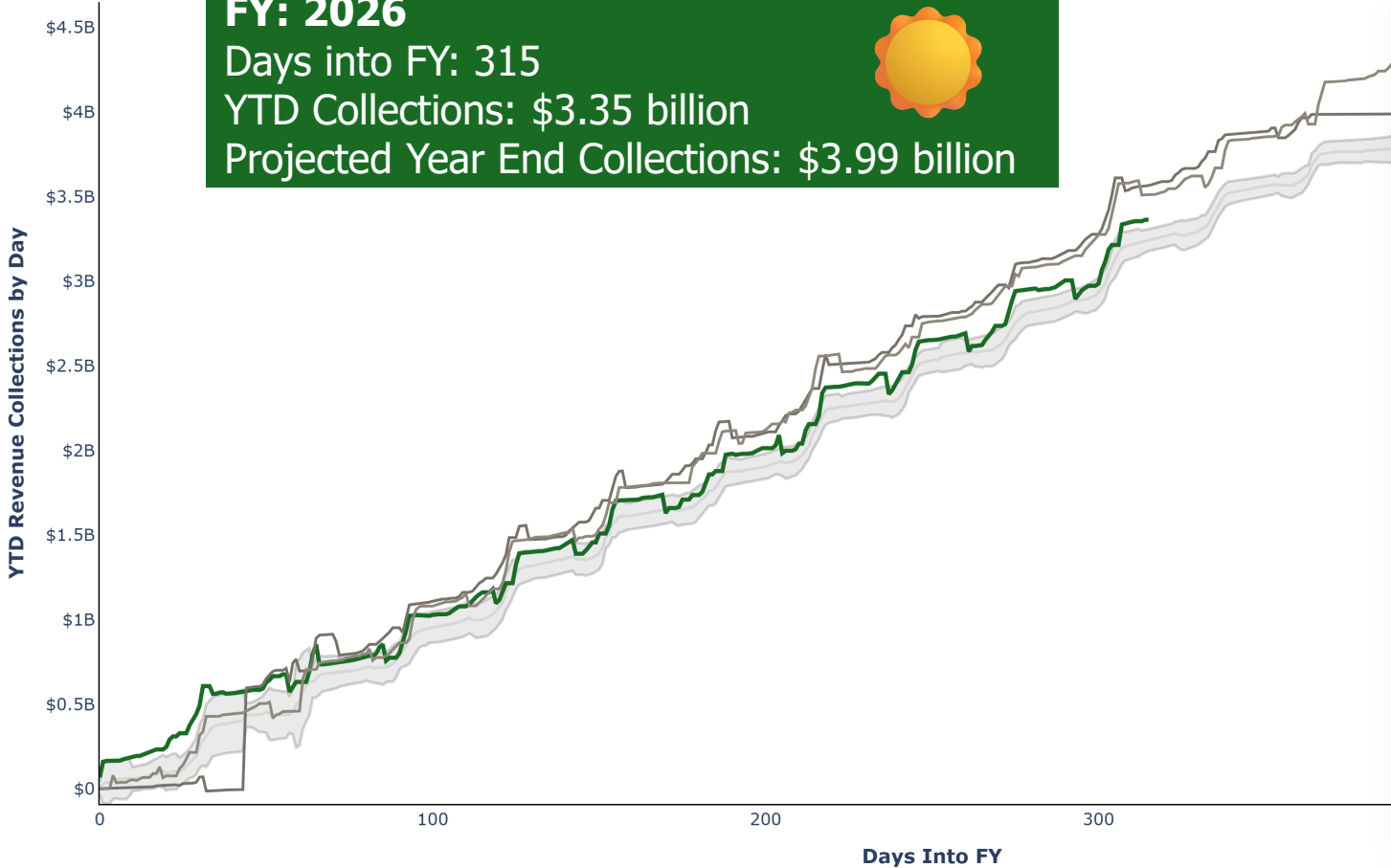

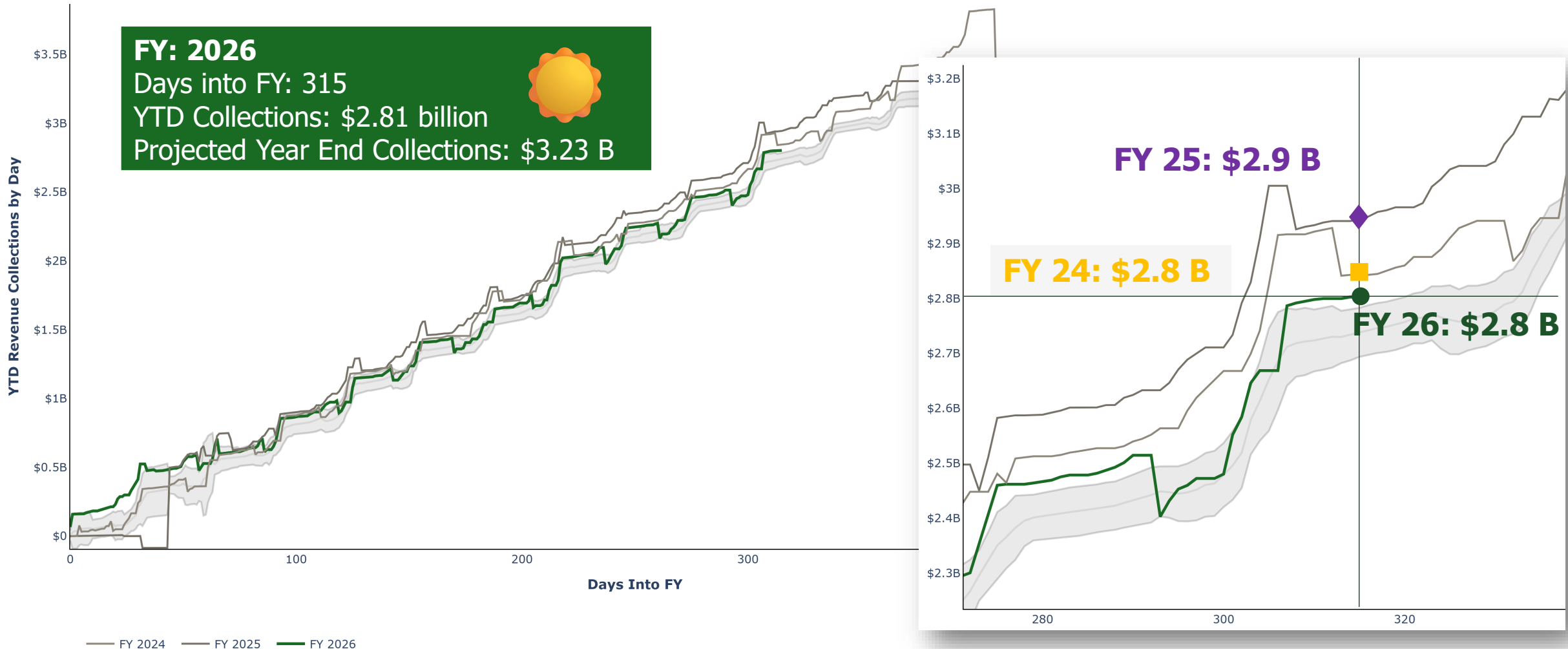

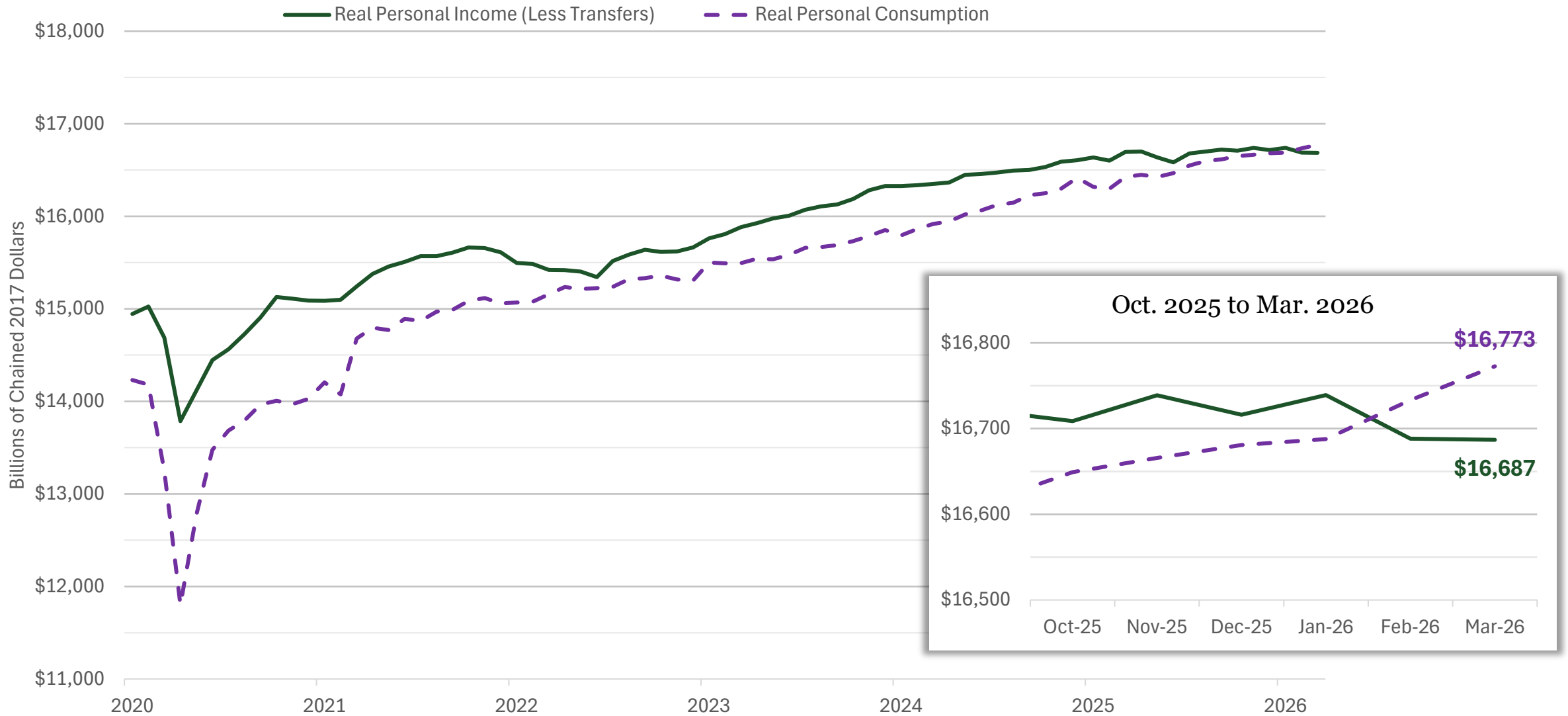


Unrestricted Sales Tax

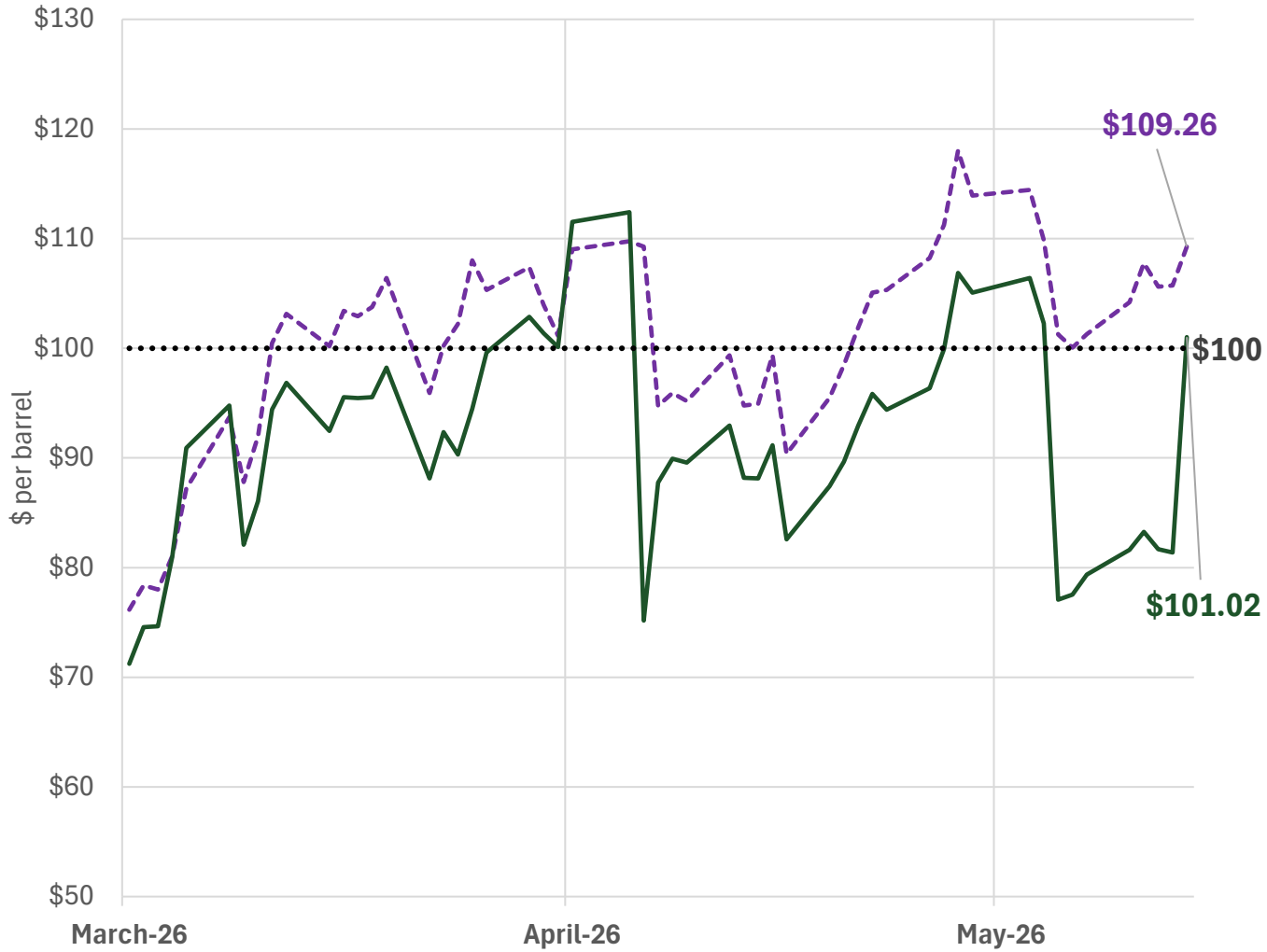
YTD Collections For: Sales Tax Total

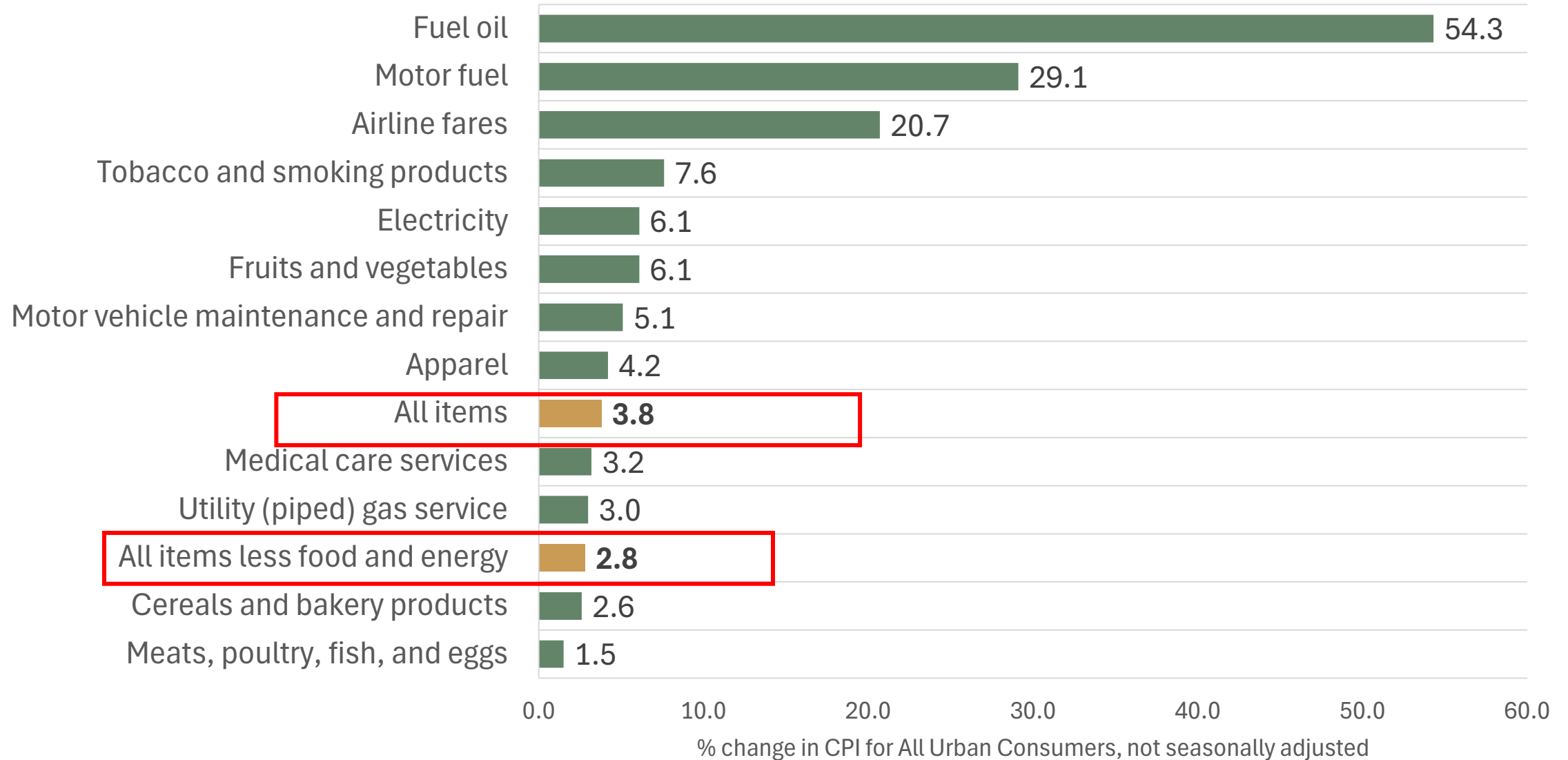

12-month percent change, Apr. 2025 to Apr. 2026





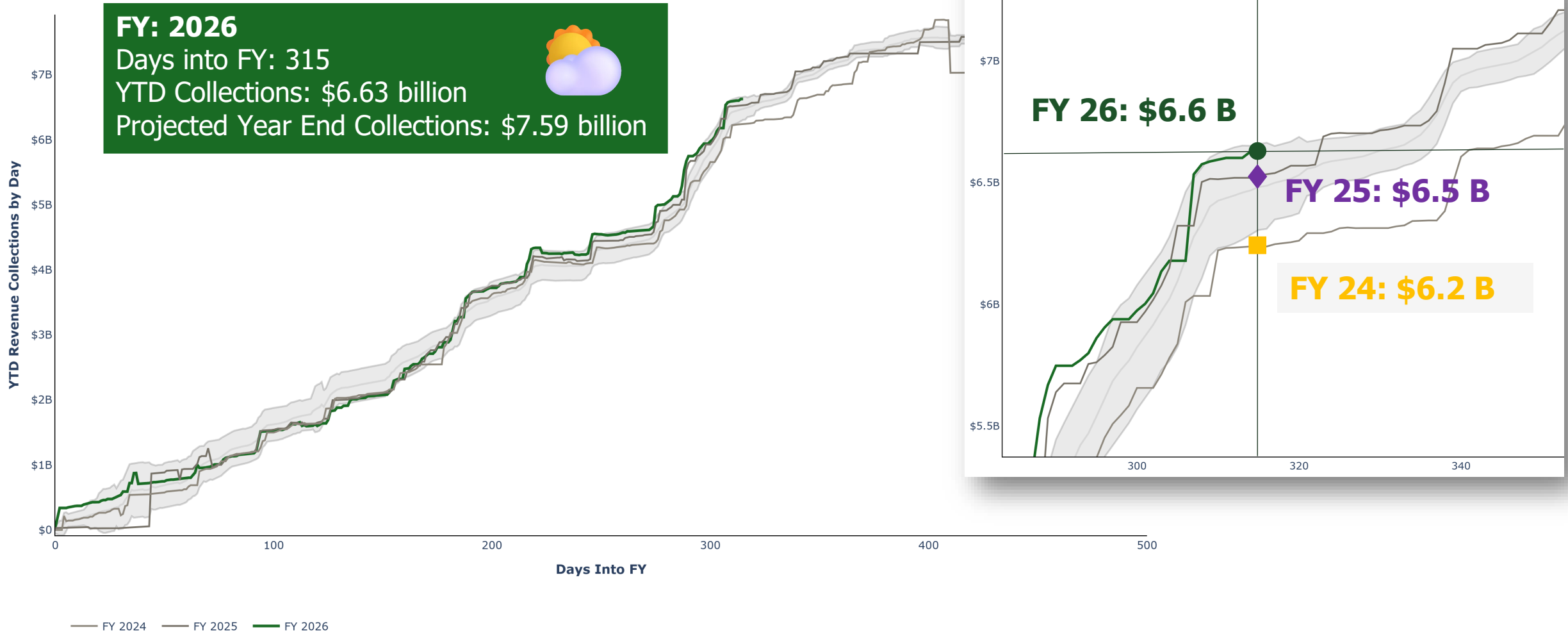
Income Tax Fund

Policy Impacts:

- Federal Level
 - H.R. 1 “The One Big Beautiful Bill Act”
- State Level
 - 2025: Income tax rate reduced to 4.5% (H.B. 106 “Income Tax Revisions”)
 - Estimated to decrease Income Tax Fund Revenue by \$124 million in FY 2026
 - 2026: Income tax rate reduced to 4.45% (S.B. 60 “Income Tax Rate Amendments”)
 - Estimated to decrease Income Tax Fund revenue by \$1.3 million in FY 2026 and \$123 million in FY 2027

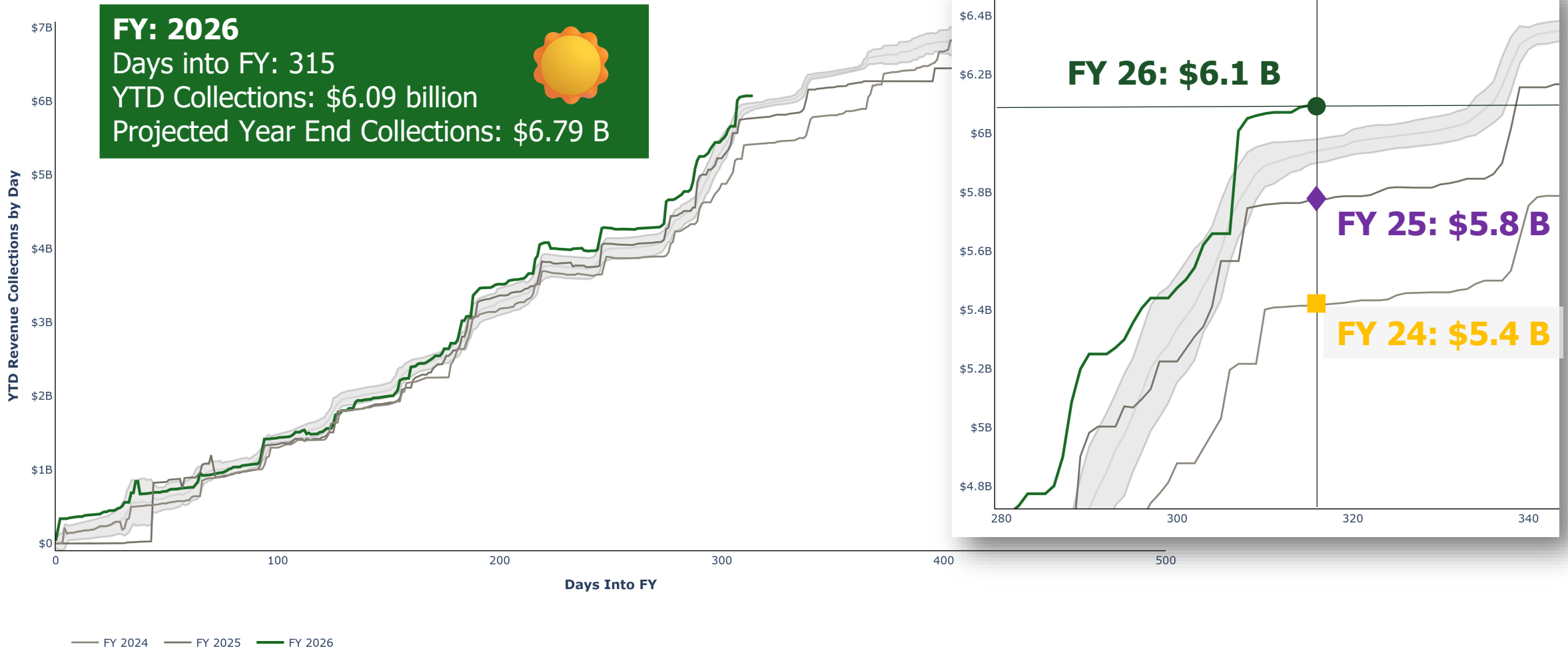
Income Tax Total Collections

YTD Collections For: *Income Tax Fund Total*



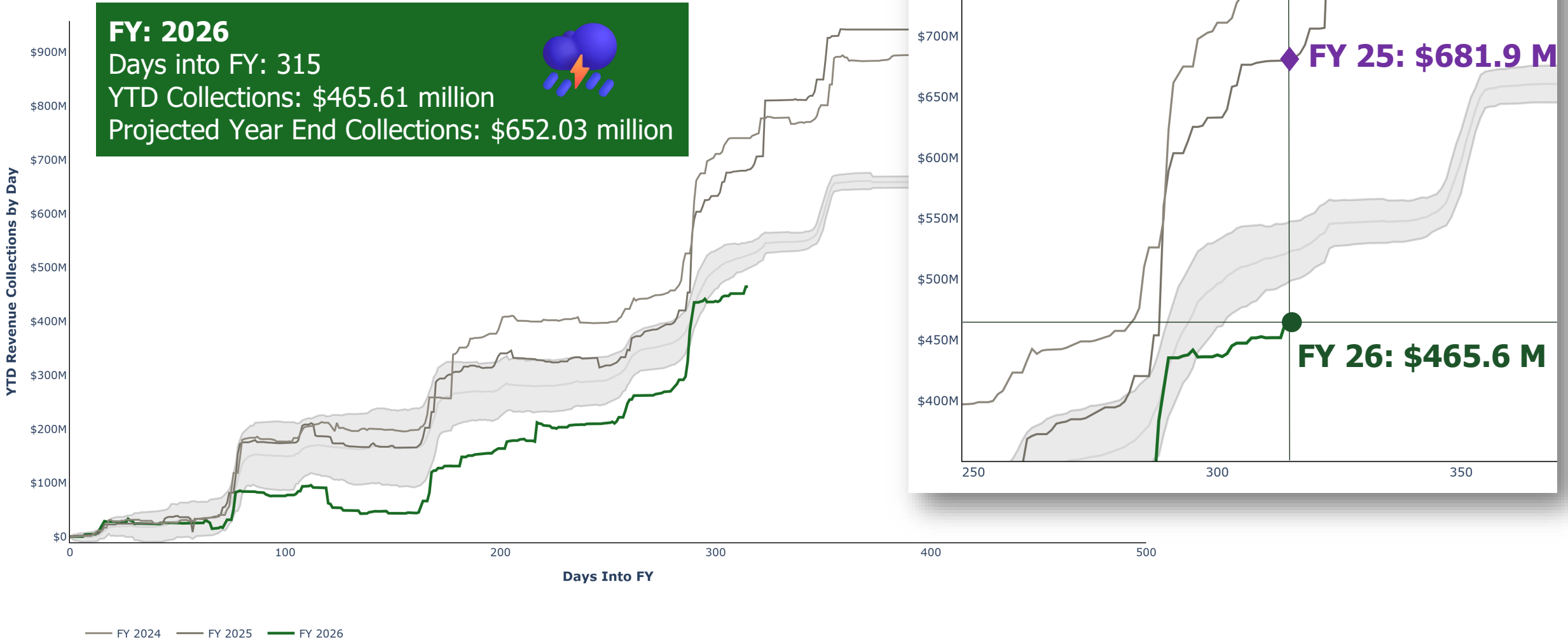
Individual Income Tax Total Collections

YTD Collections For: Individual Income Tax Total



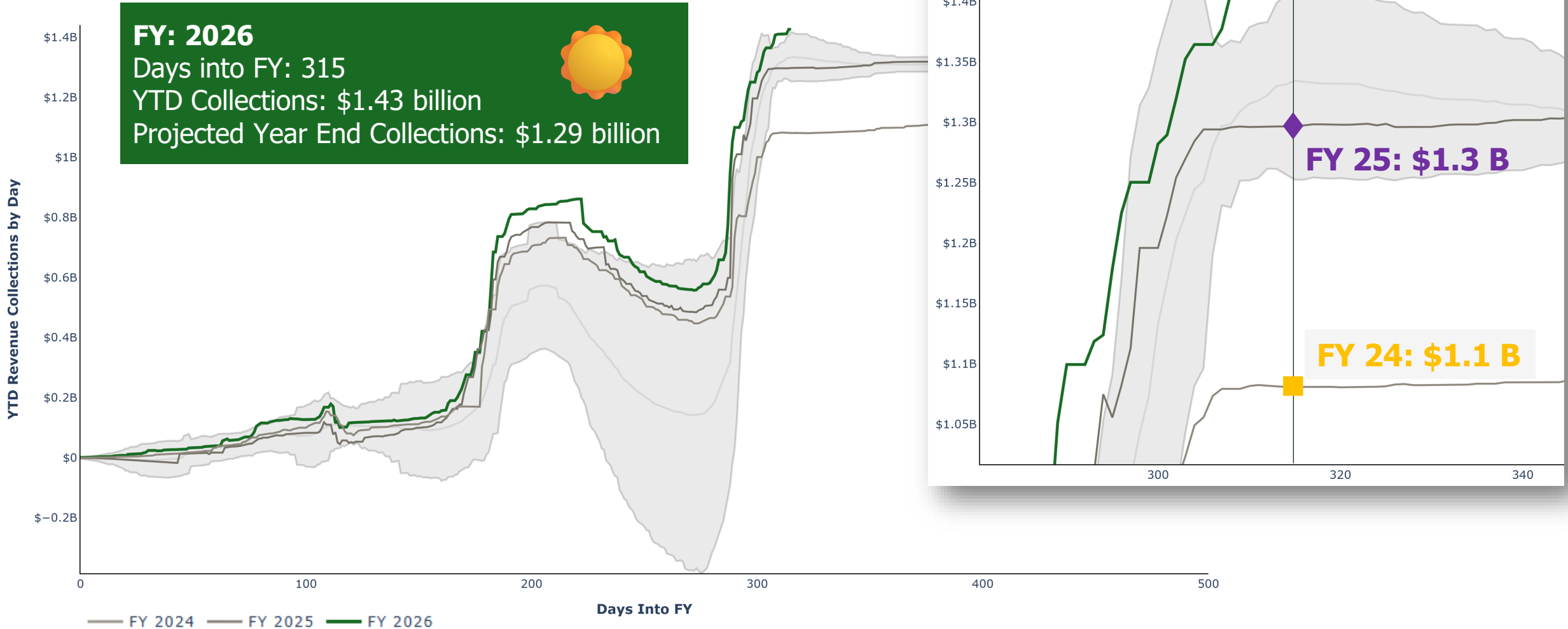
Corporate Tax

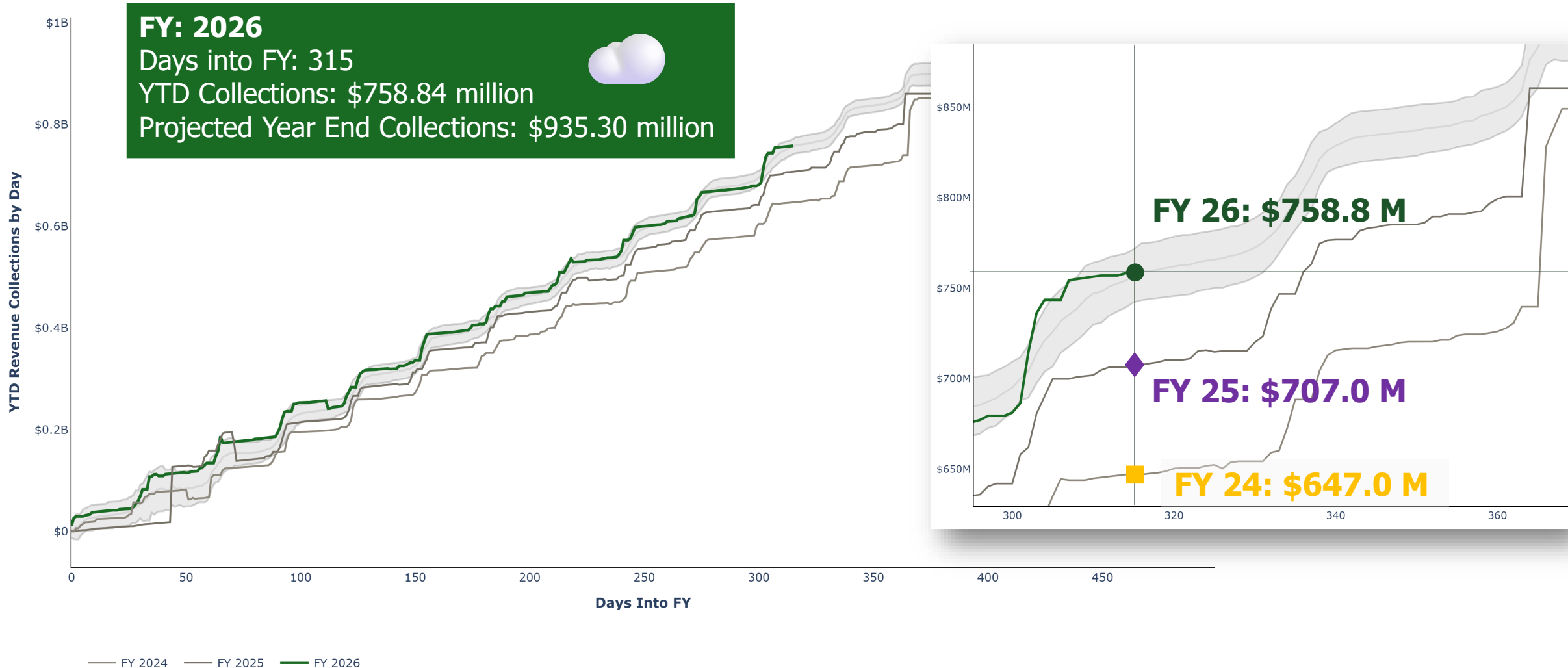
Transportation Fund

Policy Impacts:

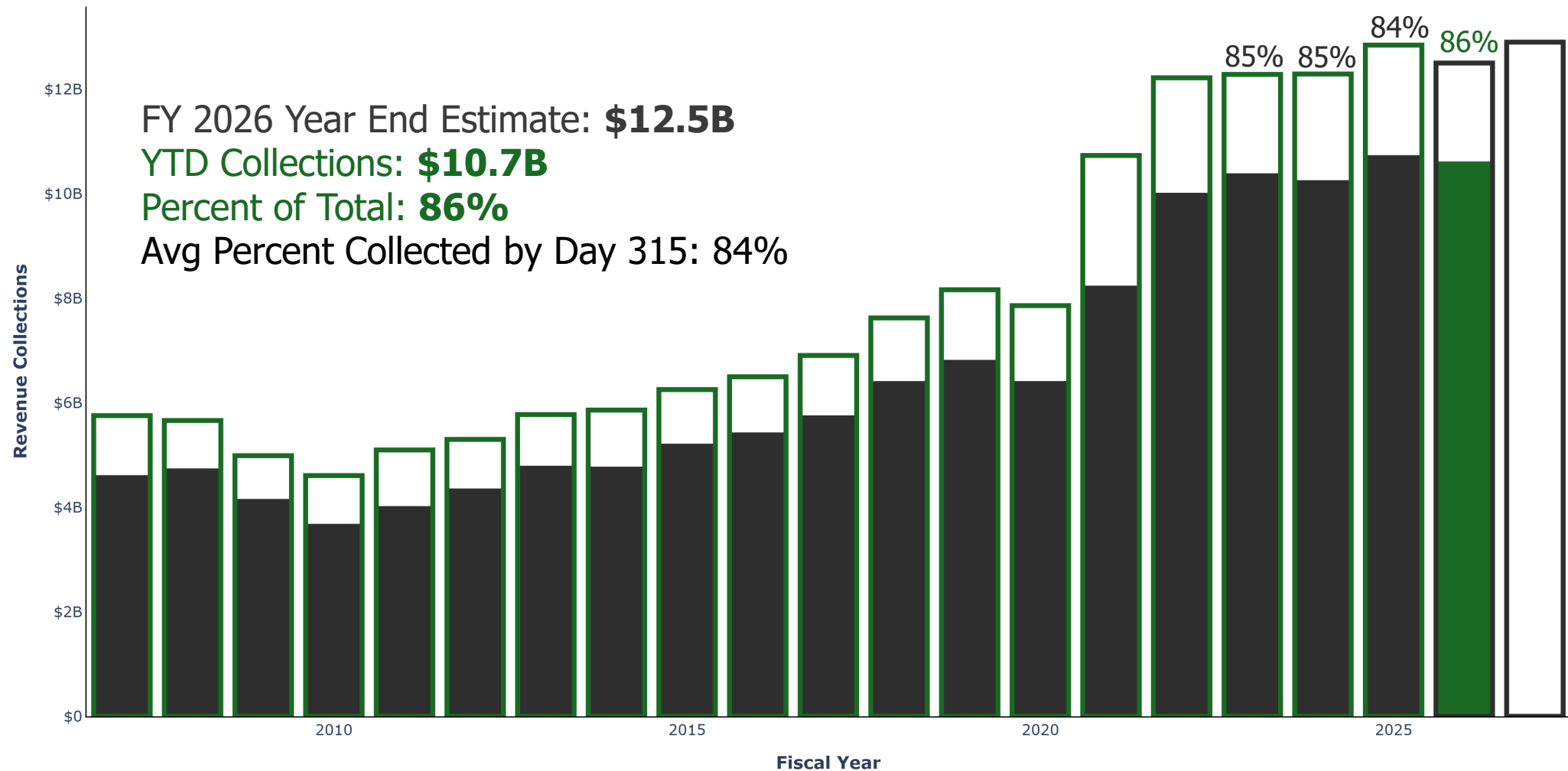
- Annual fuel rate adjustment decreased the rate by 0.6 cents beginning Jan. 1, 2026
- Temporary decrease of motor fuel tax rate (H.B. 575 "Fuel Tax and Supply Amendments")
 - Estimated to decrease Transportation Fund revenue by \$39.7 million in FY 2027

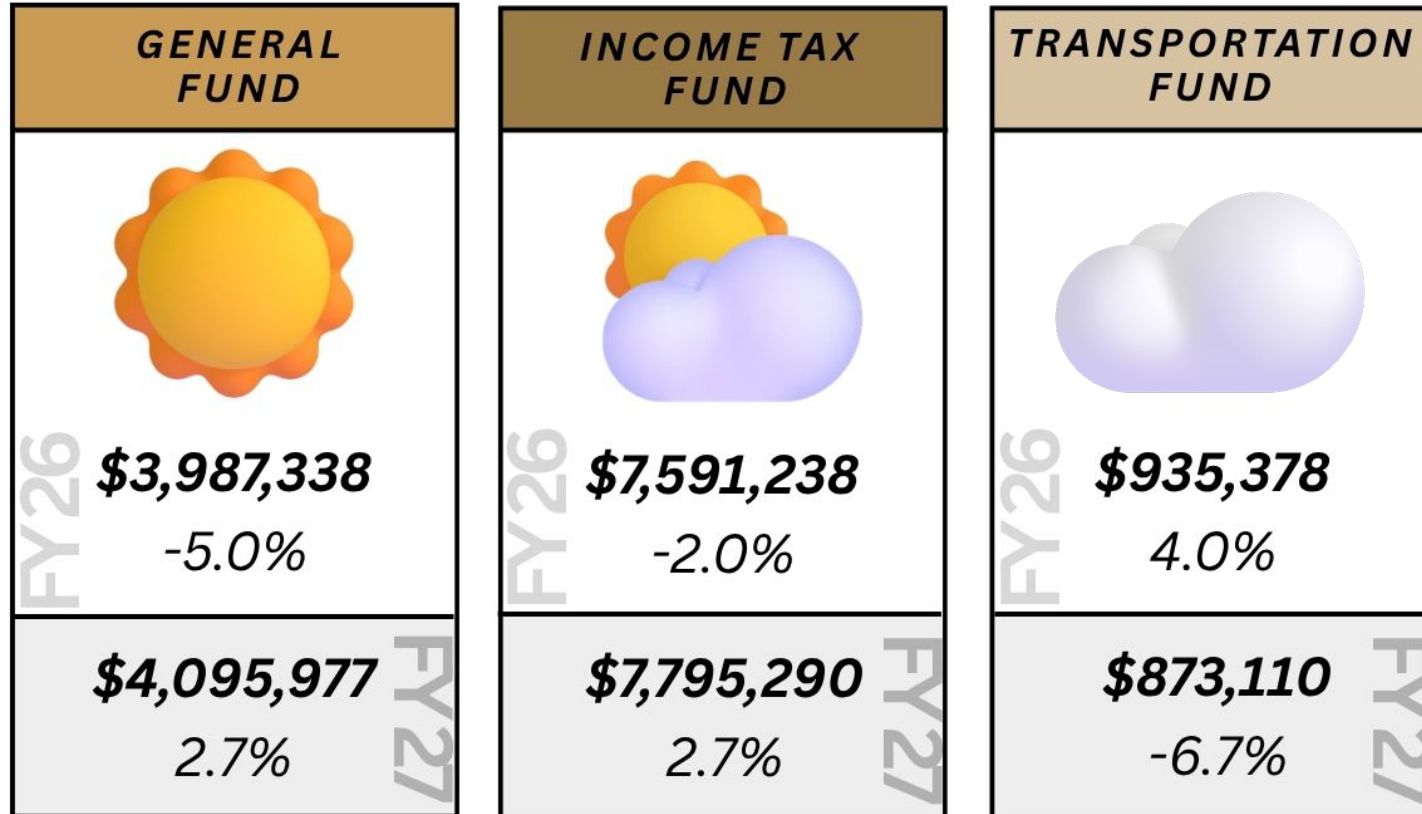


■ All Revenue Sources Total - YTD
