JOB DESCRIPTION:

The Office of Legislative Research & General Counsel is a nonpartisan office serving the Utah Legislature. The Legislature's general counsel, deputy general counsel, and a team of 24 other lawyers currently employed as associate general counsels, provide nonpartisan legal services to all 104 members of the Legislature.

The Office's Legislative Counsel Fellowship is a one-year position for emerging attorneys (0-2 years out of law school) who are interested in gaining practical experience in areas of constitutional law and legislative drafting.

A legislative counsel fellow must function effectively in a political environment and work on legislation that promotes various public policy positions while maintaining objectivity and neutrality.

The legislative counsel fellowship will be full-time. It will begin August 2024 and end August 2025.

GENERAL DUTIES AND RESPONSIBILITIES:

- Conducting legal and policy research for the general counsel, deputy general counsel, managing staff attorney, associate general counsels, legislative committees, and individual legislators;
- Attending meetings, hearings, and other activities relevant to the legislative process;
- Drafting legislation; and
- Assisting with other matters related to in-house counsel functions and litigation for the legislative branch.

POSITION QUALIFICATIONS:

- Current 3Ls or applicants intending to take the July 2024 Utah State Bar examination.
- Successful completion of the Utah State Bar examination and membership in good standing in the Bar by November 2024.
- Proficiency in legal research, analysis, and writing.
