Seeking a motivated QA Functional Tester to join the Utah Legislative Technology Team. You will be collaborating with development teams and helping with quality releases that define and implement solutions for Applications that help the State of Utah do its business. You will work closely with project management and other multi-functional teams.

- Identify issues with new features and existing features before they impact the users in production
