HOW WILL THE PUBLIC BENEFIT?

1 What is the purpose and the duties of the new program, agency, services, or population served?

JR4-2-404(4)(c)(i)

This bill will allow approximately 144 additional children to be served in the Medicaid Autism Waiver. The estimated annual cost of providing services to one child in the Medicaid Autism Waiver is \$10,417 (State Funds).

144 children x \$10,417 = \$1,500,048

2 What services are provided by the funding increase?

JR4-2-404(4)(c)(ii)

Approximately 144 additional children will receive Medicaid Autism Waiver services which include: Applied Behavioral Analysis and other similar services, respite care, and financial management services (FMS). FMS will allow services to be provided under a self-directed services method. Baseline and annual outcome assessment of each child will also be provided through this funding.

3 What are the expected outcomes of the new or expanded program and how will the public benefit?

JR4-2-404(4)(c)(iii)

Improved functional and behavioral outcomes for the children who receive the waiver services are expected. Due to the increasing number of children diagnosed with autism spectrum disorders, waiver services will provide needed treatment.

4 How will the bill be implemented and what resources are available to achieve the expected outcomes?

JR4-2-404(4)(c)(iv)

The bill will require an amendment to the current Medicaid Autism Waiver to increase the number of unduplicated recipients served and to modify the age eligibility to allow the State to provide services to children who are at least 2 years old and up to the child's 7th birthday, rather than up to the child's 6th birthday, as the current waiver allows.

5 How will the proposed agency activities cause the expected outcomes and public benefit in 3?

Amending the Medicaid Autism Waiver will result in additional children receiving services that will result in improved functional and behavioral outcomes.
