1 What is the purpose and the duties of the new program, agency, services, or population served?

2 What services are provided by the funding increase?

- Coordinate Utah's outdoor recreation policy and promotion among state and federal agencies and Utah local governmental entities as well as outdoor industry companies.
- Ensure balanced and responsible use and development of our public lands.
- Promote Utah's Outdoor Recreation & Products Cluster.
- Promote outdoor recreation as a key tourism asset.

3 What are the expected outcomes of the new or expanded program and how will the public benefit?

JR4-2-404(4)(c)(iii)

- Build statewide recognition of and support for Utah's recreation vision.
- Hold an annual Utah Outdoor Recreation Summit convening anyone with ties to outdoor recreation activities to coordinate shared interests.
- Creation of a comprehensive Outdoor Recreation Plan for Utah.
- Increase tourism revenues to the State.
- Further strengthen the outdoor industry cluster through business creation, expansion and recruitment efforts.
- Support healthy Utah initiatives.

4 How will the bill be implemented and what resources are available to achieve the expected outcomes?

JR4-2-404(4)(c)(iv)

The Outdoor Recreation program manager position will come from resources associated with an existing FTE in the Governor's Office of Economic Development (GOED). The Outdoor Recreation office would require additional funding of \$100,000 to supplement expenses related to the program manager, administrative assistant, recreation related studies, and some statewide travel and office expenses. The Outdoor Recreation office will coordinate with other State agencies administering outdoor recreation programs and responsibilities in order to leverage the agencies' efforts and programs.

5 How will the proposed agency activities cause the expected outcomes and public benefit in 3?

The Outdoor Recreation office will undertake annual strategic planning and studies to refine and promote the benefits of the state's recreation opportunities. Annual recreation summits will encourage a recruitment of recreation/outdoor related industries. It will focus on and coordinate with tourism efforts that currently promote outdoor recreational activities in the state. The office will coordinate the range of outdoor recreation programs throughout state agencies to ensure the agencies are pursuing common goals and not duplicating efforts. It will also work with Utah's universities and other data related organizations to develop better data regarding the impacts of outdoor recreation in Utah to support programs and decision-making.

Goal (public benefit): Promote the health and social benefits of outdoor recreation.

GOED currently tracks recruitment of outdoor industries to Utah and the total number of such businesses. It also tracks tourism participation and revenues. The Outdoor Recreation Office will work with the Department of Workforce Services and the State Tax Commission to generate revenue figures associated with this economic sector.
