HOW WILL THE PUBLIC BENEFIT?

1 What is the purpose and the duties of the new program, agency, services, or population served?

JR4-2-404(4)(c)(i)

The purpose of the Medicaid Autism Waiver is to provide Applied Behavioral Analysis (ABA) and other services to children ages 2 through 6 with an Autism Spectrum Disorder (ASD). Empirical data show that ABA, and other related services, lead to improvement in an autistic child's functioning, behaviors and developmental progress.

What services are provided by the funding increase?

JR4-2-404(4)(c)(ii)

The services that are provided through the Medicaid Autism Waiver include: Applied Behavioral Analysis (ABA) or similar services, case management, respite care, and financial management services (FMS). (FMS will allow services to be provided under a self-directed services method). Administrative services to implement and oversee the program will be provided. The cost to conduct a baseline and a 6-Month outcome assessment of each child will also be provided through this funding.

3 What are the expected outcomes of the new or expanded program and how will the public benefit?

JR4-2-404(4)(c)(iii)

Children who receive waiver services are expected to have improved functional, developmental and behavioral outcomes. Due to the increasing number of children diagnosed with ASDs, waiver services will help to provide needed services to this segment of the public.

4 How will the bill be implemented and what resources are available to achieve the expected outcomes? JR4-2-404(4)(c)(iv)

The Medicaid Autism Waiver was originally authorized by HB 272 from the 2012 Legislative General Session. HB 88 authorizes the program to continue on an ongoing basis. The Department will maintain one FTE to support the development and oversight of the program and will maintain its interagency agreement with DHS, Division of Services for People with Disabilities to run the operating agency and case management functions of the waiver.

5 How will the proposed agency activities cause the expected outcomes and public benefit in 3?

Maintaining the Medicaid Autism Waiver will result in children receiving services that will result in improved functional, developmental and behavioral outcomes.

The Department requires that a standardized, validated tool (Vineland) be used to evaluate each child from the parents' perspective prior to beginning services and then 6 months later. This evaluation asks questions along 5 main life-skill areas: Communication, Daily Living, Socialization and Motor Skills.
